Dear Mr. President:

I had occasion last night to be visiting with Peter Carrington, Secretary General of NATO. Carol and I have become good friends with Peter and Iona over the past few years and they were at Winfield House for the dinner in honor of Nancy. During the course of our conversation, Peter expressed his concern over who will become David Abshire's successor as our Permanent Representative to NATO. Dave has certainly done an outstanding job and his shoes will be hard to fill.

Peter inquired as to whether or not I thought that there was any possibility that Bud McFarlane would be appointed to this position. I responded that I was unable to answer the question, but that by anyone's measurement I felt Bud would be an outstanding selection. In discussing this later with David Abshire, he wholly concurred that Bud would indeed be excellent. David emphasized, and I agreed, that there are several highly important qualites that Bud would bring to this position. He has a very solid foundation in foreign policy, is intimately acquainted with arms control and the inherent political-military implications, and has well established Congressional connections on both sides of the aisle.

It is my understanding that one of the reasons Bud left his position as National Security Advisor was to take advantage of opportunities in the private sector which would enable him to enhance his financial capabilities. I am told that his wife, Johnnie, may have some distinct reservations about Bud's reentering government service for this very reason.

On the other hand, the financial disadvantages imposed by government service would to some extent be off-set by the fact that he would be provided excellent quarters properly staffed and the availability of representational funding. Furthermore, the likely length of his additional service would not be such as to deprive him of returning to the public sector within two and one-half or three years. Should you agree that Bud would be an excellent choice, I believe your personal intervention would be accepted by him as compelling.

Obviously I do not know of other candidates that you may be considering, but for the reasons stated above, I hope you will give thought to this suggestion.

Mr. President, I hope you will not regard this letter as presumptuous on my part. It is offered with my greatest respect and good wishes always. It was wonderful having Nancy with us and Carol joins in sending our love.

- Mack, I wish that my schedule today was such that we could sit down and talk. But I thought I'd call you instead since it is very hectic today.

The President today announced the appointment of Dr. Alton G. Keel, Jr., formerly Associate Director (National Security and International Affairs) of the Office of Management and Budget, to the staff of the National Security Council where he will serve as the Acting Principal Deputy to the National Security Adviser. Dr. Keel will serve during the absence of Donald R. Fortier.

Dr. Keel is currently completing his recent assignment as Executive Director of the Presidential Commission on the Space Shuttle Challenger Accident, which he began on February 10, 1986. Donald R. Fortier, Deputy Assistant to the President for National Security Affairs, died Saturday night at Georgetown University Hospital in Washington. Mr. Fortier had been ill since May of this year. He was 39.

Mr. Fortier was appointed Deputy Assistant to the President for National Security Affairs in December, 1983. Prior to assuming that position, he served successively at the National Security Council as Director of Western European and NATO Affairs and Special Assistant to the President for Political-Military Affairs. Mr. Fortier joined the Administration in 1981 as Deputy Director for Policy Planning at the Department of State. In November of 1982 he was awarded the Department's Superior Honor Award for his contribution to U.S. foreign policy. Before joining the Executive Branch, he served as a senior adviser to the Foreign Affairs Committee of the House of Representatives and as a national security consultant to the RAND Corporation. Mr. Fortier did his graduate work at the University of Chicago from 1971-1975, where he also served as the Executive Administrator of the Ford Foundation's Symposium on "The Role of the Expert in a Democracy." He received his undergraduate degree from Miami University in Oxford, Ohio, and his M.A. in Political Science and International Relations at the University of Chicago, where he held a Ford Foundation Scholarship.

Mr. Fortier was born in Ohio on January 9, 1947. He lived in Chevy Chase, Maryland with his wife, Alison, and son, Graham.

Dr. Alton G. Keel, 44, of Virginia, is presently a consultant to the Administration, having served as Acting Assistant to the President for National Security Affairs since November 1986. Dr. Keel was appointed Deputy Assistant to the President for National Security Affairs in July 1986. Previous to that, Dr. Keel served as the Executive Director of the Presidential Commission on the Space Shuttle Challenger accident from February to August 1986. From September 1982 until February 1986, he served as Associate Director for National Security and International Affairs in the Executive Office of the President, Office of Management and Budget. Previous to his OMB experience, Dr. Keel was appointed by the President and confirmed by the U.S. Senate as the Assistant Secretary of the Air Force for Research, Development and Logistics in August 1981. In April 1978, Dr. Keel accepted a position as Professional Staff member for the Senate Armed Services Committee, and in January, 1980 became Senior Professional Staff for tactical warfare, conventional force preparedness and assessment of the Five-Year Defense Plan. 

#### DRAFT WHITE HOUSE PRESS STATEMENT

The President today witnessed the administering of the oath of office to Dr. Alton G. Keel, Jr. as United States Permanent Representative to the North Atlantic Treaty Organization (NATO). The ceremony in the Oval Office was attended by the *und Frank Caluer* Vice President and Secretaries Shultz and Weinberger, as well as other dignitaries. The event followed the Senate's confirmation of Ambassador Keel's nomination by unanimous consent on Wednesday, *Murch 11*.

The bipartisan support for the appointment of this distinguished public servant, symbolized by his sponsorship at confirmation by Senators Sam Nunn and John Warner, underscores the firm commitment of the United States to the security of the Atlantic community. The Alliance remains the cornerstone of U.S. international security policy, and Ambassador Keel's appointment comes at an important moment of opportunity. Improved prospects for progress in the NST talks in Geneva, particularly in the area of intermediate range nuclear forces in Europe, confirm the success of NATO's policy of dialogue with the East backed up by a strong and vigilant defense. In the Brussels Declaration, issued last December, NATO launched an ambitious initiative for reducing the threat of conventional war in Europe. But critical work remains to be done, both in bolstering NATO's defense capability and in devising the policies needed to produce arms control agreements that materially reduce the risk of conflict. The President, with

his appointment of Ambassador Keel, is committed to strengthening the already intense consultations and coordination which characterize U.S. relations with our NATO allies in Europe and Canada.

Ambassador Keel brings a unique background in international security issues to this task. Born on September 8, 1943 in Newport News, Virginia, Ambassador Keel received a Doctor of Philosophy and Bachelor of Aerospace Engineering degrees from the University of Virginia in 1970 and 1966, respectively. Following six years of weapons systems research at the Naval Surface Weapons Center (1971-76), he became a professional staff member of the Senate Armed Service Committee where he served for four years.

In 1981, Ambassador Keel was appointed by the President as the Assistant Secretary of the Air Force for Research, Development and Logistics, a position which he held until September 1982 when he was named Associate Director for National Security and International Affairs in the Office of Management and Budget. In this position, he was OMB's principal representative at Cabinet and Senior Staff meetings on international and national security issues. From February through August, 1986, he served as the Executive Director of the Presidential Commission on the Space Shuttle Challenger Accident, whose report and investigation have been uniformly acclaimed. On July 15, 1986 the President announced his appointment as Acting Deputy Assistant for National Security Affairs, a position he assumed in September 1986. Subsequently, the President appointed him Acting Assistant for National Security Affairs on November 24, 1986, in which capacity he served until January 2, 1987. The President announced his intention to nominate Dr. Keel as Ambassador to NATO on December 18, 1986.

Ambassador Keel is married to Dr. Franmarie Kennedy-Keel, currently Chief of Staff of the Under Secretary of Education. He has a daughter, Kristen Ann, age 20.

Ambassador Keel is expected to arrive at NATO Headquarters in Brussels to assume his duties within the next week.
