I have known Mrs. Britt for a number of years and have always been impressed by her sensitivity and dedication to service of the community and of women.

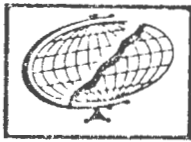


I understand that Jane Britt is being considered for a position as Chairman of the National Advisory Commission on Women.
