## Virginia Fox Zanuck, 75, film star

From combined dispatches

SANTA MONICA, Calif. — Virginia Fox Zanuck, 75, a star of silent films and for decades one of Hollywood's top hostesses, died Thursday at her home of a lung infection complicated by emphysema.

She was the widow of Hollywood tycoon Darryl F. Zanuck and mother of producer Richard Zanuck.

Born Virginia Fox in Charleston, W.Va., she came to Los Angeles with her mother in 1919. The 4-foot-9 woman became the tiniest Mack Sennett bathing beauty in silent films and later became Buster Keaton's leading lady in the

comedies "Ghost Neighbors," "The Haunted House" and "Divorce for Convenience."

She later turned to drama, starring in such films as "Now You See It" and "Compromise."

She married Zanuck when he was a young novelist. He later founded 20th Century Productions and ruled the 20th Century-Fox studios.

Mrs. Zanuck received a commendation for her role in directing entertainment for sailors heading overseas during World War II and she was chosen to christen the battleship Burlington.





## Profile:

### Put the President on her foster parents' list

**TOWN OF MENASHA** — A golden retriever romps on President Reagan's California ranch, because of her.

A couple of darling puppies will fill stockings at Christmas, thanks to her.

A bunch of four-legged creatures, from dogs and cats and pigs to sheep and horses — some with names, some without — have found a home temporarily or permanently, with her.

The classic description, "animal lover," IS her.

She's Carol Schaidler, 1204 E. Shady Lane, and it just is possible that the animals love her in return.

Schaidler, 39, took time out of her busy schedule last week to show a visitor around, introduce the guests and offer a brief history of each.

Take, for example, the affectionate terrier dubbed "No Name," a Benji look-alike and one of the reasons no visitor ever arrives at the farm house unannounced.

"She was guarding a litter of puppies that were frozen to death when they found her near Omro a few years ago," she recalls. "She was a mess."

Then there's the lumbering Wilma, an 800-pound pig, who shoos the younger porkers from her domain with a shrieking fusillade that leaves no doubt who's boss in the barn.

"Would you believe she went from five pounds to that in 3½ years?" she asks.

Schaidler has raised four youngsters (three at home, one off to college) amid the unpretentious surroundings of this animal shelter in disguise.

Somehow she managed to keep her sense of humor, evident as you drive up and notice the pink pigs with the sequential Burma-Shave style message along the fence, and the good-natured plaque mounted beneath the Christmas wreath near the back door.

"Historic Site," it proclaims. "On May 8, 1768, this was declared the first condemned building in North America." Right next to that is a list of 20 forbidden no-noes, intimidating things people may do unwittingly or otherwise to critters if they do not understand them as well as she does.

By profession, Schaidler is a nurse, a person trained to care for sick people. But by inclination, she has focused the lion's share of her attention on ailing and healthy animals since moving to Wisconsin from northern Illinois nearly two decades ago when her husband was transferred.

"I like taking care of sick animals," she says. "I don't know if I'd be a good vet. But I'd be a good animal nurse.

"I always wanted to be a veterinarian. But when I graduated from high school in 1961 there was only one college in the country that would take women students in their veterinary programs. So I decided to become a nurse."

Schaidler attended the medical school at Northwestern University in Evanston, Ill. As a student nurse at Passavant Hospital there, she met the late Dr. Loyal Davis, Nancy Reagan's father. While she didn't know it at the time, the acquaintance would lead to an interesting chapter in her life pivoting around Mrs. Reagan and one golden retriever who now goes by the moniker Victory.

It was the Wisconsin presidential primary in spring 1980 and the campaign trail had brought Ronald and Nancy Reagan to the Fox Valley. Schaidler met them at one point in the stumping route and, chatting with Nancy, happened to mention knowing her father.

She clutched a bronze, frisky pup in her arms which, during the course of the conversation, she offered to the Reagans. To her surprise, Nancy accepted the dog, then just 5½ weeks old. About two months later, the dog was old enough to travel and, the last Schaidler heard, is healthy and happy out West on the Reagan ranch.

That may have been the high point in her adopted career of placing animals in good homes, but it is evident she's scarcely in it for the glory or the money. In fact, Schaidler's gotten much more selective in recent years in the conditions under which she will take in animals and part with them as pets.

"Two years ago, I found homes for 20 dogs that weren't mine," she says. "That's the last time I kept count."

"I still average 10 to 20 calls a week from people who want to give me dogs," she says. "But today I'll take them in only if they've had their shots and are healthy." Schaidler says she barely breaks even over the course of a year caring for animals and selling them.

And, she admits to occasional doubts about the nature of her commitment.

"I go through a debate with myself every year whether I should go back to nursing. But it still comes out to about a dollar an hour any way you look at it." She occasionally does private-duty nursing.

But then, in the next breath, she is talking about what "a terrible time I have resisting a dog that's been poorly taken care of."

Naturally, a woman who's spent hours of time and trouble nursing neglected animals back to health and seen to homes for many others has firm opinions on how to improve their plight. Then too, Schaidler says, "there is a certain percentage of dogs that are totally hopeless, and should be destroyed."

"I don't think the needs are being met for taking in dogs in Winnebago County," she says. She also thinks a spay clinic is justified in this area (the nearest is Green Bay) and has a strong suspicion that only half the people who get pets see them through to adulthood.

"I think it's unfortunate that less than 50% of puppies stay in their homes for less than their lifetimes," she says.
