Contingency Talking Points for Airport Arrival Cancun, Mexico

July 31, 1981

Approximately 1740 hours

- It is a pleasure to be here in Cancun and attending this preparatory conference.
- We wish to thank our Mexican and Austrian co-hosts for the hospitality they are extending to us and the cooperative spirit they have shown in arranging this meeting.
- We do not intend to make any momentous decisions. This meeting (August 1-2) will deal primarily with procedural issues for the October Summit.
- We hope the October Summit will follow the consensus arrived at in March by the co-sponsors: the the Summit meeting will be open, informal, and without agenda, communique or joint press release.
- For the first time, Heads of State and government from leading countries will engage in an open and frank exchange on the substance of global economic issues.
- We hope this exchange will signal a new spirit in global economic cooperation for mutual benefit: national policies coupled with international consultations and cooperation.

STATEMENT FOR CANCUN SUMMIT MINISTERIAL PREPARATORY MEETING AUGUST 1-2, 1981 CANCUN, MEXICO

MR. SECRETARY, MR. MINISTER:

MAY I EXPRESS MY PERSONAL APPRECIATION, THAT OF MY DELEGATION AND THAT OF MY PRESIDENT, TO OUR CO-HOSTS AND CO-SPONSORS WHO HAVE ORGANIZED THIS MEETING. I COME HERE COMMITTED TO THE PROCESS THAT THEY HAVE STARTED. THE UNITED STATES IS WILLING TO EXPLORE ALL AVENUES OF CONSULTATION AND COOPERATION WITH NATIONS WHO SHARE OUR CONCERN FOR THE ADVANCEMENT OF GLOBAL ECONOMIC GROWTH AND DEVELOPMENT. THE CANCUN SUMMIT OF OCTOBER 22-23 IS AN EXCITING OPPORTUNITY FOR OUR HEADS OF STATE OR GOVERNMENT TO SHARE THEIR PERCEPTIONS, VIEWS AND PHILOSOPHY ON ISSUES OF GLOBAL ECONOMIC CONCERN.

INTERNATIONAL ECONOMIC DEVELOPMENTS TODAY ARE MARKED BY A
TREND TOWARD GREATER INTERDEPENDENCE AMONG NATIONS. INTERDEPENDENCE

REQUIRES THAT WE COOPERATE FOR OUR COMMON GOOD. AT THE SAME TIME,

HOWEVER, WE CANNOT IGNORE THAT ECONOMIC GROWTH AND DEVELOPMENT ARE

STILL FUNDAMENTALLY DEPENDENT ON NATIONAL ECONOMIC POLICY. THE

INTERNATIONAL ECONOMIC SYSTEM CAN ASSIST GROWTH BUT IT CANNOT CAUSE

IT.

AMERICAN POLICY IS BASED ON A RECOGNITION OF BOTH INTERDEPENDENCE AND THE CRUCIAL ROLE OF INTERNATIONAL ECONOMIC POLICY. IT IS THE RESPONSIBILITY OF ALL NATIONS WHO DRAW BENEFITS FROM THE INTER-NATIONAL SYSTEM TO WORK TO IMPROVE THAT SYSTEM THROUGH INTERNATIONAL COOPERATION. I WANT TO ASSURE YOU THAT THE UNITED STATES WILL ACCEPT ITS RESPONSIBILITIES, WE SHALL FULFILL OUR INTERNATIONAL COMMITMENTS -WE WILL CONTINUE TO FIGHT FOR OPEN MARKETS IN TRADE AND CAPITAL -WE WILL CONTINUE TO SUPPORT THE INTERNATIONAL MONETARY FUND AND THE WORLD BANK: IF POSSIBLE, WE WILL INCREASE OUR OFFICIAL DEVELOPMENT

ASSISTANCE (ODA).

ON THIS LATTER POINT I WISH TO STRESS THAT MY PRESIDENT'S

REQUEST FOR ODA IN HIS PRESENT BUDGET IS 16 PERCENT HIGHER THAN THE

FUNDS APPROPRIATED BY THE U.S. CONGRESS LAST YEAR. WE SHALL WORK

TO PRESERVE THIS INCREASE AND TO FULFILL OUR COMMITMENTS TO IDA.

THE UNITED STATES, BECAUSE OF THE SIZE OF ITS ECONOMY, HAS A

UNIQUE ROLE TO PLAY IN THE HEALTH AND STABILITY OF THE INTERNATIONAL

ECONOMIC SYSTEM. THIS SYSTEM IS ONLY HEALTHY IF THE U.S. DOMESTIC

ECONOMY IS HEALTHY. THIS IS WHY WE CONTINUE TO STRESS THAT ECONOMIC

STABILITY AND GROWTH IN THE UNITED STATES IS THE TOP PRIORITY FOR MY

GOVERNMENT.

ACHIEVING THIS GOAL WILL TAKE TIME. BUT LET ME ASSURE YOU WE

DO NOT INTEND TO NEGLECT OTHER OBJECTIVES OR TO ABANDON OUR INTER
NATIONAL RESPONSIBILITIES WHILE WE TEND OUR DOMESTIC HOUSE. WE

BELIEVE THAT OUR DOMESTIC ECONOMIC RECOVERY WILL PROVIDE US WITH A

BETTER OPPORTUNITY TO RESIST PROTECTIONISM, FOSTER OPEN TRADE AND

PROVIDE THE NECESSARY RESOURCES FOR THE U.S. TO PLAY A GREATER ROLE.

LET ME CONCLUDE BY SAYING THAT WE ALL SHARE A COMMON GOAL - AND OBLIGATION - TO RAISE HUMAN DIGNITY AND EXPAND HUMAN FREEDOM BY

EASING THE BURDEN OF ECONOMIC SURVIVAL. THE UNITED STATES WILL COME

TO CANCUN IN OCTOBER IN A SPIRIT OF COOPERATION - NOT ON THE BASIS

OF EAST VERSUS WEST OR NORTH VERSUS SOUTH - BUT SHOULDER TO SHOULDER

FOR OUR COMMON WELFARE AND OUR COMMON BENEFIT.

Ambassador Gavin and Ms. Laris will escort you to your room on the first floor of the hotel (floor above the lobby).

You will bid farewell to Ms. Laris.
