Main Objectives

- -- Impress upon the Algerians that the U.S. does take seriously problems of the developing countries.
- -- Avoid any open confrontation on the subjects of Global Negotiations and the North-South dialogue.


Bear In Mind

- -- Foreign Minister Ben Yahia is convalescing in Paris from injuries sustained in his recent airplane crash. The delegation is comprised largely of technicians.
- -- The primary Algerian objective is launching Global Negotiations at the UN as soon as possible. The Algerians see us as the most serious obstacle to this objective and at odds with its allies on this issue.

Checklist

- -- Inquire about the Foreign Minister's condition. Note that Americans have not forgotten his personal role in resolving the hostage crisis.
- -- Hear out Algerian views. Assure them that the U.S. is concerned about problems of development even if we do not always agree with Algeria on how to solve them.
- -- Suggest that more attention should be given to the potential of the private sector in increasing efficiency in developing countries and facilitating technology transfer.
- -- As appropriate, stress importance of reaffirming agreement to have no agenda and no communique at the Cancun Summit. Express our hope that it will change tone of multilateral consultations.

SUMMARY

Huang Hua participation in the Cancun preparatory meeting marks China's debut into the world of international economic summitry. After Cancun, he will be travelling to Venezuela and Colombia, and stopping over in New York August 10-13. Huang has declined your invitation for a day of talks in Washington on August 12, pleading the tightness of his schedule (late August 10 arrival and early August 13 departure) and the need for rest (he has been hospitalized twice in recent months for a urinary infection).

In your meeting with Huang, you will want to thank him for his hospitality during your Beijing trip, regret his inability to come to Washington on August 12, and mention that you look forward to seeing him at UNGA. You will want to explain briefly our consideration of issues for the Liu Huaqing visit, and our desire to be responsive to Chinese requests. You will also wish to elicit Chinese understanding and support for our general position on how to approach North/South issues.
