Dear Ronald,

In reply to your letter of July 9th, concerning the position the U.S. is taking in the debate on the downing of the Iranian Airbus which will take place in the Security Council starting July 12th, I would like to thank you for your solicitude in informing me of the line that your Government intends to follow in this circumstance.

For my part, I consider it important that the Islamic Republic of Iran, for the first time in the history of its relations with the Security Council in recent years, has decided to take its case to the highest organ of the U.N. to examine a question which constitutes, as you yourself have said, a human tragedy of terrible proportions.

Foreign Minister Andreotti has informed Secretary of State Shultz of what transpired in the conversation that he had

in the evening of July 8th with Iranian Deputy Foreign Minister Larijani. Andreotti reported on the indications of movement that appeared in Teheran's position and on some ideas mentioned to him, which deserve to be thoroughly examined, both as concerns the aspects directly related to the Security Council debate (bearing in mind that Larijani made frequent references to the adoption of a resolution at the end of next Tuesday's debate) and as regards the indications pertaining to the settlement of the relationship with Iran.

In this connection I feel that the debate should be oriented in the most constructive direction possible, which can find the unanimous consent of the Security Council, but according particular attention to the intention of immediately reviving the negotiating process for a settlement of the conflict, and to keeping a productive relationship between Iran and the Security Council going, not least in view of the delicate balances of that country, in order to foster the tendencies which are currently evolving to the full extent possible.

In this regard, I am of the opinion that the debate in the Security Council should bring out the necessity to consider the implementation of Resolution 598 a matter of the highest

priority, strenghtening the value and the appeal of the Resolution not only by giving new impetus to the U.N. Secretary General's plan of implementation, but also by accepting his proposals of June 17th and intensifying the negotiations.

The NSC staff opposes Justice's draft report on HConRes 330, and believes that Justice should rewrite its report to oppose adoption of the resolution.

HConRes 330 stipulates that the US should not enter into negotiations with the Government of Iran on compensation for the downing of flight 655 until Iran enters into negotiations to compensate for attacks on civilian shipping and United States Armed Forces in the Persian Gulf. This approach contradicts President Reagan's publicly stated intention to provide ex gratia payments to the victims' families. HConRes 330 also implies that the USG would enter into negotiations with the Government of Iran on the matter of compensation, which the President has also explicitly rejected. The NSC staff therefore requests that Justice rewrite its report to oppose HConRes 330, using the rationale above as guidance.

Justice has prepared a draft report on HConRes 330, which provides that the United States should not undertake negotiations to compensate the Government of Iran or any party in Iran until the Government of Iran begins to negotiate to compensate for attacks on civilian shipping and US Armed Forces in the Persian Gulf.

Justice has noted in its draft report that since the Resolution simply expresses the sense of Congress, it has no objection to the Resolution. The Resolution, though, contradicts the President's publicly stated intention to make ex gratia payments to the victims' families. The Resolution also implies that the USG would enter into negotiations with the Government of Iran on the matter, when in fact we have already said we would not do so. State has advised us that they have similar objections to HConRes 330; a draft of State's report to Fascell is attached.

We therefore recommend that the NSC staff oppose the Justice draft, and request that Justice oppose HConRes 330.

Bill cockell, Mike Andricos, and Dan Levin concur.

That you sign the memo at Tab II to Ronald Peterson opposing the Justice report, and requesting that Justice oppose HConRes 330.

This is in response to your request for the views of the Department of Justice on H.Con.Res. 330, providing that the United States should not undertake negotiations to compensate the government of Iran or any party in Iran in connection with the shooting down of Iran Air Flight 655 until the Government of Iran undertakes negotiations to compensate for attacks by Iranian military forces on civilian shipping and United States Armed Forces in the Persian Gulf.

Because this Concurrent Resolution would simply express the sense of the Congress, the Department has no constitutional objection to H.Con.Res. 330.

The Office of Management and Budget has advised this Department that there is no objection to the submission of this report from the standpoint of the Administration's program.

Thank you for the opportunity to comment on H. Con. Because the Vincennes acted in justifiable self-defense, the United States Government is not legally obligated to make any payments nor can the decision on compensation be construed as a concession of such liability.

Details of the compensation plan have yet to be determined. However, President Reagan has made clear that decisions on compensation and payments will be made without the involvement of the Government of Iran and that every possible precaution will be taken to ensure that payments to Iranian nationals are not transferred to, or confiscated by, the Government of Iran.

Consequently, the Administration does not anticipate conducting any "negotiations" with the Government of Iran as contemplated by H. Con. Res 330.

In offering to extend <u>ex gratia</u> compensation, the United States has stressed the humanitarian and voluntary nature of the compensation and has not made payment of compensation to the families contingent on changes of behavior by the Iranian Government, in part because this would suggest that we are prepared to reward such changes by paying money to the Iranian Government. It should also be noted that a number of nationals from other countries were killed in the accident.

Moreover, ex gratia payment of this type is consistent with the past practice of the United States and of other nations and is particularly appropriate where a civilian airliner has been shot down. The only instances in which a nation responsible for shooting down a civilian airliner has refused to pay compensation involve the Soviet Union.

The Office of Management and Budget advises that from the standpoint of the Administration's program, there is no objection to submission of this report.

To make payment contingent on the release of our own hostages would reward terrorism and hostage-taking.

Moreover, ex gratia payment of this type by the United States is consistent with the past practice of the United States and of other nations and is particularly appropriate where a civilian airliner has been shot down. The only instances in which a nation responsible for shooting down a civilian airliner has refused to pay compensation involve the Soviet Union.
