RE: State of the Union Address

I believe it is imperative that the President mention the positive aspects of the 1981 tax cut in his State of the Union Address. A special emphasis should be placed on the beneficial aspects to small investors. From: Secretary of the Interior

I was visited recently -- as I know you were -- by Peter MacDonald, Chairman of the Navajo Nation and also of the Council of Energy Resource Tribes, a national coalition of tribes with substantial energy-resource holdings. Chairman MacDonald described a benefit-performance to take place in the Kennedy Center Opera House on March 4, 1982, that is intended, in his words, to present a very positive picture of the accomplishments and contributions of the Indian people. Proceeds from this event, which has the potential to be subsequently televised nationwide, -- will benefit a program that trains young Indians to be engineers, scientists and business managers -- in short, to pursue careers for which there is a dire shortage and need on the reservation.

As you know, Nancy Clark Reynolds has offered her services as Chairman of the Benefit Committee for this event, which is called Night of the First Americans. Lorne Greene is Executive Producer of the performance itself; noted Indian Artist Retha Gambaro is coordinating what may well be the most extensive Indian art exhibition and sale ever to take place in Washington, for the Kennedy Center that night as well. Finally, co-chairing the Sponsors Committee with Chairman MacDonald will be Robert O. Anderson, Chairman of the Atlantic Richfield Company.

I have reviewed the projected content of the show and believe it is an effort to which the Administration should lend solid support. Accordingly, I would concur with Chairman MacDonald's request that President and Mrs. Reagan host a pre-performance White House reception March 4 for the attending stars and major performance patrons and for the many Indian tribal chairmen who will be attending. I hope you'll also agree that the performance itself will be something that President and Mrs. Reagan will want to attend.

Thank you for your involvement in this matter. I look forward to hearing from you soon.

SUBJECT: Staff Identification Pins

In order to clarify the position on the distribution of Staff identification pins, the following policy will take effect immediately.

New pins will be issued by the USSS for the following categories:

1. Permanent Travel Party - Limited group designated by the Deputy Chief of Staff of those persons who travel regularly when the President leaves the White House.
2. White House Staff Pins - Limited to those staff members who sometimes need to travel with the President. In addition, we will distribute on a trip-by-trip basis, temporary pins for those who will seldom be required to travel with the President.
3. Support Services Pin - Pins to identify WHCA and Military support personnel. The White House Military Office will submit the names of those persons required to travel with the President.

There will be no publication of the names of personnel receiving pins under the categories listed above. Therefore, if anyone who hasn't received a pin by 1 February 1982, you may appeal directly to my office in writing.

Mary and I were very pleased to meet you and Joe Canzeri last Thursday, and we are greatly honored by the Administration's proposal regarding the office of the Chief of Protocol. We are extremely grateful for your thoughtfulness; the opportunity to serve the Administration has been the center of a strong wish in my mind from the beginning.

After careful - indeed agonizing - discussion and consideration, I must decline the exceedingly interesting invitation with utmost regret. I would like you to know the compelling reasons which force this decision.

Dear Mike:

I am sorry we couldn't get together yesterday or today. Before I leave town, I would like to pass along a few thoughts.

After last Friday's meeting with the President, I spent the weekend thinking about what had been discussed -- where we were as an industry and our prospects for the future.

My conclusion did not vary from my thoughts of months ago. We are in trouble. We are muddling through. We are waiting for the "trickle down" to work; but in the meantime, we have an unemployment problem that is worsening by the week.

We reviewed the facts for the President, but let me reiterate a few:

- . Nearly 200,000 auto workers are on indefinite lay off.
- . In the past year, up to a million workers in businesses related to our industry have lost their jobs.
- . Over 2,600 dealers have gone out of business -- 10 percent of total.
- . The Big Three's pre-tax losses over the past ten quarters have totaled a staggering \$13 billion.
- . High interest rates are causing the average urban dealer to spend \$40,000 a month for rent and floor plan costs. In 1976, this cost averaged \$12,500 a month.
- . Sales of domestic cars are down 33 percent from the peak year of 1978.
- . Sales of imports are up 19 percent from 1978; Japanese up 41 percent.

- . Import auto sales are near record levels.

Import penetration was 17.9 percent in 1978.

Import penetration is at 26.5 percent in 1981. (29.7 percent, Nov., 1981)

- . The four domestic auto companies had working capital of \$13 billion at year-end 1978. At the end of the third quarter in 1981, working capital had been reduced to \$300 million.

Mike, as you can see, the picture is bleak. In my thirty-six years in the business, I have never seen a depression like this one. For thirteen quarters, our industry has been depressed. For the life of me, I don't see what is going to happen in the first six months of 1982 to change the current condition.

We talked to Mayor Coleman Young's office the other day. They tell us that unemployment problems are at their worst. This was before the recently announced G.M. lay offs. Their recent lay offs save them \$500 million, but what does that do for the economy? Instead of "trickle down," we are going to have big trouble in Detroit. In our city, 29 percent of the blacks are out of work -- 68 percent of all black teenagers are out of work -- that's two out of three.

In our meeting, we discussed economic policy, regulatory and legislative reform, energy policy and trade policy. These areas are all being reviewed, but they address only our long-term needs. What our industry needs is to improve our selling rate now. People need to be able to get back into the market to buy cars and trucks.

I urge your White House staff to consider and implement a short-term program that will help all Americans, our industry, and the President himself.

We need to provide for a six-month period a \$1,500 personal investment tax credit for the purchase of fuel-efficient, U.S.-built cars and trucks.

This is our only shot. There is only one method I can think of that will provide for fast sales incentives which will:

1. Bring 250,000 people back to work.
2. Save a billion gallons of gas a year.
3. Increase car sales by a half million units in that half year.

We have studied the economics of this program. The attached sheet demonstrates that it will cost-out at nearly a break-even for the Treasury.

I am prepared to discuss this with you and your associates. The State of the Union message will be delivered in less than a month. Everybody can be a winner.

The President is committed to the Program for Economic Recovery which he proposed last year. He has stated that the major portions of that program, and the major tax reductions which it contained, will not be abandoned. Although the Administration will continue to deliberate upon economic initiatives appropriate for the future, we are convinced that when carried to completion, the policies adopted last year will provide for a more productive and prosperous nation.
