Response to State Department memo re PD/NSC-58,

Concept of Operations

The State Department has submitted its concept of operations for Continuity of Government in accordance with PD/NSC-58 (Tab II). Although the normal process would have been for them to forward this directly to the Chairman of the Interagency Steering Group (Tom Reed), we should not quibble over bureaucratics -- but have Mike Wheeler sign the response at Tab I acknowledging receipt.

The plan they have submitted has unfunded resource implications which they have asked you to address with OMB. Rather than embroil you in this matter at this point, we should proceed as follows:

- -- Have the Interagency Working Group (chaired by North) review the plan and report their findings to the Steering Group.
- -- Have State brief its plan to the next Steering Group Meeting (May 4).
- -- Forward to you any actions that cannot be resolved (funding will be the logical issue).

#### RECOMMENDATION

That you authorize Mike Wheeler to sign the proposed response at Tab I.


