MEMORANDUM FOR THE UNITED STATES TRADE REPRESENTATIVE

SUBJECT: Renewal of Trade Agreement with the People's Republic of China -- Finding and Determination under Subsection 405(b)(1) of the Trade Act of 1974

Pursuant to Section 405 of the Trade Act of 1974 (19 U.S.C. 2435), I find that a satisfactory balance of concessions in trade and services has been maintained during the life of the Agreement on Trade Relations between the United States of America and the People's Republic of China. I further determine that actual or foreseeable reductions in United States tariffs and non-tariff barriers to trade resulting from multilateral negotiations have been satisfactorily reciprocated by the People's Republic of China.

This finding and determination shall be published in the Federal Register.

MEMORANDUM FOR THE PRESIDENT

FROM: NANCY J. RISQUE

SUBJECT: Renewal of the Trade Agreement Between the United States and the People's Republic of China

Issue: You must decide by January 1, 1989 whether or not to renew the Agreement on Trade Relations between the United States and the People's Republic of China (PRC). The attached memorandum from Ambassador Yeutter cites several reasons why you should renew the agreement.

Background: The Agreement on Trade Relations between the United States and the People's Republic of China first went into effect on February 1, 1980. It has been renewed every three years since then by Presidential determination. Trade between the two countries has flourished during the life of the present agreement. China has become our 13th largest trading partner. Renewal of the agreement would allow for greater trade expansion as well as increased leverage on the PRC to improve the environment for protection of intellectual property and foreign investment.

Discussion: The Trade Act of 1974 requires two conditions for renewal of the agreement: 1) a finding that a balanced level of concessions existed between the two countries over the life of the agreement; and 2) a determination that China has reciprocated actual or foreseeable reductions in our tariff and non-tariff barriers. The trade agencies unanimously agree that both these conditions have been met.

Recommendation: That you sign the attached Presidential determination renewing the Agreement on Trade Relations between the United States and the People's Republic of China.
