SUBJECT: Vice President's Visit to Europe and Followup

It is important that we do not lose the positive thrust of the Vice President's visit by actions here that would give contrary signals to the Europeans. It is particularly important that we build on this positive base at least through March 6, date of the German elections.

I have just learned that there is a possibility of an overall foreign policy speech that is planned for the President tentatively before an audience of American Legionnaires.

I think this would be most inappropriate at this time.

The President can not make a speech of this type without using a part of the speech to discuss our defense and military capacity. While obviously this must be discussed at some time, doing it prior to March 6 German elections will only cause European press to focus on that part of the message that relates to "hardware" at the expense the reassuring part about arms reduction.

It would be another example of our giving mixed signals...a major part of our current problem with people in Europe. An audience composed of former military people is also inappropriate at this time...for the same reason.

RECOMMENDATION

However, we strongly recommend that the President followup the Vice President's visit with a short, clear, speech outlining American policy on arms reduction. It is needed to reemphasize the Vice President's trip. It is needed to clearly position the President as the leader in seeking world peace.

1. Strategic Arms Reduction. The President is the first world leader to address the arms issue with a meaningful and positive program to reduce arms. Proposals by other world leaders have dealt with limiting arms or controlling them.

The President should emphasize his leadership and his role in beginning the strategic arms reduction talks. He has proposed a 25% reduction in strategic arms. This is a very important fact, and one that is not well known by the public, in the United States and in Europe.

This proposal undercuts the previous nuclear freeze movement and we should make this point strongly in view of their coming demonstration in Washington on March 7 and 8..

2. Elimination of Intermediate Range Weapons. Following on the theme of identifying the President as the initiator of strategic arms reduction explain the President's proposal to rid Europe of an entire category of weapons (the INF proposals).

This initiative also completely undercuts the Freeze Movement

. Perhaps wonder could be expressed that peace groups and the freeze movement are noticeably absent from support of this issue which goes far beyond their current propositions. Why?

3. Excess Capacity? The truth, less megatonnage than 10 years ago. The President should point out the fact that in strategic arms megatonnage the United States has substantially less nuclear weapons today than it had 15 years ago, and continues to reduce its excess capacity continually, maintaining only what is necessary for defense.

This would help overcome the feeling of many people that we constantly add more and who are not aware that the size of the deterrent is substantially less than it has been in the past.

4. Positive Gesture. As a gesture of his continuing desire to reduce nuclear weaponry, the President's speech should announce his commitment to remove 1,000 nuclear shells from Europe this year.

In summary the speech should be short, 10-15 simple, clear in its statement in the President's goals in arms reduction and under no circumstances with any of our defense posture. I.E., mention any other weapons system of that nature.


The speech should be delivered prior to March 6, German elections, and it should be delivered before an audience that would be appropriate.

It has been suggested that the Washington Diplomatic Corps would be appropriate, I would endorse this. Alternatively he could speak to a young audience..e.g. university. That would demonstrate that we want public support for our policy and indicate the President's commitment to build a future of peace and security.

Conclusion .We should do nothing to undercut the positive momentum of the Vice President.

One of our problems in the past has been conflicting signals to Europeans which cancel out or confuse our messages and are creating increasing creditable problems about our true positions.

At this point in time Europe does not need to have its views about our military capacity reassured. It is our commitment to arms reduction, our sincerity to achieve that and our commitment to European Community and its Alliance which must be enhanced.

1. (C - ENTIRE TEXT).

2. IN AN EFFORT TO COUNTER SOVIET PROPAGANDA INITIATIVES AND ADDRESS THE GROWING PUBLIC DEBATE OVER THE WESTERN ZERO/ZERO OPTION AND THE NATO DUAL TRACK DECISION, USNATO WOULD LIKE TO SUGGEST THAT BRIEF, TO-THE-POINT TALKING POINTS BE DISTRIBUTED ON A MONTHLY BASIS DURING THIS "YEAR OF DEPLOYMENT" TO ALL US OFFICIALS WHO MIGHT IN ANY WAY BECOME INVOLVED IN DISCUSSIONS RELATING TO INF ISSUES.

3. WHEN WE SAY US OFFICIALS, WE DO NOT RPT NOT MEAN ONLY SENIOR AND SUBSTANTIVE OFFICERS, BUT ALSO COMMERCIAL, CONSULAR, ADMINISTRATIVE AND OTHER PERSONNEL -- ANYONE WHO MIGHT CONCEIVABLY BE IN A POSITION OF DISCUSSING INF WITH OUR OWN PUBLIC OR WITH EUROPEANS, ESPECIALLY MEMBERS OF THE "PEACE" OR "FREEZE" MOVEMENTS.

4. BEARING IN MIND THAT WE ARE NOT ATTEMPTING TO PERSUADE THE EXPERTS, THE EMPHASIS SHOULD BE ON ABSOLUTE BREVITY, WITH OUR ARGUMENTS STATED IN THE SIMPLEST, MOST STRAIGHTFORWARD AND EFFECTIVE TERMS POSSIBLE.

5. THE FOLLOWING ARE EXAMPLES OF THE SORT OF THING WE HAVE IN MIND:

- A. ZERO-ZERO PROPOSAL
- -----
- -- WE FAVOR THE ELIMINATION OF ALL LONG-RANGE NUCLEAR MISSILES IN EUROPE ON BOTH SIDES: ZERO FOR THE US AND ZERO FOR THE SOVIET UNION.
- B. THIRD COUNTRY SYSTEMS
- -----
- -- THE SOVIET DEMAND TO COUNT BRITISH AND FRENCH NUCLEAR FORCES ALONG WITH THOSE OF THE US IS A DEMAND FOR THE RUSSIANS TO HAVE AS MANY NUCLEAR WEAPONS AS ALL OTHER COUNTRIES COMBINED. THIS IS A DEMAND FOR SOVIET SUPERIORITY, NOT EQUALITY.
- C. SOVIET CLAIMS OF A NUCLEAR BALANCE

- -- THE SOVIETS HAVE MORE THAN 1200 LONG-RANGE INF MISSILE WARHEADS; NATO HAS 0. 1200 TO ZERO IS NOT A BALANCE, IT'S A MONOPOLY.
- D. WHY NO NUCLEAR FREEZE

- -- THE SOVIETS WANT A FREEZE SO THEY CAN QUIT WHILE THEY ARE AHEAD: 1200-0. WE WANT REDUCTIONS TO ZERO-ZERO ON BOTH SIDES.

6. IN DEVELOPING AND REGULARLY UPDATING SUCH TALKING POINTS, DEPARTMENT WOULD DOUBTLESS NEED TO COMBINE THE SUBSTANTIVE EXPERTISE OF POLITICAL-MILITARY OFFICERS WITH THE PUBLIC RELATIONS SKILLS OF PUBLIC AFFAIRS OFFICERS. IN ANY CASE, WE BELIEVE THAT A CONSCIENTIOUS EFFORT TO PRODUCE MONTHLY TALKING POINTS ALONG THIS LINE COULD BE MOST HELPFUL IN OUR ONGOING STRUGGLE AGAINST SOVIET AGIT-PROP EFFORTS AIMED AT STOPPING NATO'S TWIN-TRACK DECISION.

SETTING

2. THE NETHERLANDS GOVERNMENT ACCEPTS THE 1979 DUAL  
DECISION, BUT HAS NOT DECIDED ON DEPLOYMENTS ON DUTCH  
SOIL. NOR HAS IT SPECIFIED PRECISELY WHEN IT WILL DO SO.  
THE GON POSITION IS BOTH TO SUPPORT THE U.S. AT GENEVA,  
AND TO DO NOTHING THAT WOULD HAVE A NEGATIVE IMPACT ON  
OUR NEGOTIATING EFFORTS. THIS INCLUDES CAUTIOUSLY MOVING  
FORWARD WITH GLCM PREPARATIONS.

3. WHILE THE VOTE WOULD LIKELY BE CLOSE, THERE IS PROBAB-  
LY NOT A MAJORITY IN THE DUTCH PARLIAMENT FOR DEPLOYMENT  
AT PRESENT. A MAJORITY MAY WELL BE ATTAINABLE IN THE  
FUTURE, DEPENDING ON EVENTS, DESPITE THE FACT THAT PUBLIC  
OPPOSITION IS SUBSTANTIAL. GIVEN THE ADVERSE IMPACT ON  
THE ALLIANCE THAT A NEGATIVE DUTCH DECISION WOULD HAVE,  
OUR INTERESTS ARE BEST SERVED BY THE DUTCH CONTINUING  
PREPARATIONS BUT NOT RISKING A PARLIAMENTARY VOTE UNTIL  
A MAJORITY IS CLEARLY ATTAINABLE, AND/OR BASING IS WELL

SPECIFIC OBJECTIVES

4. THESE ARE SEVERAL:  
--ULTIMATELY, TO PERSUADE THE GON TO DEPLOY 48 GLCM'S  
IN ACCORDANCE WITH THE DECEMBER 1979 NATO DUAL-TRACK  
DECISION;  
--DURING 1983-4, TO PERSUADE THE GON TO CONTINUE PRE-  
PARATIONS ESSENTIAL FOR DEPLOYMENT IN ORDER TO (A)  
ADHERE AS CLOSELY AS POSSIBLE TO THE NATO SCHEDULE FOR  
THE NETHERLANDS, AND (B) STRENGTHEN THE POSITION OF U.S.

--AT AN APPROPRIATE TIME, TO PERSUADE THE GON TO AGREE

5. IN PRIORITY ORDER THESE ARE:  
(A) THE CABINET. GOVERNMENT MINISTERS, JUST AS THE  
PARLIAMENT AND THE PUBLIC, WANT THE ISSUE TO GO AWAY.  
THEY SENSE INCREASINGLY THAT IT WILL NOT. WE HAVE

DECISIVE IN ANY SHOWDOWN VOTES: CHRISTIAN DEMOCRATS,  
LIBERALS, D'66. EXPOSURE OF THESE PARLIAMENTARIANS TO  
PERSUASIVE AND WELL-INFORMED USG OFFICIALS, ESPECIALLY  
MEMBERS OF CONGRESS, IS INDISPENSABLE. EXPOSURE CAN  
TAKE PLACE HERE OR IN WASHINGTON, BUT MAY BE MORE EFFECTIVE  
HERE BECAUSE THE AMERICANS CAN THUS GAIN A BETTER "FEEL"  
FOR THE NATURE OF THE PROBLEM WHERE THE DUTCH DECISIONS  
WILL BE MADE.

(C) DUTCH JOURNALISTS. SOME DUTCH PRINT AND BROADCAST  
JOURNALISTS ARE UNALTERABLY OPPOSED TO DEPLOYMENTS (HERE  
OR ELSEWHERE) AND OUR COURTING THEM SIMPLY ENHANCES  
THEIR PRESTIGE. OTHERS THOUGH ARE PROFESSIONALLY NEUTRAL  
AND WILL GIVE US A FAIR SHAKE, WHILE A FEW ARE CLOSET  
SUPPORTERS. WE SHOULD FAVOR THOSE IN THE TWO LATTER  
CATEGORIES, WHILE BEING VERY CAREFUL NOT TO APPEAR TO  
ANNOY THEM, WHICH COULD EMBARRASS THEM AND US AND UNDER-  
MINE THEIR CREDIBILITY. WE STRONGLY RECOMMEND A MORE  
CONCERTED EFFORT TO CULTIVATE THE U.S.-BASED DUTCH PRESS.  
THIS SHOULD NOT BE LIMITED TO OCCASIONAL LARGE BRIEFINGS  
BUT SHOULD INCLUDE FREQUENT, SYSTEMATIVE ONE-ON-ONE

SYTSE VAN DER ZEE, FOR EXAMPLE, IS A PROLIFIC JOURNALIST  
WHO HAS AT LEAST ONE, SOMETIMES TWO, ARTICLES DATED IN  
WASHINGTON IN NEARLY EVERY ISSUE OF HIS PAPER.)

COMMENT: MASS OPINION IN THE NETHERLANDS IS SHAPED  
MORE BY EVENTS THAN BY ARGUMENTS. BUT THERE IS AN  
OPINION ELITE HERE OF SOME ONE THOUSAND PERSONS WHO HAVE  
EXCEPTIONAL INFLUENCE ON WHAT GOVERNMENT POLICY WILL BE.  
THEY READ EACH OTHERS' ARTICLES AND ATTEND EACH OTHERS'  
SEMINARS AND DINNER PARTIES. THIS ELITE INCLUDES THE  
MINISTERS AND STATE SECRETARIES, MEMBERS OF PARLIAMENT,  
SENIOR CIVIL SERVANTS, JOURNALISTS; SOME CHURCH LEADERS,  
AND CERTAIN SCHOLARS, AS WELL AS BUSINESS AND LABOR

LEADERS. THE LATTER TWO, HOWEVER, SELDOM EXERT THEMSELVES  
ON ANYTHING OTHER THAN ECONOMIC ISSUES.

ALONG WITH GOVERNMENT LEADERS (POLITICAL AND CAREER),  
PERSUADABLE PARLIAMENTARIANS, AND REALLY PROFESSIONAL  
(OR SYMPATHETIC) JOURNALISTS, WE SHOULD CONCENTRATE ON  
CERTAIN OF THE CHURCH LEADERS, PUBLISHING SCHOLARS AND  
SOME LABOR LEADERS. THE TOTAL NUMBER OF THOSE WHO SHOULD  
GET SPECIAL ATTENTION ON THIS ISSUE--THEY ARE SUPPORTERS  
OR PERSUADABLES--IS NO MORE THAN 300. ENO COMMENT.

(D) CHURCH LEADERS. THE AMERICAN BISHOPS' LETTER HAS  
HURT US. WE NEED REPLIES. THESE CAN BE IN WRITING,  
WHICH WE CAN CIRCULATE BY HAND AND SEEK TO HAVE PUBLISHED  
IN CHURCH PERIODICALS. PERHAPS EVEN MORE HELPFUL WOULD  
BE VISITS BY PERSUASIVE CHURCH LEADERS AND INTELLECTUALS.  
WE WOULD VERY MUCH WELCOME THE ASSISTANCE OF SOMEONE

6. SELECTING EFFECTIVE THEMES IS THE MOST IMPORTANT PART OF OUR EFFORT. IF WE SAY THE WRONG THINGS, OR EVEN THE RIGHT THINGS IN THE WRONG WAY, WE LOSE GROUND WITH ALL OUR AUDIENCES--FROM THE CABINET TO THE PUBLIC. WHILE REQUIREMENTS MAY VARY FROM COUNTRY TO COUNTRY, WE SUSPECT THERE IS A GOOD DEAL OF COMMONALITY TO THEMES THAT WILL REALLY PROVE EFFECTIVE.

7. FIRST, WE HAVE TO SEIZE THE HIGH GROUND: PEACE. PRESERVATION OF PEACE IS OUR GOAL, AND ALL OUR POLICIES--FROM CREDIBLE DETERRENCE TO ARMS REDUCTIONS--ARE PURSUED WITH THE AIM OF PROTECTING PEACE WITH FREEDOM. WE TOUCHED ON THIS THEME IN REFTEL "B", AND IT CAN BE DEVELOPED FURTHER. A PERSUASIVE CASE FOR PEACE ADDRESSES THE FEARS AND LONGINGS OF DUTCH MEN AND WOMEN, AND WE SUSPECT PEOPLES FAR BEYOND THIS NATION. WE HAVE MADE A TERRIBLE MISTAKE IN LETTING THE SO-CALLED "PEACE" MOVEMENTS MONOPOLIZE THIS ISSUE. WE MUST REPEAT OUR GOAL AND THE ARGUMENTS WHY OUR POLICIES ARE WORKING--AGAIN AND AGAIN AND AGAIN. THIS THEME SHOULD DOMINATE ALL OUR OFFICIAL STATEMENTS. THE BIG TRUTH HAS ONE THING IN COMMON WITH THE BIG LIE; IF IT IS REPEATED OFTEN ENOUGH, PEOPLE WILL BELIEVE IT.

8. THE SECOND MAJOR THEME--WITH ACCOMPANYING ARGUMENTATION--SHOULD BE THAT PREPARATIONS FOR DEPLOYMENTS AND DEPLOYMENTS THEMSELVES ARE THE MOST POWERFUL SUPPORT THE DUTCH CAN GIVE IN SUPPORT OF THE NEGOTIATORS IN GENEVA. INDEED, NEGOTIATIONS NEED NOT CEASE AFTER DEPLOYMENTS HAVE BEGUN; IT MAY WELL BE THAT THEN AND ONLY THEN WILL THE SOVIETS MAKE SIGNIFICANT CONCESSIONS. (EXAMPLES FROM THE HISTORY OF U.S.-SOVIET NEGOTIATIONS CAN BE CITED.)

9. A THIRD THEME FOR USE WITH THE DUTCH IS THAT RESPONSIBILITIES FLOW FROM THEIR MEMBERSHIP IN NATO, A MEMBERSHIP WHICH IS WIDELY SUPPORTED AMONG VIRTUALLY ALL ELEMENTS OF THE POPULATION. WHILE THE DUTCH ATTACHED A RESERVATION TO THE 1979 DECISION IN REGARD TO DEPLOY-

MENTS HERE, THEY HAVE AN OBLIGATION TO SHOULDER RESPONSIBILITIES OF ALLIANCE MEMBERSHIP AS WELL AS SHARING IN ITS BENEFITS. THEY CAN BE REMINDED THAT THE EXTENT OF THEIR INFLUENCE ON ALLIANCE POLICY IS CLOSELY PROPORTIONAL TO THEIR CONTRIBUTION TO THE COMMON DEFENSE. THIS THEME WILL BEAR ONLY SO MUCH WEIGHT, BUT IT CAN USEFULLY BE REFERRED TO AT LEAST ONCE IN EVERY PRESENTATION. ANOTHER NATO ASPECT WORTH HIGHLIGHTING IS THE EXTRAORDINARILY CLOSE ARMS CONTROL CONSULTATIONS THAT THE ALLIES PARTICIPATE IN IN THE CONTEXT OF THE 1979 DECISION. THIS CAN HELP MITIGATE THE FEELING MANY DUTCH HAVE THAT THEY ARE HELPLESS TO CONTROL THEIR OWN DESTINY.

10. A FOURTH THEME, WHICH THE VICE PRESIDENT INTRODUCED AND WE BELIEVE (WITHOUT FIRM PROOF) WAS EFFECTIVE IS THE MORALITY OF THE ZERO/ZERO OPTION--TO RID THE WORLD OF A WHOLE CLASS OF NUCLEAR WEAPONS. THE ONLY COUNTER-ARGUMENT ONE HEARS HERE IS THAT THE SOVIETS WILL NOT ACCEPT IT BECAUSE WE ARE ASKING THEM TO TAKE A MAJOR STEP TOWARD "UNILATERAL DISARMAMENT," GIVING UP ONLY "PAPER MISSILES" IN RETURN. THE ANSWER TO THAT IS TO DEPLOY "REAL MISSILES" AND NEGOTIATE.

11. A FIFTH THEME, WHICH CAN BE USED SELECTIVELY WITH THOSE WHO TRY TO THINK SERIOUSLY ABOUT SECURITY ISSUES, IS THE COUPLING EFFECT (U.S. AND WESTERN EUROPE) OF DEPLOYMENT. WHILE WE PREFER A ZERO/ZERO OUTCOME AT GENEVA, THERE IS A BENEFIT IN STRENGTHENED COUPLING IF DEPLOYMENTS TAKE PLACE. WE HAVE FOUND THE COUPLING ARGUMENT EFFECTIVE WITH SOME OF OUR TARGETED INDIVIDUALS WHO DID NOT UNDERSTAND THE CONCEPT. IT ALSO HELPS TO REMIND DUTCH INTERLOCUTORS THAT SINCE DEPLOYMENTS WOULD IN FACT INCREASE THE NUMBERS OF WARHEADS THAT COULD STRIKE THE U.S.S.R. BY ONLY A SMALL PERCENT, THE COUPLING

EFFECT OF DEPLOYMENTS MAY BE THE PRIME MOTIVATION FOR SOVIET OPPOSITION RATHER THAN AN INCREASED THREAT AS THEY CLAIM.

12. THE SIXTH AND FINAL THEME WE SUGGEST FOR USE HERE IS THAT WE STRESS THAT THE ACTUAL NUMBERS OF FOUR WARHEADS IN EUROPE HAVE DECLINED IN RECENT YEARS, AND THAT

COOPERATING AND OPPOSING ORGANIZATIONS

13. COOPERATING GROUPS ARE NOT MANY NOR TERRIBLY EFFECTIVE. SOME HELP IN THE PUBLIC DOMAIN MAY COME FROM THE DUTCH ATLANTIC COMMISSION, THOSE INVOLVED WITH THE ANTI-UNILATRALIST "MUTUAL" DISARMAMENT GROUPS, THE NEWLY-FORMED INSTITUTE FOR INTERNATIONAL AFFAIRS, AND A HANDFUL OF OTHERS. WE KNOW THEM, AND CAN CALL ON THEM AS SPECIFIC NEEDS ARISE.

14. THE ACTIVE ORGANIZED OPPONENTS, WHILE A DECIDED MINORITY, ARE MORE NUMEROUS THAN ACTIVE SUPPORTERS; THESE OPPONENTS FEEL VERY INTENTLY ABOUT THE ISSUE, ARE WELL ORGANIZED AND HIGHLY MOTIVATED. THEY INCLUDE: THE LABOR AND SMALL LEFT PARTIES; THE DUTCH INTER-CHURCH PEACE COUNCIL (IKV); PAX CHRISTI; THE "STOP THE N-BOMB/STOP THE ARMS RACE" GROUP; WOMEN FOR PEACE; WOMEN AGAINST NUCLEAR WEAPONS; AS WELL AS ASSORTED SMALLER GROUPS WHOSE MEMBERS OPENLY DISLIKE THE UNITED STATES AND WANT TO SEE IT LOSE INFLUENCE AND POWER. THERE ARE OTHER GROUPS WHO ARE NOT ANTI-AMERICAN BUT SIMPLY FEAR, AND THEREFORE DISLIKE, NUCLEAR WEAPONS. WE ARE UNLIKELY TO WIN ANY OF THESE GROUPS TO OUR SIDE, AND WE BELIEVE WE SHOULD NOT WASTE OUR TIME WITH THEM ON THIS ISSUE. MOREOVER, WE SHOULD DO NOTHING TO ENHANCE THEIR PRESTIGE, SUCH AS INCLUDING THEM IN EVENTS WE SPONSOR.  
KEY DATES

15. THE GON WILL POSTPONE MAKING DECISIONS IN THE PUBLIC DOMAIN AS LONG AS IT CAN. BUT THERE ARE FEW DECISIONS REMAINING ON THIS ISSUE THAT THE GON CAN TAKE BEHIND THE SCENE. LABOR AND THE OTHER OPPOSITION PARTIES WILL DOUBTLESS SEEK THE FIRST OPPORTUNITY FOR A PARLIAMENTARY VOTE IN WHICH THEY CAN WIN OR SERIOUSLY EMBARRASS THE GOVERNMENT. THE FIRST TEST WILL COME IN MARCH IF LABOR ATTEMPTS TO REDUCE THE NATO INFRASTRUCTURE BUDGET (A LA DENMARK). THE GOVERNMENT WOULD PROBABLY WIN. PUBLIC DEBATE WILL CONTINUE THROUGH THE SPRING AND SUMMER (AND

BEYOND). THE DEFENSE PAPER--PROJECTING THE COUNTRY'S DEFENSE NEEDS OVER THE NEXT DECADE--IS DUE IN SEPTEMBER, AND ITS PUBLICATION WILL INTENSIFY THE DEBATE, ESPECIALLY IN PARLIAMENT. IN ADDITION, WHEN A BASING SITE FOR POSSIBLE DUTCH DEPLOYMENT IS ANNOUNCED--POSSIBLY TOWARDS THE END OF THE YEAR--A PARLIAMENTARY VOTE WILL SURELY FOLLOW, WHETHER IN A MATTER OF DAYS OR MONTHS IS MOOT. ON OCTOBER 29, VERY POSSIBLY IN THE COURSE OF THE PARLIAMENTARY DEBATE ON THE DEFENSE PAPER, THERE WILL BE A LARGE ANTI-DEPLOYMENT PUBLIC DEMONSTRATION IN THE HAGUE, WHICH MAY ECLIPSE THE NOVEMBER 21, 1981 DEMONSTRATION IN AMSTERDAM.

USIA SUPPORT REQUIRED

16. WE CAN USE MORE PERSUASIVE SPEAKERS (WHOM WE HAVE AN OPPORTUNITY TO BRIEF THOROUGHLY). SPEAKERS WITH GOOD CHURCH CREDENTIALS, LEFT-OF-CENTER REPUTATIONS ON NON-DEFENSE ISSUES, MEMBERS OF CONGRESS, ADMINISTRATION OFFICIALS, CAN ALL BE UTILIZED. THE MORE ADVANCE NOTICE THE BETTER, BUT WE CAN USUALLY PUT SOMETHING WORTHWHILE TOGETHER IN TWO WEEKS.

17. NEWSCLIPS, FILMS, VTR'S, PHOTOS, ETC., ARE HARD TO PLACE IN THE ULTRA-SENSITIVE MASS MEDIA, BUT WE BELIEVE THAT ARTICLES OR COMMENTS BY CHURCH LEADERS CAN BE USED IN CHURCH PUBLICATIONS. WIRELESS FILE PIECES ARE READ HERE BY MANY OF THE "300" THAT WE HAVE SPECIALLY TARGETED. OUR WORD-PROCESSING SYSTEM IS TOO SMALL AND THE ABSENCE OF A SKILLED PROGRAMMER LIMITS FURTHER ITS USE. THE SOON-TO-BE INSTALLED VS-80 COMPUTER REPORTEDLY DOES NOT HANDLE THE CURRENT DRS-PROGRAM. SINCE THE INF DEBATE WILL DOUBTLESS CONTINUE WELL INTO 1984 AND PROBABLY BEYOND, WE BELIEVE A TDY-ASSIGNMENT OF A USIA COMPUTER/DRS EXPERT WOULD BE A GOOD INVESTMENT.

CONCLUDING COMMENT

18. YOU PROBABLY KNOW WITHOUT OUR REPORTING IT THAT THE PERSONNEL CHANGES IN ACDA HAVE CONFOUNDED OUR FRIENDS AND DELIGHTED THE OPPOSITION. THE PUBLICITY GIVEN THE BT

SUBJECT: Public Opinion Survey on Security Matters

Attached are comments that Ambassador Dailey and I have received on the survey. The recommended modifications should be incorporated in the next survey.

## General Observations

1. The questions should be reformed so that they present simple dichotomous choices (to the extent possible). Rather than asking respondents to choose one of four phrases that describe both the US and USSR, we should separate them and ask whether each single phrase is more descriptive of the US or the USSR. Respondants will be able to answer both either or neither on their own.

2. The dichotomous questions should be followed with an intensity measure question--Is the difference (just described above) between the US and USSR slight or large?

3. The open ended questions should be moved up in the survey. Before we begin to pepper the interviewee with questions on INF, we might ask what his first thoughts are when he hears the term "intermediate range nuclear forces," and why he favors or opposes NATO deployment.

4. The questions that provide information about the INF status quo and policy should be moved to the back of the survey. We are interested in gauging both current impressions and how those impressions could be changed when more information is provided.

5. We should include questions about the host government's INF policy. Do the populations see a gap between the US and other NATO governments on this issue?

6. There should be a screening question--whether the respondent has been publicly active on the INF question--before asking the specifics.

7. We should include agree/disagree questions on the themes that we and the Soviets have been using. We must find out what sells.

Comments on Specific Questions

#2. Simplify. Is the US or the USSR better described by the following phrase:

Their strategy is to achieve military superiority. Is there a big difference or slight difference between them on this issue?

Is the US or the USSR better described by the phrase:

Their strategy is to achieve military equality and balance. Is there a big difference or a slight difference between the US and USSR?

#3. Simplify, break up the questions, and add an intensity measure.

#6. Measure whether the populations fear that US as well is likely to try to press the country to do things against their best interests. Structure this as a dichotomous question with an intensity indicator follow-up.

#8. This should be preceded by an an open ended question about first thoughts on intermediate range nuclear weapons.

#10. Simplify, add an intensity indicator.

#11. Move this question back in the survey - Providing the information at this point means you no longer can measure pre-existing attitudes.

#13. Move this question back

#14. Add a screen about whether they have been politically active on this issue.

#15. Break this question up into approve disapprove with an intensity indicator. It may be that people have inconsistent views.

#16. Add a question about the host government.

#18. Move this question earlier in the survey.

ALLIANCE UNITY REFLECTS OUR COMMON ADHERENCE TO CERTAIN FUNDAMENTAL PRINCIPLES--E.G., FREE AND OPEN SOCIETIES AND GOVERNMENT BY THE ACTUAL CONSENT OF THE GOVERNED. B. SUGGESTED "ROADMAP" FOR DISCUSSING INF

A. NATO UNITY: NATO IS A DEFENSIVE ALLIANCE AND THE REAL PEACE MOVEMENT. 1. C - ENTIRE TEXT.

2. AS RECENT EVENTS IN DENMARK AND NORWAY HAVE DEMONSTRATED ONCE AGAIN, OPPOSITION SOCIALIST AND SOCIAL DEMOCRATIC PARTIES -- MANY OF WHICH BACKED THE 1979 INF DECISION WHEN THEY WERE IN GOVERNMENT -- ARE PLAYING AN ASSERTIVE AND ALL TOO OFTEN UNSUPPORTIVE ROLE IN THE EVOLVING INF DEBATE. AS A RESULT THEY ARE ABLE TO INFLUENCE BOTH PUBLIC UNDERSTANDING OF THE ISSUE AND, IN SOME CASES, THE APPROACH AND PUBLIC POSTURE OF GOVERNMENTS THEMSELVES ON THE IMPLEMENTATION OF THE 1979 DECISION. POSTS SHOULD THEREFORE PLACE A HIGH PRIORITY ON SUSTAINING WITH INFLUENTIAL DEMOCRATIC LEFT OPPOSITION GROUPS A DIALOGUE ON INF FOCUSING ON THE SAME POINTS -- SUCH AS IN REFTEL -- THAT WE ARE CONVEYING TO GOVERNMENTS AND PARTIES IN POWER.

3. IT IS OBVIOUS THAT SOME ARGUMENTS ARE MORE RELEVANT TO THE CONCERNS OF CERTAIN GROUPS THAN OTHERS, AND JUDICIOUS SELECTION AND EMPHASIS ARE ESSENTIAL IF OUR MESSAGE IS TO GET THROUGH. WE WOULD THUS WELCOME ANY COMMENTS YOU MAY HAVE ABOUT THE MOST EFFECTIVE WAY TO "REACH" LOCAL LEFT OPPOSITION GROUPS OR THE LEFT OPPOSITION GENERALLY IN EUROPE.

4. POSTS SHOULD ALSO BE ALERT TO AND INFORM DEPARTMENT OF OCCASIONS WHICH WE SHOULD TAKE ADVANTAGE OF BY PROVIDING CURRENT INF ARGUMENTATION TO SELECTED PARTICIPANTS. THESE RANGE FROM POSTS' OWN CONTACTS WITH HIGH-LEVEL INTERLOCUTORS ON THE DEMOCRATIC LEFT TO SCHEDULED SI MEETINGS OR OTHER GATHERINGS, SUCH AS THOSE OF THE SMALL COUNTRY PARTIES, WHICH MIGHT INCLUDE

In our public campaign to retain the initiative on arms control issues in general, and INF in particular, we are our plan is to keep

One important aspect of our public campaign to retain the initiative on INF is a series of authoritative public statements by ~~U-S-government~~ high U.S. government officials. The President addressed arms reduction issues in his State of the Union message, and in his address to the American Legion on February 22. The Vice President ~~xxxx~~ during his trip to Europe and in two major addresses put forward the U.S. position on I.N.F.

~~xxxxxx~~ It is important for our INF policy that you take a more active role in explaining U.S. arms reduction policies, and INF policies in particular. You have not made a major address on this subject, ~~xxxx~~ ~~xxxxxxx~~ You are a trusted and respected figure in Europe,

and ~~x~~ an address by you in the next several weeks would help keep the initiative on these issues. ~~xxxxxxx~~  
The overall approach of your ~~xxxxxx~~ speech, as I would envision it, would be to emphasize that this Administration ~~x~~has taken a new approach to arms control - arms reductions.

1. Equality of rights and limits between the US and the USSR.
2. These negotiations, being bilateral in nature, should address only the systems of the United States and the Soviet Union.
3. Limits should be applied to LRINF missiles regardless of location.
4. An agreement limiting nuclear forces should not weaken the contribution of the United States to NATO's conventional deterrence and defense.
5. An agreement resulting from these negotiations must be verifiable.

### President's Feb 22 speech

- The only basis on which a fair agreement can be reached is that of equality of rights and limits between the United States and the Soviet Union.

- As a corollary, British and French strategic systems are, by definition, not a part of these bilateral negotiations and, therefore, not to be considered in them.

- In addition, Soviet proposals— which have the effect of shifting the threat from Europe to Asia—cannot be considered reasonable.

- And finally, as in all areas of arms control, it will be essential that an INF agreement be underwritten by effective measures for verification.
