Veteran War Correspondents

Tony Dolan tells us that a group of correspondent who covered WWII and the Normandy Invasion will be travelling to the commemorative ceremonies in June.

Jack Higginbotham, now writing for the New York Times News Service, is leading the group which will include Jack Thompson who, according to Higginbotham, "is the only surviving correspondent actually present at the invasion." Others who will be present (not necessarily travelling with Higginbotham) include Walter Cronkite, Andy Rooney (who reportedly scaled Pointe du Hoc with the Rangers), and Larry Lesueur.

Higginbotham would be happy if some small recognition is given to these veteran correspondents, and the following suggestions provide ways in which that might be done:

- 1. Rope off a special section at one of the beach ceremonies.
- 2. Get them together for a group interview with the press covering the event, to add another human dimension to the occasion.
- 3. A letter from an appropriate Administration official, taking note of their achievements, past and present, and commending them for their participation in the ceremonies.

I have no idea whether or not the current status of events on the President's itinerary could accommodate a gesture along the above lines but I pass it on to you and Bill Henkel for whatever consideration you think it might merit (it's a good idea from a public diplomacy viewpoint, but like a lot of other good ideas, may simply have come along too late in the game). Higginbotham leaves for London tomorrow (May 24), booked into the Holiday Inn near Marble Arch; he can be reached until then at 817-292-8165. Let me know if you need/desire any follow-up from my office.

I. Central Perceptions

A. Scene

- The President's trip to Ireland, France and the London Economic Summit should be publicly viewed as a practical expression of the foreign policy principles articulated in the April 6th CSIS speech: Realism, Strength, Economic Growth, Shared Responsibility With Allies, Non-Aggression, and Dialogue With Adversaries.
- Explicitly or implicitly every part of the June itinerary should provide mutual reinforcement for one or more of these principles.
- -- The importance of the President's June travel will transcend not only the London Summit itself but in a real sense the entire European itinerary: our objective, by the time the trip is completed, will be to reassert U.S. interest in a stronger and viable Europe within a larger policy context embracing both the Atlantic and Pacific communities, while stressing shared democratic values.

B. Primary Perception

- A Strong President and the American Renewal: assertive U.S. leadership is essential to world peace and prosperity.

C. Supporting Perceptions

- The Dynamics of Interdependence: genuine peace is a product of Western strength, constancy, and cohesion.
- Keeping Our Powder (And Our Provender) Dry: viable Western security depends on both economic and defense cooperation.
- -- Reality Is Catching Up With Ronald Reagan's Vision: convergence of the Atlantic and Pacific communities as a positive trend in the late 20th Century.
- -- Continuity and consistency: from Williamsburg to London, a full year of successful high-level meetings with foreign leaders (forging solidarity at Williamsburg Summit; expanding Pacific ties with Korea and Japan; furthering normalization with China; re-emphasis on the Atlantic relationship).

D. Individual Locations and Matching Themes

1. Ireland

General Theme: "Return To American Roots"

Specific Emphases

- -- Ireland as a link between two continents.
- -- Importance of European integration (Ireland assumes EC presidency in July).

Public Affairs Plan for the Economic Summit

Last week I met with Bob Kimmitt, Doug McMinn and Marlin Fitzwater to discuss a public affairs plan for the Economic Summit and the question of whether or not we should hire someone to run this particular effort. We discussed the fact that there would be a difference between the public affairs effort this year and last year, particularly in view of the fact that we are no longer hosts. We agreed, however, that this year's political atmosphere would necessitate special attention to the public affairs aspects of this Summit. We agreed that particularly in the areas of trade and monetary matter we could have some vulnerability and that these issues should be reviewed so that matters in these areas which are presently scheduled for discussion or decision between now and the time of the Summit could be carefully coordinated in terms of our overall communications effort. I suggested that we use Ambassador Jim Rentschler once again as the Public Affairs Coordinator and everyone agreed. I suggested that we ask him to outline for us on a piece of paper the job as he would see it for this particular Summit and the goals that need to be accomplished over the next several months. I talked with Jim Rentschler following the meeting and he expressed an interest in taking on this assignment and agreed that he would get such a paper to me by the end of this week. I suggested to him that he would also want to get an outline of all the various trade issues that are up for consideration or discussion that could be Summit related over the next several months, together with any trade missions or other Summit related meetings which would occur between now and the time of the Summit. Once he had all of these together, we could better coordinate what we wanted to get out of each particular meeting and better coordinate our communications effort. Since we had also discussed the possibility of there being a space item on the agenda or raising the issue of international terrorism again, these two issues should also be given some consideration. In addition, we need to consider the stories out of the President's visit to Ireland and to Normandy prior to the Summit as well as any bilaterals which may take place around the time of the Summit itself.

Lastly, we need to focus on the actual Summit events in order to properly portray, as best we can, the President as a world leader not only for the purpose of the press coverage of the Summit itself, but also for the documentary which will be filmed during our visit to Ireland, France and England.

Jim told me that he would try to get a paper in very general terms back to me by the end of this week so that it can be reviewed by both you and Bud McFarlane, and then I suggest that we formally give Jim the assignment and have him go into the more detailed areas. We also need to focus on how early he needs to come back to Washington to begin this effort. It is my view that this should be as soon as possible since we need to get the overall effort coordinated and agreed upon prior to the President's trip to China and we may want to have part of this effort included in the pre-advance visit to Europe.
