AFGHANISTAN

US reaction to the political reality of Soviet Union dominance in Afghanistan

- o The Soviets do not dominate Afghanistan. They are trying to do so by direct military force and are devastating the country in the process.
- o As we have repeatedly made clear, this is a threat to world stability, and is not consistent with Soviet professions of a desire to settle disputes peacefully.
- o We believe Afghanistan should be restored to its non-aligned status, which is a threat to no country, and that the people of Afghanistan should be allowed to choose their own government.
- o If the Soviets ever decide to withdraw, we will do what we can to provide assurances that Afghanistan would not be used to threaten them.
- o What is important is for the Soviets to decide to withdraw.
