WE HAVE NOW RECEIVED AN UPDATED VERSION OF WHAT SENATOR CRANSTON INTENDS TO MOVE BY WAY OF AN AMENDMENT TO THE CONTINUING RESOLUTION -- PROBABLY ON THURSDAY BUT WITH VOTE DELAYED TO FRIDAY OR LATER. AMENDMENT WILL BE SPONSORED BY SENATORS CRANSTON, HATFIELD, GLENN, STAFFORD, PELL, AND PROXHIRE; THE "DEAR COLLEAGUE" LETTER ACCOMPANYING, WE UNDERSTAND, IS SIGNED BY ALL OF THOSE PLUS SENATORS MOYNIHAN AND LEVIN.

2. REVISED DRAFT TEXT OF AMENDMENT IS AS FOLLOWS: AT AN APPROPRIATE PLACE IN THE BILL ADD THE FOLLOWING: THE FOREIGN ASSISTANCE ACT OF 1961, AS AMENDED, IS FURTHER AMENDED BY ADDING THE FOLLOWING NEW SECTION: S-620F. NUCLEAR NON-PROLIFERATION CONDITIONS ON ASSISTANCE PAKISTAN:

A. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AND IN ACCORDANCE WITH THE PROVISIONS OF SUBSECTION (B), NO DEFENSE ARTICLES OR SERVICES SHALL BE SOLD OR OTHERWISE PROVIDED TO PAKISTAN, AND NO MILITARY CREDITS OR ASSISTANCE SHALL BE FURNISHED, IF NINETY DAYS AFTER THE

ENACTMENT OF THIS SECTION, PAKISTAN ENGAGES IN A PROGRAM TO DEVELOP OR CONSTRUCT A NUCLEAR EXPLOSIVE DEVICE, OR ACQUIRES TECHNOLOGY OR EQUIPMENT FOR USE IN A NUCLEAR EXPLOSIVE DEVICE, OR PRODUCES SPECIAL NUCLEAR MATERIAL IN A FORM AND CONCENTRATION SUITABLE FOR NUCLEAR EXPLOSIVE PURPOSES.

B. THE PROHIBITIONS IN SUBSECTION (A) ON ASSISTANCE TO PAKISTAN MAY BE WAIVED BY THE PRESIDENT IF, AFTER RECEIVING INFORMATION REQUIRING TERMINATION OF SUCH ASSISTANCE, THE PRESIDENT DETERMINES IN WRITING TO THE CHAIRMAN OF THE SENATE FOREIGN RELATIONS COMMITTEE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, SUCH TERMINATION WOULD IRREVOCABLY HARM THE URGENT NATIONAL SECURITY INTERESTS OF THE UNITED STATES. SUCH DETERMINATION BY THE PRESIDENT SHALL BE ACCOMPANIED BY A COMPREHENSIVE REPORT OF SUITABLE ELABORATION DESCRIBING:

(I) ANY ACQUISITIONS BY PAKISTAN OF MATERIAL, EQUIPMENT OR TECHNOLOGY WHICH CAN BE USED FOR THE MANUFACTURE OF NUCLEAR WEAPONS TOGETHER WITH AN ASSESSMENT OF PAKISTAN'S INTENTIONS AND CAPABILITIES FOR USE OF SUCH MATERIAL, EQUIPMENT, OR TECHNOLOGY;

(II) THE IMPACT OF A HALT OF U.S. MILITARY SALES, ASSISTANCE OR CREDITS TO PAKISTAN ON U.S. NATIONAL SECURITY INTERESTS IN THE REGION;

(III) THE IMPACT ON INTERNATIONAL NORMS AGAINST PROLIFERATION OF ONGOING U.S. MILITARY ASSISTANCE IN THE PRESENCE OF A CONTINUING PAKISTAN NUCLEAR EXPLOSIVES DEVELOPMENT PROGRAM;

(IV) THE PROSPECTS FOR SUCCESS OF ANY U.S. INITIATIVE TO MEDIATE THE INDO/PAKISTAN CONFLICT IN ORDER TO REDUCE TENSIONS AND THE MOTIVATION TO ACQUIRE NUCLEAR WEAPONS.

1. SUMMARY: IN HIS ADDRESS TO THE GA, PAKISTAN FOMMIN YAQUB-KHAN REAFFIRMED HIS COUNTRY'S COMMITMENT TO THE UN SPONSORED NEGOTIATIONS ON AFGHANISTAN. HE CALLED FOR REVIVED AND INTENSIFIED DISCUSSIONS WITH INDIA ON ISSUES INCLUDING THE KASHMIR QUESTION AND ON THE RECIPROCAL INSPECTION OF NUCLEAR FACILITIES. END SUMMARY.

2. WORLD SITUATION: IN HIS ADDRESS TO THE GA ON OCTOBER 2, PAKISTAN FOMMIN SAHABZADA YAQUB-KHAN DECLARED THAT INTERNATIONAL PEACE REMAINED ELUSIVE SO LONG AS POWERFUL NATIONS CONTINUED TO USE FORCE WITH IMPUNITY AND UNTIL THE FRONTIERS OF SMALLER NATIONS WERE SECURE AND THEIR RIGHT TO SEEK FREEDOM AND SELF-DETERMINATION WAS RESPECTED.

3. AFGHANISTAN: YAQUB-KHAN SAID THAT PAKISTAN WAS ATTEMPTING TO FIND A POLITICAL SETTLEMENT OF THE SITUATION CAUSED BY "FOREIGN TROOPS" IN AFGHANISTAN. THE 1979 MILITARY INTERVENTION HAD ALTERED THE REGIONAL SECURITY ENVIRONMENT AND HEIGHTENED INTERNATIONAL TENSIONS. IT HAD PRODUCED A FLOW OF THREE MILLION REFUGEES INTO PAKISTAN. IT HAD ALSO TRIGGERED A HEROIC INDIGENOUS NATIONAL MOVEMENT OF RESISTANCE WITHIN AFGHANISTAN. REFERRING TO "A SHARP ESCALATION IN THE INTENSITY AND FREQUENCY" OF VIOLATIONS OF PAKISTANI TERRITORY FROM AFGHANISTAN, YAQUB-KHAN SAID PAKISTAN TOOK A SERIOUS VIEW OF THE RECENT ATTACKS, WHICH HAD TAKEN 54 LIVES IN AUGUST AND 32 MORE ON SEPTEMBER 27, AND HOPED THE INTERNATIONAL COMMUNITY WOULD COMPEL A CESSATION OF FURTHER AGGRESSION. YAQUB-KHAN PRAISED THE LATEST ROUND OF UN SPONSORED INDIRECT TALKS AS "A FURTHER STEP FORWARD" AND REAFFIRMED HIS GOVERNMENT'S CO-OPERATION WITH THE SECRETARY-GENERAL'S PERSONAL REPRESENTATIVE IN HIS QUEST FOR A COMPREHENSIVE SETTLEMENT. YAQUB-KHAN DID

NOT MENTION THE SOVIET UNION BY NAME IN HIS DISCUSSION OF AFGHANISTAN, THOUGH THE REFERENCES TO IT WERE OBVIOUS.

4. SOUTH ASIA: YAQUB-KHAN SAID PAKISTAN REMAINED UNDAUNTED BY TEMPORARY SET-BACKS TO THE ACHIEVEMENT OF PEACE AND GOOD RELATIONS WITH INDIA. PAKISTAN WAS PREPARED TO REVIVE AND INTENSIFY NEGOTIATIONS AND TO TAKE CONCRETE STEPS TO BUILD MUTUAL CONFIDENCE AND PROMOTE CO-OPERATION BETWEEN THE TWO COUNTRIES. PAKISTAN, HE SAID, SOUGHT A JUST AND HONORABLE SETTLEMENT OF THE JAMMU AND KASHMIR QUESTIONS IN THE SPIRIT OF GOOD-NEIGHBORLY RELATIONS. YAQUB-KHAN SUPPORTED EFFORTS BY THE SEVEN SOUTH ASIAN NATIONS TO INCREASE AND INSTITUTIONALIZE MUTUAL CO-OPERATION FOR ECONOMIC AND SOCIAL PROGRESS AND TO ESTABLISH A FRAMEWORK FOR REGIONAL CO-OPERATION.

5. REGIONAL DISARMAMENT: YAQUB-KHAN REAFFIRMED PAKISTAN'S ABIDING COMMITMENT TO NUCLEAR NON-PROLIFERATION AND SUPPORTED DISARMAMENT MEASURES ADVANCED IN THE UN FRAMEWORK. HE SUPPORTED THE ESTABLISHMENT OF A NUCLEAR-WEAPON-FREE ZONE IN SOUTH ASIA, AND PROPOSED AN INITIATIVE FOR A JOINT DECLARATION FOR NON-ACQUISITION OF NUCLEAR WEAPONS BY THE REGIONAL STATES. HE RESTATED THE OFFER TO INDIA OF A RECIPROCAL ARRANGEMENT FOR INSPECTION OF NUCLEAR FACILITIES, AND SAID PAKISTAN IS COMMITTED NOT TO DEVELOP NUCLEAR WEAPONS.

6. OTHER TROUBLE SPOTS: YAQUB-KHAN REAFFIRMED PAKISTAN'S POLICY OF SCRUPULOUS NON-ALIGNMENT. HE EXPRESSED ANGUISH OVER THE CONTINUING CONFLICT BETWEEN IRAN AND IRAQ, AND NOTED PAKISTAN'S COMPREHENSIVE MEDIATION EFFORTS. ON THE MIDDLE EAST, HE URGED THE INTERNATIONAL COMMUNITY TO COMPEL ISRAEL TO RESPOND POSITIVELY TO THE NUMEROUS PEACE INITIATIVES. HE CALLED FOR THE WITHDRAWAL OF ISRAELI FORCES AND ESTABLISHMENT OF

A PALESTINIAN STATE. HE REFERRED TO THE 1982 FEZ PLAN, PRESIDENT REAGAN'S 1983 PROPOSALS, AND RECENT PROPOSALS BY THE USSR AS EVIDENCE THAT THE PATH TO PEACE WAS OPEN. YAQUB-KHAN URGED THE WITHDRAWAL OF ALL FOREIGN FORCES FROM KAMPUCHEA AND SUPPORTED THE DEMOCRATIC KAMPUCHEA COALITION. ON CENTRAL AMERICA, HE OPPOSED "ANY MEDDLING BY OUTSIDE POWERS" IN THE REGION AND BACKED THE CONTADORA PROCESS AS THE BEST HOPE FOR HARMONY AND PROGRESS. HE CALLED ON THE INTERNATIONAL COMMUNITY TO SUPPORT THE STRUGGLE BY THE NAMIBIAN PEOPLE AND TO OPPOSE APARTHEID.
