PRESIDENT REAGAN'S TRIP TO ASIA (SPRING 1986) AND GORBACHEV II:

THE PUBLIC DIPLOMACY FRAMEWORK

I -- Core Concept

The President's Asian trip and the Tokyo Economic Summit, followed by Gorbachev II, form a public diplomacy continuum; major thematic chords sounded from the earlier platform should both amplify and reinforce the basic message of the later.

II -- Controlling Theme

The Winds of Freedom: With strong American leadership directed toward building of a better and safer world, the fresh winds of freedom are blowing, East and West.

III -- Target Perceptions

A. Scene

- The President's trip to Guam, Bali, the Tokyo Economic Summit, and any additional stop(s)/event(s) should be publicly viewed as yet another practical and positive expression of the economic principles which he has articulated since the Ottawa Summit of 1981, together with the central foreign policy objectives embodied in his Geneva meeting with Soviet Leader Gorbachev, highlighting
  - improved communication between different societies;
  - peaceful competitiveness of differing political and economic systems;
  - unflagging support for democratic aspirations;
  - free economies which meet human needs;
  - free-nation solidarity in the service of mutual security.
- Explicitly or implicitly every part of the April-May itinerary should provide reciprocal reinforcement for one or more of these principles and further influence the public climate for Gorbachev II.

B. Primary Target Perception

- An energetic President and the continuing American renewal: assertive U.S. leadership is essential to world peace and prosperity.

C. Supporting Target Perceptions

- Reality is catching up with Ronald Reagan's vision: commonality of interests in the Atlantic and Pacific communities now a positive trend in the late 20th Century.
- Recommitment to Democracy: the future lies with those nations espousing full political/economic self-expression and self-determination.
- The U.S. is a reasonable partner in the search for lasting peace.

D. Individual Locations and Matching Messages

1. Guam

- Main theme; indivisibility of democratic freedom.
- Specific emphasis
  - America's role in preserving peace in the Pacific ("No man is an island")

2. Bali/Indonesia

- Main theme: America remains centrally relevant to the promotion of democratic cooperation, economic progress, and security in the Pacific Basin.
- Specific emphases
  - ASEAN contributes to regional stability and prosperity.
  - Indonesia on the path of democracy.
  - U.S. offers a partnership of shared values.
  - Primacy of economic and political freedom (lesson of the Philippines).

### 3. Tokyo Economic Summit/Japan

- Main theme: Summit partners help power the winds of freedom increasingly blowing democratic self-rule and entrepreneurial energy across the globe.
- Specific emphases
  - Free markets. Freedom from encumbering government regulation, ownership, or control, together with freedom of choice for consumers.
  - Free trade. Freedom to flow without barriers or distortions; resistance to protectionism and continuing support for new round of multilateral negotiations.
  - Free investment. Freedom to invest in enterprises; freedom from onerous or growth-depressing taxation which stifles new investment.
  - Free nations. Freedom for LDCs to grow and move toward self-sufficiency through economic reform, reaping the benefits of Summit consensus on sustained non-inflationary market-oriented growth.

### 4. Summit Bilaterals

- Main theme: Western democracies retain the initiative in jointly shaping a freer and safer world.
- Specific Emphases
  - Japan: emerging Japanese role in supporting broader Western security.
  - All: necessity of united stand on East-West issues.
  - All: sincerity of American commitment to progress in U.S.-USSR relationship.

--- All: implications of the Philippines experience directly affect/support Western interest in promoting expanded freedom.

--- All: tightened international cooperation is the key to combatting terrorism.

--- All: tightened international cooperation is also the key to cutting drug traffic.

5. Possible other stop(s)/event(s)  
(appropriate material to be developed)

6. Post-Asia: Gorbachev II (U.S.)

- Main theme: Building on the New Start at Geneva.

- Specific emphases

--- Realism: Pursuit of understanding with the Soviets must continue to proceed in full and frank awareness of the major differences existing between democratic and Communist societies.

--- Reducing, eventually eliminating nuclear and conventional arsenals. We have the opportunity and the mandate to press forward with the reduction of nuclear arsenals.

--- Encourage respect for Human rights. U.S. will remain second to none in the vigorous defense of human rights, believing that countries which respect civil liberties and quality of life are unlikely to unleash war.

- Reducing the use and threat of force. Any recipe for better superpower relations must include Soviet cessation of efforts to expand influence in other countries through armed intervention and subversion.
  
- Building trust, a more cooperative, relationship. Improved people-to-people, as well as government-to-government communication between our countries can promote better understanding and lead to strengthened peace and stability.





TALKING POINTS

-- Trip great success. Tokyo Summit best of six have attended. United front on major issues. Meetings in Indonesia strengthened relations with ASEAN countries.

-- Good meetings in Indonesia. Soeharto and the ASEAN foreign ministers took constructive approach. Region eager to keep relations with us on sound footing; resist Soviets and Vietnamese. Soeharto pressed hard for early launch of Indonesian communication satellite.

-- Tokyo Summit: Especially pleased with statement on terrorism. Commitment from Allies to increase cooperation. Condemnation of Qadhafi. Thatcher's role crucial.

-- Soviet nuclear accident/cover-up contributed to cohesion. Statement expresses sympathy, offers assistance; but calls attention to Soviet behavior -- highlights need for verification.

-- Economic discussions excellent. Allies agree our policies for sustained, noninflationary growth have worked. Have broad agreement for multilateral trade round. Political will to resolve Allied disputes, particularly on agriculture.

-- Nancy immensely helpful. Her trip to Malaysia and Thailand successful. Step forward in worldwide fight against drug abuse.

-- In sum, a super trip, a great Summit. Now let me turn to Don and John for their thoughts on the economic and political aspects of the trip.

The first meeting of the Summit White House Group (SWHG) has been scheduled for Monday, April 7, 1986, with the President. The purpose of the meeting is to review progress on preparations for the Tokyo Economic Summit that have been undertaken by the Summit White House Working Group, and to bring the President up-to-date on the economic and political issues that will be raised at the Summit. In addition, there will be a brief presentation on the public diplomacy program, currently underway, for the President's Far Eastern trip.

Introductory Remarks

- Today's meeting has been called to review preparations for the Tokyo Economic Summit (May 4-6).
- Since December, Summit preparations have been undertaken by a Summit White House Working Group, chaired by Dennis Thomas and Don Fortier.
- The Working Group has made considerable progress in laying the groundwork for a successful Summit.
- At the present date, the President's Far Eastern trip (the longest trip outside the United States during his Presidency) has been completely advanced.
- The trip will have two major parts: a visit to Bali (Indonesia) for a meeting with ASEAN officials and, of course, the Tokyo Summit.
- Our focus today will be on the Tokyo Summit, but the ASEAN trip, as it relates to political issues and our public diplomacy efforts, will also be considered.
- There are three areas which we will discuss today.

- o First, the status of the preparatory process and the economic agenda. Allen Wallis who is, as he has been for the previous three Summits, your Personal Representative (for Tokyo), will speak on this issue.

As you indicated, some of these economic issues will be further developed over the next weeks, at the IMF meeting, the OECD and the final Sherpa meeting in Paris. To that end, Mr. President, we have scheduled another meeting of this group on April 24, just before your departure. Until then, Allen and the Sherpas will be providing briefing and background papers for your weekend reading. Shorter versions of those papers will be included in your briefing book to be delivered on April 18.

-- The next item on the agenda today is the political background to the Summit. The other leaders will of course be anxious to meet privately with you, Mr. President, and as usual during Economic Summits, political issues will be dealt with as part of the formal agenda. Secretary Shultz, the man who was present at the creation of the Economic Summit process, will speak to these issues.

Turn to Shultz/Ridgway

[Shultz/Ridgway]

-- Finally, in the time remaining, I would like to ask Jim Rentschler to describe the public diplomacy program for the Summit, and the entire Far Eastern trip. The Summit White House Working Group developed and adopted a thematic approach for your Pacific visit. This approach follows logically your challenge to the Soviet Union prior to Geneva when you told the European Parliament that we are "in for an extended period of competition of ideas," and when you expressed confidence that "our ideals of freedom and democracy and our economic systems have proven their ability to meet the needs of our people." Well here is our opportunity to invite the world to witness the difference between our economic and political system and theirs; to observe firsthand the performance and energy of free markets, free enterprise and free peoples; to demonstrate the inexorable convergence and attraction of political and economic freedom. We call the theme the "Winds of Freedom," and it reflects a recognition of what recent developments around the world show: that history is proving us correct, Mr. President.

-- Jim, why don't you tell us where we are on the public diplomacy program?

[Rentschler presentation]

-- We can now open the meeting up to any comments or discussion.

In closing

-- We will now all begin to fully focus in the next few weeks on the final preparations for the Tokyo Summit and the trip to the Far East. I know that all of you present are participating in the development of the President's briefing books. There will be an NSC meeting to discuss political and bilateral issues on April 22. Another meeting of this group is scheduled to take up economic issues on April 24.
