I have not seen my brother since the convention after a chance meeting in a convention hall aisle (where we chatted with three or four other people

for possibly five or ten minutes) except for one occassion three weeks ago when he came over to my brother im laws. I immediately left the house and simply said hello to him. The day was the Sunday of the week of the Democratic convention. I want to stress again that I have been scrupulous about this matter. I have not and will not discuss campaign matters with anyone who might be tied to an independent expenditure group.

3. I discussed this matter with ED Meese and showed him my earlier memo to you on it. I did this three weeks ago and we have been religous about avoinding
