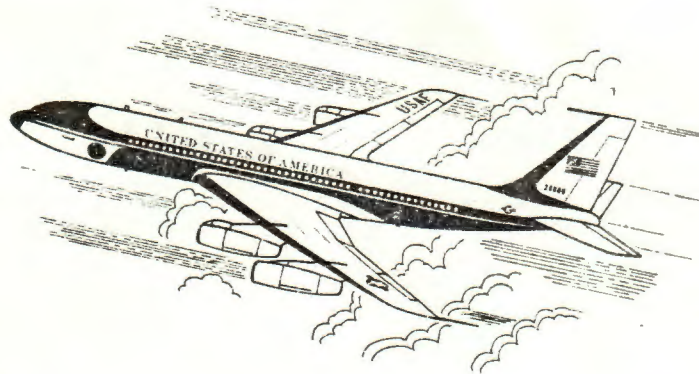
SUBJECT: WELCOMING EVENTS IN SAN FRANCISCO HONORING QUEEN ELIZABETH

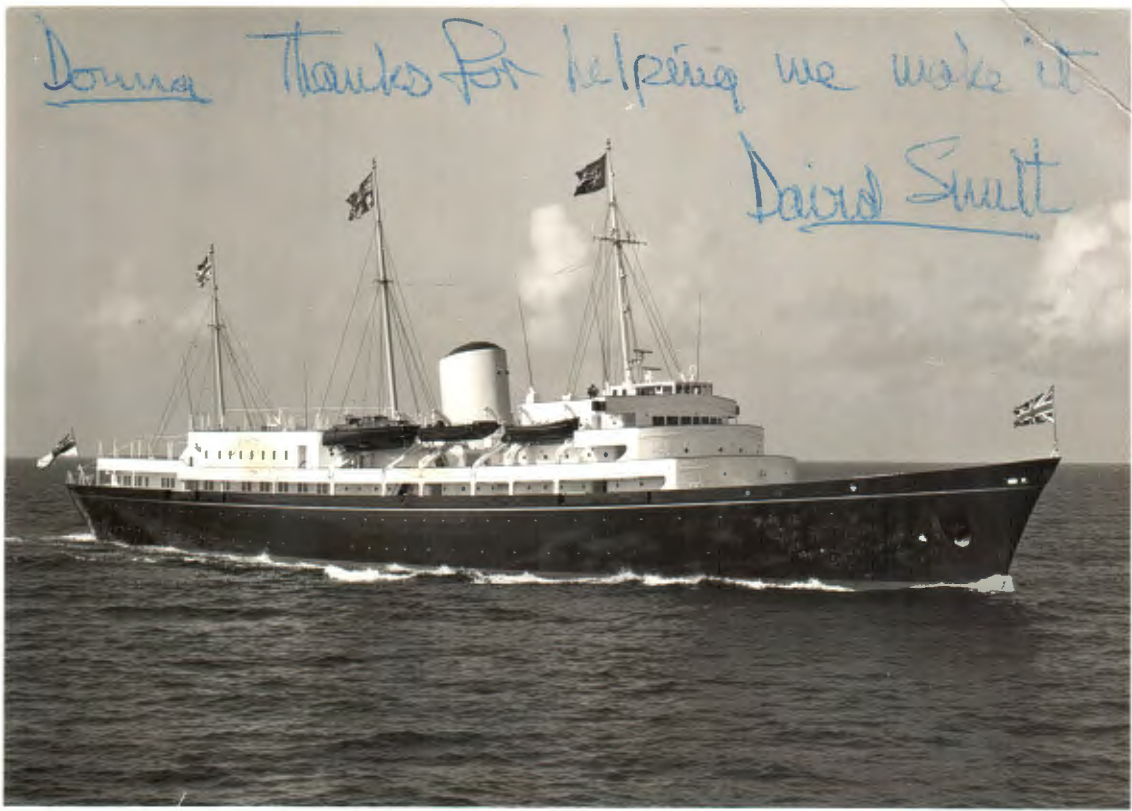
