DEDICATION OF THE DITCHLEY BELLS IN WASHINGTON DC 18/19 APRIL 1983

Her Royal Highness Princess Alexandra and the Hon. Angus Ogilvy will visit Washington for the Dedication of the Ditchley Bells on 18/19 April 1983.

The Ditchley Bells are a gift from the Ditchley Foundation in Great Britain to the United States Congress to commemorate the 1976 Bicentenary of the United States of America. The gift was made possible by Sir David Wills, who founded Ditchley Park in Oxfordshire, England as an Anglo-American Conference Centre where high level representatives from Britain and the United States could meet informally to discuss major international issues and, in so doing, could strengthen co-operation between the two countries.

The Bells, which are installed in the Old Post Office Tower on Pennsylvania Avenue in Washington DC, will be dedicated on 19 April. The dedication ceremonies will form part of the commemoration of the Bicentenary of the formal termination of hostilities at the conclusion of the War of Independence.

The commemoration will commence with a lecture given by The Right Honorable Lord Home of The Hirsel on "Today's Challenges to Democracy" at The National Academy of Sciences in Washington DC at 6.00 pm on Monday, April 18. The lecture will be followed by a dinner at the State Department. The dedication of the Ditchley Bells will take place at 11.00 am on Tuesday, April 19 at the Old Post Office Tower on Pennsylvania Avenue in the presence of representatives of the US Government, Congressional leaders, HRH Princess Alexandra and The Hon. Angus Ogilvy, and the Right Honourable Paul Channon, British Minister for the Arts.

Further details of the press facilities at these events will be given in due course.

NOTES FOR EDITORS

The Ditchley Bells:

The Ditchley Bells, cast in the Whitechapel Bell Foundry in London where the Westminster Abbey Bells were cast in 1596, have the same pitch and tone as the Abbey Bells. Each carries two symbols - the great seal of the United States and Britannia. The flower "London Pride" is engraved around the base of the Bells to denote the connection with London, and the headstocks are engraved with Westminster Abbey's coats of arms. The tenor bells carry the three words "wisdom" "courage" and "love". The treble bells bear

words "Fide et Constantia" the motto of the Lee family who built the present house at Ditchley Park during the reign of Queen Elizabeth I and lived there for over 300 years.

Dedication of the Ditchley Bells:

The dedication of the Ditchley Bells will form a part of the ceremonies commemorating the bi-centenary of the ending of hostilities between Britain and the United States at the conclusion of the War of Independence. On 18 April 1783 General George Washington issued a proclamation ordering "the cessation of hostilities between the United States of America and the King of Great Britain to be publicly proclaimed tomorrow at 12 o'clock". Washington recorded that the cessation of hostilities would afford "sincere satisfaction to every benevolent mind, as it puts a period to a long and doubtful contest, stops the effusion of human blood, opens the prospect to a more splendid scene and, like another morning star, promises the approach of a brighter day than hath hitherto illuminated the Western Hemisphere".

The Ditchley Foundation:

The Ditchley Foundation was created in 1958

"to promote the joint study of and education in, matters of common interest to British and American peoples".

The first Anglo-American Ditchley conferences were held at Ditchley Park in 1962. Two years later, the American Ditchley Foundation was formed under US law, with similar purposes and especially to help the original Foundation in Britain. The British headquarters of the organization are at Ditchley Park, an 18th century house near Oxford built by Sr Henry Lee whose nephew was an ancestor of General Robert E Lee. During the Second World War the house was one of the wartime headquarters of Sir Winston Churchill and made a special contribution to contemporary British and American history through the many important talks with American leaders which Churchill held there.

Ditchley Conferences:

Conferences at Ditchley are organized on a regular basis to study major aspects of public affairs. The conferences may cover geographical themes, eg the Middle East, or institutional themes, eg progress towards European Unification. The conferences are unofficial and off-the-record and have brought together senior members of British Governments and of successive US Administrations. The Chairman of the American Ditchley Foundation is the former US Secretary of State, the Hon Cyrus R Vance.
