- EMBASSY HAS POSED (VIA A U.S. OFFICIAL IN ANOTHER CITY) A NUMBER OF QUESTIONS TO THE ITALIAN OFFICIAL WHO CLAIMS TO HAVE A SOURCE WHO KNOWS WHEREABOUTS OF GENERAL DOZIER. FOLLOWING ARE OUR COMMENTS AND/OR QUESTIONS AND THE REPLIES PASSED BACK TO US BY THE U. S. OFFICIAL:
- WE ARE MOST INTERESTED IN THE PROPOSAL BUT NEED SOME ELUCIDATION. FOR AN OFFICIAL IN YOUR CAPACITY THE PROPOSAL SEEMS IRREGULAR; WHO ELSE IN THE ITALIAN GOVERNMENT KNOWS OF THIS?
- A. NO ONE ELSE KNOWS.
- A SECOND CONSIDERATION IS YOUR SHORT TIME-FUSE REQUIREMENT. WE CAN MAKE NO SENSE OUT OF

THE NEED FOR AN ANSWER TONIGHT. WHAT CONSIDERATIONS DICTATE SUCH A TIME CONSTRAINT?

URGENCY IS DICTATED BY A DESIRE TO ACT BEFORE THE SITUATION CHANGES.

GIVEN THE REQUIREMENT THAT THIS NOT BE LEAKED, HOW IS OUR COMING TOGETHER WITH GEN. DOZIER TO BE ARRANGED? WILL HE BE ALONE, OR STILL IN THE COMPANY OF HIS CAPTORS? IF WITH CAPTORS, WILL WE NEED TO SURPRISE THEM? IS THE GENERAL STILL ALIVE AND PHYSICALLY ABLE TO MOVE ON HIS OWN?

OUR SOURCE WANTS TO GUARANTEE THAT THE MONEY IS AVAILABLE. ONCE HE CAN DO THIS, HE WILL GO TO HIS SUPERIORS REGARDING WHAT ACTION TO TAKE. NO INFORMATION IS PRESENTLY AVAILABLE AS TO WHETHER THE GENERAL IS STILL ALIVE, OR WHETHER HE IS IN THE COMPANY OF HIS CAPTORS. WHY HAS NO EFFORT BEEN MADE TO ASCERTAIN WHETHER

A. THE KEY TO THIS IS OUR SOURCE'S RELATIONSHIP WITH THE INFORMANT. HE FEELS THAT HE CAN ONLY GIVE A GUARANTEE OF FUNDS TO HIS INFORMANT WITH U.S. ASSURANCE THAT THE FUNDS WILL BE AVAILABLE. IF HE APPROACHES THE ITALIAN GOVERNMENT TO OBTAIN SUCH AN ASSURANCE, THE POTENTIAL FOR OBTAINING INFORMATION FROM THE INFORMANT WOULD BE LOST.

1. - ENTIRE TEXT.

2. DCM AND COL. JOHNSON CALLED JANUARY 7 ON MINISTER OF INTERIOR ROGNONI, WHO WAS ACCOMPANIED BY CHEF DE CABINET GASPARRI AND NATIONAL CHIEF OF POLICE CORONAS. DCM INTRODUCED COL. JOHNSON AND SAID THAT IF ITALIAN AUTHORITIES THOUGHT IT USEFUL, WE WOULD BE PREPARED TO BRING A SMALL NUMBER OF SPECIALISTS FROM COL. JOHNSON'S UNIT INTO ITALY NOW. IF IT SHOULD PROVE POSSIBLE TO LOCATE GEN. DOZIER AND IF THE ITALIAN AUTHORITIES DECIDED TO CARRY OUT AN OPERATION TO RESCUE HIM, THESE SPECIALISTS WOULD BE PREPARED TO TAKE PART IN THE ITALIAN OPERATION. THE GROUP WOULD NUMBER NINE MEN, AND WE WOULD PROPOSE TO LOCATE THEM FOR NOW AT A U.S. INSTALLATION, CAMP DARBY.

MESSAGE (CONTINUED):

- 3. ROGNONI SAID IMMEDIATELY THAT THE ITALIAN AUTHORITIES WOULD BE PLEASED TO HAVE THEM COME.
- 4. ROGNONI THEN ASKED WHETHER THERE WAS ANY POSSIBILITY THAT FUNDS MIGHT BE PROVIDED FROM AMERICAN SOURCES FOR POSSIBLE PAYMENT OF A REWARD FOR INFORMATION ON THE GENERAL'S WHEREABOUTS. THE DCM SAID THAT BEFORE ANSWERING, HE WOULD LIKE TO ASK THE MINISTER ABOUT PRESS REPORTS THAT A GROUP OF ITALIAN FRIENDS OF THE GENERAL MIGHT BE READY TO OFFER SUCH A REWARD. THE MINISTER GAVE A VERY INDEFINITE REPLY, TO THE EFFECT THAT HE WAS NOT CERTAIN WHAT MIGHT BE DONE IN THAT DIRECTION. IN ANY CASE, THE MINISTER SAID, IT WOULD BE EXTREMELY IMPORTANT THAT ANY REWARD PAID NOT END UP IN THE HANDS OF THE RED BRIGADES. THE MINISTER SAID THAT ONE COULD IMAGINE A SCENARIO IN WHICH AN "INFORMER" WHO WAS REALLY A RED BRIGADE OPERATIVE

REVEALED THE GENERAL'S WHEREABOUTS, THE GENERAL WAS SPRUNG, AND A REWARD WAS PAID WHICH WAS THEREAFTER USED TO FINANCE FURTHER TERRORIST ACTS.

- 5. THE DCM SAID THAT WE WOULD FULLY AGREE THAT THIS SORT OF THING COULD NOT BE PERMITTED TO HAPPEN. TO ANSWER THE MINISTER'S QUESTION, HE WOULD FIRST STRESS THAT WE DID NOT PAY RANSOMS, AFD WOULD NOT. HE WOULD NOT, HOWEVER, EXCLUDE THE POSSIBILITY THAT FUNDS MIGHT BE FOUND FROM PRIVATE AMERICAN SOURCES TO PAY A REWARD, ALTHOUGH IT WOULDSUNDOUBTEDLY HAVE TO BE A CONDITION THAT THE REWARD WAS PAID ONLY AFTER THE GENERAL HAD BEEN RECOVERED.
- 6. COMMENT: IT IS POSSIBLE THAT THE MINISTER PUT THE QUESTION BECAUSE HE HAD ALREADY BEEN APPRISED OF MATTER TREATED REFTEL. HOWEVER, WE ALSO HAVE SOME REASON TO BELIEVE THAT ITALIAN COORDINATOR DE FRANCISCI MAY HAVE SUGGESTED TO ROGNONI THAT IT MIGHT BE ADVANTAGEOUS TO TRY TO FIND AMERICAN FUNDS FOR A REWARD RATHER THAN ARRANGE FOR A POSSIBLE REWARD TO BE PAID FOR BY "ITALIAN FRIENDS". IN ANY CASE, IT DID NOT SEEM PRUDENT TO SAY LESS TO THE MINISTER THAN WE DID.

1. S-ENTIRE TEXT.

2. WITH THE OPENING OF THE CHRISTIAN DEMOCRATIC (DC)
NATIONAL COUNCIL MEETING JUST TWO DAYS AWAY, AMBASSADOR
RABB ON JANUARY 20 CALLED ON ARNALDO FORLANI WHO
WILL PRESIDE OVER THE MEETING AS PRESIDENT OF THE DC
TO OFFER OUR VIEWS ON TREATMENT AND HANDLING OF IMPRISONED
TERRORISTS. AS IN MEETINGS WITH OTHER POLITICAL AND
GOVERNMENT LEADERS (REFTELS), THE AMBASSADOR STRONGLY
EXPRESSED THE OPINION THAT CONCRETE MEASURES WERE NEEDED
IMMEDIATELY TO ISOLATE IMPRISONED RED BRIGADES MEMBERS
FROM THE OUTSIDE WORLD. OUR CONCERN, THE AMBASSADOR
POINTED OUT, WENT BEYOND THE DOZIER CASE TO THE
"DECLARATION OF WAR" ON NATO AND THE ASSAULT ON DEMOCRACY
REPRESENTED BY THE INTENDED RED BRIGADES MASSACRE OF THE
DC LEADERSHIP IN THE FORTHCOMING NATIONAL COUNCIL MEETING.
IN OUR VIEW, THE AMBASSADOR SAID, NATO AND ITS MEMBER
GOVERNMENTS NEED TO BE FREE TO CONCENTRATE ENTIRELY ON
THE DEFENSE OF EUROPE AND THE WEST.

MESSAGE (CONTINUED):

- 3. THE TIME WAS THEREFORE AT HAND FOR EMPHATIC MEASURES TO BREAK THE BACK OF THE RED BRIGADES, WHOSE RECENT BREAKOUT FROM ROVIGO PRISON HAD UNDERSCORED THE LINKS BETWEEN TERRORISTS IN THE PRISONS AND THOSE OPERATING OUTSIDE. THE AMBASSADOR CALLED ON FORLANI TO ENCOURAGE THE DC TO TAKE A STRONG, UNIFIED STAND SUPPORTING THE ISOLATION MEASURES DISCUSSED BY THE GOVERNMENT LAST WEEK, BUT NOT YET IMPLEMENTED.
- 4. FORLANI HAD NO RESERVATION WITH RESPECT TO ANY OF THE PROPOSED MEASURES TO ISOLATE THE TERRORISTS. INDEED, HE POINTED OUT THERE HAD BEEN EVIDENT GAPS IN THE SECURITY EFFORTS OF BOTH THE MINISTRIES OF INTERIOR AND JUSTICE. - THE POPE DID NOT OPEN THE UNSEALED ENVELOPE BUT LEFT IT LYING ON HIS DESK WHILE WE TALKED. SENSING THAT I WAS THERE TO DISCUSS POLAND, HE TOOK THE LEAD IN THE CONVERSA-TION BY GOING INTO A RATHER LENGTHY DISCUSSION OF THE HIS-TORY OF THE POLISH PEOPLE AND THEIR HERITAGE OF STRUGGLI-ING OVER THE CENTURIES FOR LIBERTY, INDEPENDENCE AND FREEDOM. - INTERNATIONAL CONNECTIONS: BEFORE BEING INTERROGATED, DOZIER WAS GIVEN BR POLITICAL LITERATURE, SUCH AS LEAFLETS AND PAMPHLETS TO READ. WAS ALSO GIVEN A COPY OF THE LATEST BR STRATEGIC RESOLUTION. HIS CAPTORS WOULD LET HIM READ AND THEN

EXPLAIN TO HIM THE PORTIONS WHICH HE DID NOT UNDERSTAND. CONVERSATION WAS ONLY IN ITALIAN, AND THERE WERE NO ENGLISH-SPEAKING INTERPRETERS.

- 6. IT WAS DURING THE READING OF THESE TYPES OF PAMPHLETS AND BOOKLETS THAT DOZIER POINTED OUT THAT HE WOULD BE WILLING TO ANSWER ANY QUESTIONS WHICH THEY HAD, PROVIDING THE QUESTIONS DID NOT INVOLVE MILITARY SECRETS. DOZIER TOLD HIS CAPTORS HE BELIEVED THERE MIGHT BE A CONNECTION BETWEEN THE BR AND THE KGB. AT THIS POINT HIS CAPTORS TOLD HIM THEY WERE NOT CONNECTED WITH THE KGB, THAT THEY WERE NOT CONNECTED WITH THE KGB, THAT THEY WERE NOT CONNECTED WITH THE LIBYANS, AND THAT THEY ONLY HAD LOOSE TIES WITH OTHER EUROPEAN TERRORIST GROUPS. - 7. METHOD OF INTERROGATION:
 DOZIER WAS INTERROGATED FOR SEVERAL DAYS AT A TIME, THEN

 BE INTERROGATED AGAIN FOR ANOTHER DAY OR SO. WE ESTIMATE
 THAT THERE WERE ABOUT 7 INTERROGATIONS IN ALL. AT THE

 INFORMED HIM THAT THEY, BEING RED BRIGADES, DO NOT

8. THESE SESSIONS WERE MORE QUESTION-AND-ANSWER TYPE THAN SERIOUS INTERROGATION. THEY WERE NOT HOSTILE SITUATIONS. GENERALLY, THE INTERROGATORS WOULD HAVE PREPARED A QUESTIONNAIRE FROM WHICH THEY WOULD READ QUESTIONS. AT THE VERY BEGINNING, DOZIER REALIZED THAT MOST OF THE QUESTIONS THEY ASKED HIM REGARDING HIS CAREER WERE ONES TO WHICH THEY ALREADY HAD THE ANSWERS. MANY TIMES WHEN HE DIDNOT KNOW A PARTICULAR NAME THEY WOULD VOLUNTEER IT TO HIM. BECAUSE OF THIS SITUATION, AND BECAUSE THEY HAD MADE AVAILABLE TO HIM A NEWSPAPER ACCOUNT WHICH INDICATED THAT THEY HAD REMOVED MILITARY DOCUMENTS FROM HIS RESIDENCE, DOZIER FELT THAT THE BEST APPROACH TO HIS CAPTIVITY WOULD BE TO ANSWER AS TRUTHFULLY AS HE COULD THE QUESTIONS OF A GENERAL NATURE. HE DECLINED TO ANSWER ANY QUESTIONS WHICH HE FELT WOULD DEAL WITH MILITARY CLASSIFIED INFORMATION, OR WHICH WOULD BE EMBARRASSING TO THE U.S., TO ITALY, OR NATO.
