largest party in Italy, and the most staunchly

from Italian President Pertini (Socialist party)
and Prime Minister Spadolini (Republican party).
The largest party in the current Italian co-
alition, however, is the Christian Democratic
party, which de Mita leads, although he does not
have a government post. A picture with de Mita
would maintain broad U.S. relations with Italy.
