Proclamation 4838 of April 22, 1981

#### Days of Remembrance of Victims of the Holocaust

By the President of the United States of America

#### A Proclamation

The Congress of the United States established the United States Holocaust Memorial Council to create a living memorial to the victims of the Nazi Holocaust. Its purpose: So mankind will never lose memory of that terrible moment in time when the awful spectre of death camps stained the history of our world.

When America and its allies liberated those haunting places of terror and sick destructiveness, the world came to a vivid and tragic understanding of the evil it faced in those years of the Second World War. Each of those names—Auschwitz, Buchenwald, Dachau, Treblinka and so many others—became synonymous with horror.

The millions of deaths, the gas chambers, the inhuman crematoria, and the thousands of people who somehow survived with lifetime scars are all now part of the conscience of history. Forever must we remember just how precious is civilization, how important is liberty, and how heroic is the human spirit.

Like the genocide of the Armenians before it, and the genocide of the Cambodians which followed it—and like too many other such persecutions of too many other peoples—the lessons of the Holocaust must never be forgotten.

As part of its mandate, the Holocaust Memorial Council has been directed to designate annual Days of Remembrance as a national, civic commemoration of the Holocaust, and to encourage and sponsor appropriate observances throughout the United States. This year, the national Days of Remembrance will be observed on April 26 through May 3.

NOW. THEREFORE. I, RONALD REAGAN, President of the United States of America, do hereby ask the people of the United States to observe this solemn anniversary of the liberation of the Nazi death camps, with appropriate study, prayers and commemoration, as a tribute to the spirit of freedom and justice which Americans fought so hard and well to preserve.

IN WITNESS WHEREOF. I have hereunto set my hand this 22nd day of April, in the year of our Lord nineteen hundred and eighty-one, and of the Independence of the United States of America the two hundred and fifth.

Dear Mr. Baker:

A letter written by Mr. Max Green, Assoc. Dir. of Office of Public Relations of the White House, addressed to Mr. Ugur Camli of Maryland Turkish-American Assoc. recently came to our attention. A copy of this letter is enclosed along with Mr. Camli's letter to Mr. Green.

All members of our organization were appalled by the blunt, convinced, and subjective tone of Mr. Green's letter in an extremely complex and historically controversial and diplomatically sensitive issue of so called the "Armenian Claims of a Genocide charge against Turks" spearheaded by the Armenian Revolutionary Federation (ARF) of Boston and its political arm, the Armenian National Committee (ANC) of Washington, D.C.

The personal opinion of Mr. Green on the issue is quite unimportant to us as we all very well know, historically, how many good names in the U.S. Government and in the U.S. Congress have been hoodwinked by the A.R.F. zealots to gain support to their cause during their 96 years of effort to rewrite the history. However, when the personal opinion is typed on a piece of stationary bearing the title of the Office of the Public Relations of the White House it

takes on an important bearing which we cannot condone as a slippage. Because, such a document may be construed by hostile circles as the official view of the President of the U.S.A.

It is commonly known that the Administration and the Congress are both under pressure by the Armenian Lobby to legitimize their falsified claims in the political arena. In this effort they are constantly seeking to place and cultivate people sympathetic to their cause. Such people do exist in the State Department, the Presidential Commissions, many on the Capitol Hill and also in the White House. Again, the recent events clearly prove that some staff in the White House can take matters into their own hands without the due knowledge or supervision of their superiors which can cause embarrasment and instabilities even in the highest circles. The Armenian issue carries such a potential with deep domestic and international political consequences.

On the other hand, we also believe that President Reagan and the U.S. Administration greatly value the good relations between our country and Turkey which is a staunch ally and strong supporter of the Western Solidarity against Communism, and the Free World ideals.

In the light of these considerations we have decided to bring this very grave misjudgement by Mr. Green to your attention.

Mr. Green claims that "Genocide of Armenians by Turks is a historical judgement, overwhelmingly accepted by the U.S. society due to many, many historical works, too many to mention in this letter". If Mr. Green is thinking of the many, many one-sided, distorted, anti-Turkish propaganda and

hate material, he is quite right in his assessment of the profusion. Such publications have a history of 96 years or more. In fact in a rewakened anti-Turkish campaign the Armenians are mass producing some of them and disseminating to the pertinent offices and persons to further their cause. Among them, perhaps, Mr. Green also received his share of it. If, on the other hand, Mr. Green means well respected authorities of the Middle Eastern History in the prestigious universities here and abroad he would not find a single one. On the contrary, there are dozens of authorities of the Middle East and last century Political History who completely disagree and reject the Armenian claims. If you need to know, we will be more than happy to provide a list.

Recently, 69 leading Professors of Turkish and Middle Eastern studies in this country wrote an open letter to the members of the U.S. Congress declaring that the Armenian issue is a very controversial one and best left to the unemotional and disinterested research by historians in the academia (copy enclosed).

If Mr. Green's logic is correct and valid that the existence of "many, many historical works" justifies the truth of an issue, then we kindly submit to his attention of the mountain of anti-semitic literature both in the Western world and in the U.S.A. written by many low-grade historians and, also by no less famed people than Martin Luther, Voltaire, Houstan Chamberlain and Arnold Toynbee, to mention a few, who we all agree, are among the founding giants of Western philosophy and morality. Then, by the same logic, would Mr. Green and through his office, the President accept such preponderance as sufficient grounds to pass judgement on the issue and justify issuing Presidential

Proclamations? We certainly hope NOT! We all recognize that all the antisemitic literature is due to racial and religious hatred and bigotry and therefore baseless and should be ignored and rejected. By this token did it also occur to Mr. Green that anti-Turkish defamation literature in abundance might have a historical trace of bigotry, racial hate, and therefore should not be taken at its face value?

We would also like to remind Mr. Green that Turkey and Turks were not only subjected to defamation and hatred campaign just because of their race and religion as the Jewish people had been, but additionally they were maligned by a vicious and sadistic propaganda campaign, such as the masterworks of Wellington House in England and in the Allied countries during World War I for just being on the wrong side of the war.

The volume of publicity or propaganda cannot be considered as proof of a genocide when such a crime was not committed. Similarly lack of publicity and interest should not be construed as sufficient proof that such a crime did not occur when it was actually committed. Such was the case of the Turkish Genocide by the Armenians during 1918 to 1921. Victims were the Ottoman and Caucasian Turks and all Moslems (Armenians call them Tartars in their epic books to camouflage the issue) and therefore, had no sympathizers in the West, nor did they have a lobby machine and friends in the U.S. media and the Congress. They constituted 45% of the population in the Independent Republic of Armenia of Eastern Turkey and the Caucasus. It lasted 2.5 years.

Dear Senator Thurmond:

I understand that the Committee on the Judiciary will consider 5J Resolution 43 designating April 24, 1987 as a \*National Day of Remembrance for Victims of the Armenian Genocide". The purpose of this letter is to give you the Administration's views on this legislation, which we oppose. Our opposition is based on three central and related concerns: first, the significance of Turkey as an ally; second, the very negative effect on this sensitive and vital relationship were Congress to pass a resolution which accuses the Turks of genocide against the Armenians; and third the risk that passage of this legislation could encourage terrorism directed at both Turkish and American citizens.

In the postwar era, the United States has attached great Committee rtance to its relationship with Turkey. Wadministration importance to its relationship with Turkey. WAdministrations have done so with the support of Congress because of a shared recognition of the need to maintain a strong and fruitful relationship between the United States and Turkey. A major nation with a promising future, Turkey is a bridge and buffer in a critical region. It sits astride the vital narrows between the Black Sea and the Mediterranean, controls land and .. air access to the Middle East and has extensive borders with Bulgaria, the Soviet Union, Iran, Iraq and Syria. We are fortunate that our desire for a strong partnership with Turkey has been realized in an alliance based on mutual respect and confidence.

Turkey contributes greatly to the success of the NATO Alliance in deterring aggression. While it is the poorest member of NATO, Turkey nonetheless spends a greater percentage of its GNP on defense than almost any other NATO ally. It has NATO's second largest Army, tying down major Soviet and Warsaw Pact forces.

Moreover, as part of our alliance relationship with Turkey, we have access to military facilities there that play a major role in our defense. Composed of six major facilities and many smaller ones, they include air bases for deployment of U.S. forces, logistic depots and vital intelligence collection facilities. In this regard, we have just signed an agreement for our defense cooperation with Turkey, extending our present agreement until 1990 and committing us to strong efforts to provide necessary assistance to help Turkey modernize its military and strengthen its economy.

SJ Resolution 43 judges the Armenians who died in the Ottoman Empire (present-day Turkey) in 1915-1923 to be victims of genocide. A similar draft resolution in 1985 provoked near universal public outcry in Turkey, as well as a movement in the Turkish Parliament for review of diplomatic relations with the United States. Prime Minister Ozal was able to head off this latter effort. However, the Turkish Government also informed us that adoption of a resolution to this effect would seriously damage the vital relationship between Turkey and the United States. And that is still the prospect if the 100th Congress should pass a resolution that indicts the Turkish people for the events of 1915-1923.

Besides reflecting resentment at a judgment by the United States Congress that Turkey, and the Turks as a people, bear the guilt of perpetrating genocide, such strong Turkish reaction is also related to modern Armenian terrorism. Since 1975 over 50 Turkish citizens, mostly diplomats, have been killed by Armenian terrorists. In addition to demanding Turkish Government recognition of an Armenian genocide, the terrorists demand reparations and cession of a major portion of eastern Turkey to form an independent Armenian state. The Turks thus view the campaign to characterize the tragedy of the Armenians as a genocide as the first step toward their territorial dismemberment.

Armenian terrorism has affected Americans. Four assassinations have occurred on our soil. U.S. citizens have been the target of a number of attempted bombings or other harassment during this terrorist campaign, and one U.S. citizen died in an Armenian attack on a Turkish airport. ASALA, one of the two major Armenian terrorist groups engaged in these activities, also aids other terrorist groups which have Americans as their primary target. It has publicly declared its support of Islamic Jihad, the Iranian-supported terrorist organization responsible for so much of the violence in Lebanon. We believe that resolutions judging Turkey responsible for Armenian genocide, however well-intentioned and however worded, will inevitably be seen by the terrorists as encouragement of and justification for their acts.

We regret the suffering and tragedy experienced by Armenians. We do not seek to dismiss the devastation and the widespread massacres suffered by this group. Indeed, there is no doubt that much of the population in Mastern Turkey, Christian and Moslem, experienced death, deprivation and removal during these wartime years. When a House Resolution similar to SJ Res 43 was under consideration in 1985, sixty-nine American academicians who specialize in Turkish, Ottoman and Middle Eastern studies wrote the House membership that they had reservations about use of the word genocide to describe what took place in 1915-1923.

Politically, Turkey has continued to consolidate its democracy. Economically, the country is making progress in a program to release its huge potential. Passage of a resolution offensive to Turkey and to Turks would undermine the effectiveness of our support for these efforts when we have every reason to want Turkey to succeed as a prospering democracy. Passage could also set back our efforts to encourage Turkey to play a positive role on Cyprus--an issue which also arouses deep nationalist sentiments and on which the Turkish government is playing a positive role.

The undersigned American academicians who specialize in Turkish, Ottoman and Middle Eastern studies are concerned that the current language embodied in House Joint Resolution 192 is misleading and/or inaccurate in several respects.

Specifically, while fully supporting the concept of a "National Day of Remembrance of Man's Inhumanity to Man," we respectfully take exception to that portion of the text which singles out for special recognition:

"...the one and one half million people of Armenian ancestry who were victims of genocide perpetrated in Turkey between 1915 and 1923..."

Our reservations focus on the use of the words "Turkey" and "genocide" and may be summarized as

• From the fourteenth century until 1922, the area currently known as Turkey, or more correctly, the Republic of Turkey, was part of the territory encompassing the multi-national, multi-religious state known as the Ottoman Empire. It is wrong to equate the Ottoman Empire with the Republic of Turkey in the same way that it is wrong to equate the Hapsburg Empire with the Republic of Austria. The Ottoman Empire, which was brought to an end in 1922, by the successful conclusion of the Turkish Revolution which established the present day Republic of Turkey in 1923, incorporated lands and peoples which today account for more than twenty-five distinct countries in Southeastern Europe, North Africa, and the Middle East, only one of which is the Republic of Turkey. The Republic of Turkey bears no responsibility for any events which occurred in Ottoman times, yet by naming "Turkey" in the Resolution, its authors have implicitly labeled it as guilty of the "genocide" it charges transpired between 1915 and 1923;

 As for the charge of "genocide:" No signatory of this statement wishes to minimize the scope of Armenian suffering. We are likewise cognizant that it cannot be viewed as separate from the suffering experienced by the Muslim inhabitants of the region. The weight of evidence so far uncovered points in the direction of serious inter-communal warfare (perpetrated by Muslim and Christian irregular forces), complicated by disease, famine, suffering and massacres in Anatolia and adjoining areas during the First World War. Indeed, throughout the years in question, the region was the scene of more or less continuous warfare, not unlike the tragedy which has gone on in Lebanon for the past decade. The resulting death toll among both Muslim and Christian communities of the region was immense. But much more remains to be

discovered before historians will be able to sort out precisely responsibility between warring and innocent, and to identify the causes for the events which resulted in the death or removal of large numbers of the eastern Anatolian population, Christian and Muslim alike,

Statesmen and politicians make history, and scholars write it. For this process to work scholars must be given access to the written records of the statesmen and politicians of the past. To date, the relevant archives in the Soviet Union, Syria, Bulgaria and Turkey all remain, for the most part, closed to dispassionate historians. Until they become available the history of the Ottoman Empire in the period encompassed by H.J. Res. 192 (1915~1923) cannot be adequately known.

We believe that the proper position for the United States Congress to take on this and related issues, is to encourage full and open access to all historical archives, and not to make charges on historical events before they are fully understood. Such charges as those contained in H.J. Res. 192 would inevitably reflect unjustly upon the people of Turkey, and perhaps set back irreparably progress historians are just now beginning to achieve in understanding these tragic events.

As the above comments illustrate, the history of the Ottoman-Armenians is much debated among scholars, many of whom do not agree with the historical assumptions embodied in the wording of H.J. Res. 192. By passing the resolution Congress will be attempting to determine by legislation which side of a historical question is correct. Such a resolution, based on historically questionable assumptions, can only damage the cause of honest historical enquiry, and damage the credibility of the American legislative

Gov. Michael S. Dukakis was on hand to celebrate the opening of the exhibit on Tuesday afternoon, April 21. Speaker of the

#### How and Why Are Hallowed Family Ties Severed?

Your children continue to grow and change. sunrise to sunset, for their unimportant wrongs, early youth, and you can no longer see the innocence and the carefree behavior of their child-

culties. They may be rebellious. They display nerve-wracking rampancy, and you observe abnormal changes in their rude behavior.

I ask you, dear parents, how shall you confront position be regarding it? How shall you carry on in this unstable environment so that your children will emerge with the least possible harm from this abnormal crisis, and serenely approach maturity?

The number is not negligible of those parents who go through this crisis with unbelievable indifference. There are some who affect shock, with anger and remonstrations. Others, confused, cry out in emotional anguish, "What ever happened to my child? Why did he turn out this way? What does he want, that he grumbles continually? Why is he annoyed with the slighest criticism, and refuses advice or counsel from anyone? He withdraws into himself, isolates himself, and spends hours buried deep in impassivity? In olden times we were free of such cares, and knew nothing about them."

Such complaints, no matter how reasonable, are unable to help in any way, and cannot resolve problems.

It is important, during this period of their growth, that you be sweet, and tender in your attitude. Your sole aim must be to disclose to their impressionable souls a world wherein the Creator reigns with his goodness and bounty.

Try, with your affectionate love, to raise them with an appreciation of responsibility, so that they may pass through chaotic life with heroic success, and use their personal freedom wisely and courageously for the good of mankind, and for the lifting of moral values.

If you succeed wisely in opening their hearts and minds to the great issues of the day as, in generations past, when your parents were strict in assuring your development to which you dutifully responded, then there is no reason to fear that your children will go astray, no matter how alluring life's diversionary attractions might be.

However, it is essential that in the light of present-day styles we break away from our old, out-of-date thinking and prejudice, and adapt to modern circumstances and needs.

First of all, we must understand this eternal truth, that we are the spiritual offspring of the Universal Spirit, the benevolent and omnipotent God. An awareness of this truth must early be instilled in your children, so that godly virtues will develop along with the evolving times, so that the individual's character assumes a unique stamp, and a greatness that will never be overshadowed by ephemeral values.

Errors and failure will mark our efforts only when we ignore the important issues and we get involved in worthless details.

We must give each detail only that value that it' deserves, and no more.

But on the other hand, essentials must be given absolute values, nothing less than they deserve. When we constantly rebuke our children, from

With unbelievable quickness they have reached we in so doing forget what is important and we waste our breath and time in meaningless details.

Should it occur that under some circumstances children interrupt adults in conversation, with Their conduct may present insoluble diffi- trivial talk, or if they burst out giggling, or in some other disorderly behavior perturb tranquility, we would be erring in our parental calling if we scolded them angrily.

We need to show respect for our children as we this sudden transformation, and what will your do for grown-ups. We should not be contemptuous of them.

> These are times when divorces are at their peak. When man and woman, both equally, are wound up in passionate hate, they allow perversity, selfishness, and an unforgiving spirit to prevail in their relationship with their children, instead of parental love.

> How, in truth, can a growing child develop normally and grow spiritually when a father on a mother is missing from the home because of unhappy controversies.

> According to God's plan, the father and the mother are obliged to work together in the sacred task of raising their children, the mother with her tenderness, and the father with his masculine firmness

> When one of this pair is absent because of a repugnant divorce, of because of an untimely death, how can the child be expected to develop morally and one day become a whole personality?

> I have often heard the lamenting cry of a distraught mother. "How can I control my child without threatening and breaking him of his bad temper? He has reached a point where he no longer heeds my angry threats, or his father's. He has become an uncontrollable beast who wants and does everything in his own way.

> It is quite true that neither can the mother fulfill her responsibility without the help of the father, nor can a father fashion the moral character of the child without the mother's help.

> How many families would escape being broken up, and how many husbands and wives would avoid the tragedy of divorce if they would only replace their selfishness with love for their child, and think only of its salvation.

> Parents who have not tarnished the sanctity of their married life must say to themselves and to one another, "First let us consider our children and not ourselves, our differences, our wrongs."

The impossible must be made possible. The tender child's life and future must not be endangered by unwise divorce.

If we try to think in this way during times of deep family crisis, then certainly we would not only save ourselves, but we would not subject the sensitive hearts of our children to the trauma of divorce.

A member of the court, at an appropriate moment, asked Empress Catherine why she revered her spiritual father more than her natural father. The empress answered, "My natural father brought me from heaven to earth, but my spiritual father with his hallowed life and wise advice lifted me from earth to heaven.'

Trying to understand the conflicting and confusing opinions of the so-called experts on our economy leads to one con-clusion: They know about as much as Will Rogers claimed he knew about the gold standard nothing.

It reminds me of the "that's good, that's-bad joke." First they say a strong dollar is good for us. Foreign capital comes in to buy our stocks, bonds and Treasury bills. That reduces our deficit. That's good. But a dollar means higher strong interest rates, which means more inflation. That's bad. And higher interest rates means higher mortgage rates, less housing starts and slowing down of the economy. That's also bad. But a strong dollar means we can buy foreign goods cheaper and have a better life and less inflation. That's good. But a strong dollar also means foreign consumers cannot buy our American-made products and that will cause our production to go down and produce unemployment. That's bad. And when we buy foreign-made goods our American manufacturers sell less

So the dollar falls. 'Is that good or bad? Well, cheaper dollar means foreign consumers can buy our American-made products which means more jobs here and less recession. That's good. But a weak dollar also means decreased stock and bond sales, less T-bill sales to foreigners which means the deficit rises. That's bad. A weak dollar also means the price of foreign goods goes up and that increases inflation and that's bad, too. And if the purchase of foreign goods now goes down due to increased prices, the foreign economies suffer, they have a recession and cannot buy our goods, real estate, stocks, bonds and Treasury bills. That's not good. With the subsequent higher budget deficit we get higher interest rates, decreased consumer spending, a stalled economy and recession. That's bad.

Which all means: you can't win for losing.

#### Entrepreneurship to Plug Supply-Demand Gap in Armenia

YEREVAN — When an injury prevented Peti Mirzoyan from resuming construction work, he collected 22 friends and began producing plastic beach shoes from industrial scraps — and more than doubled the salary each had been receiving.

Arabyat Garnikyan and his extended family organized a cooperative in February to sew children's jackets from defective parachutes and other second-hand materials. Now the 15 workers of the Novinka shop are sewing all night to keep up with orders.

The cooperatives in Yerevan, capital of Soviet Armenia, are successful tributes to some tentative private enterprise the Soviet government sanctioned this year in an effort to close the huge gap between state supplies and consumer demand.

Reforms outlined in recent months by the Kremlin under Soviet leader Mikhail Gorbachev took another small step toward market economics on May Day when a new, "individual labor" law took effect.

The program encourages citizens with time on their hands to supply goods and services that state enterprises have been unable to fill.

to characterize the cooperatives and individual labor as "free enterprise" or "capitalism" and argue that the concepts are consistent with socialism and permitted by the constitution.

But allowing workers to start their own businesses in everything from baking bread to tending grave sites — and to set prices at whatever the market will bear — nudges the lumbering Soviet economy a little closer to Western models.

The private ventures are expected to retain only a small place in the national economy for the next few years. But the public has been enthusiastic about the smattering of private cafes and businesses begun as experiments.


In Armenia, more than 2,500 applications for private businesses had been filed by Wednesday, according to Mikhail Kotanyan, economics chief of the republic's Communist Party.

Sabir Stepanyan, Armenia's procurement minister, said 10 cooperatives are already in business in the republic of 3.3 million. Four more are planned soon.

Cooperatives have fewer restrictions and lower taxes than the private initiatives, but co-op output is sold to the government under contract for fixed prices.

At Mirzoyan's plastics cooperative and Garnikyan's sewing enterprise, workers' earnings are determined by their output.

The average Soviet industrial worker earns about 190 rubles CALL 467-6767 per month, or about \$300 at the



official exchange rate.

Mirzoyan told reporters who visited his small factory this week that each of the collective's members earns 250 rubles (\$400) per month plus about 200 rubles (\$320) from bonuses for extra production.

Lyudmila Varabyova, head seamstress at the Novinka shop, said the enterprise operates on flexible work hours, allowing housewives to sew at night after their husbands return home to watch the children.

room-office, a cutting room and a stifling 10-machine sewing center that whirs with the sound of stitching from dawn until late at night.

"One of our seamstresses can sew up to four jackets in an eight-hour shift," Varabyova said, adding that such productivity is unheard of in state factories.

Workers at both shops attribute part of their success to what they deem a stronger work ethic among Armenians than in the Russian Republic.

Similar free-enterprise projects also are showing good results in the Baltic republics of Latvia, Lithuania, and Estonia.

Each republic is allowed to determine the goods and services needed locally and set license fees

In the Russian Republic, a license to operate a private car as a taxi costs 560 rubles (about \$900 at the official rate) a year and construction workers must pay 470 rubles (\$700) to work privately. The same licenses in Armenia cost 640 rubles (\$1,025) and 320 rubles (\$510), respectively.

The fees and a graduated tax of as much as 65 percent on income over 6,000 rubles (\$9,600) a year are expected to produce

from 1 percent to 3 percent of national revenues, state labor committee chairman Ivan Gladky has predicted.

But officials contend the primary aim of the program is consumer service.

The new program's bureaucracy and tax structure are likely to discourage many entrepreneurs, especially those already operating "na levo" — on the left — in the flourishing black market.

"Why should I pay hundreds of rubles and high taxes to knit and sew for my friends?" a Moscow woman said when asked if she planned to make her underground tailoring business legal.

# "The Slaughterhouse Province..." to be Published in Booklet Form

NEW YORK - In comme moration of the 72nd anniversary of the Armenian Genocide on April 24, 1987, His Eminence Archbishop Mesrob Ashjian announced the publication of the booklet "The Slaughterhouse Province: A United States Consul's Report on Armenian Massacres". This 12-page booklet contains excerpts from the original lengthy Report Written by Consul Leslie Ammerton Davis during the 3-year period, 1914-1917, when he served as Consul in the towns of Harput/Mamuret -ul-Aziz in Ottoman Turkey.

The discoverey of this Report, however, did not come until many years later, when Susan K. Blair of Alexandria, Virginia did extensive research in several renowned libraries. Ms. Blair's 6 year long archival research on "American relief for the persecuted minorities in the Ottoman Empire during the period from 1915-1935" came to a halt upon her discovery of the Davis Report documented with photographs taken by him of scenes he vividly described in

his account. Ms. Blair, having now set aside her original project, decided to compile her archival findings into a book which will be published shortly by the publishing firm, Aristide Caratzas, who specialize in fine scholarly publications. (Details published in this newspaper, April 22 issue).

Mr. Leslie Ammerton Davis, prior to his foreign service in 1913, was an attorney in New York City. He was then assigned by the State Department to serve as Consul in Harput/Mamuret. It was there that Consul Davis became the first official eyewitness to the gruesome remains of the Armenian inhabitants in the twin towns, which came to be known as "The Slaughterhouse Province".

When Consul Davis informed the State Department of his findings, he was instructed to investigate in and to report on the conditions of the territory to which he was assigned. He carried out the edict of the State Department with fearless and thorough diligence,

After having seen partial burial and open gravesites of thousands of Armenians, Consul Davis decided to help surviving Armenians by giving them food, shelter and education in the Consulate.

Mr. Davis' heroic efforts to save a people are recognized not only by those he saved but also by the Nation he served — The United States of America. The United States Government commended him for his excellent Report - a Report given by a trusted public servant who described mass murder sites in an official capacity. His document, recorded in the archives of the U.S. Government, states that these events did in fact take place during World War I making "The Slaughterhouse Province: A U.S. Consul's Report on Armenian Massacres", "irrefutable evidence"

The Armenian Prelacy, in cooperation with the publishers, are making the 12 page booklet available to the public upon request. The book in its entirety will be released in the near future.

# Agathangelos "History of the Armenians" Now Available

"History of the Armenians" by Agathangelos, translated into English by Robert W. Thompson, is now available at the St. Vartan Bookstore at Diocesan headquarters in New York City. This 527-page scholarly edition is in Armenian juxtaposed with the English Translation.

Agathangelos' "History" is about the conversion of Armenia to Christianity in the early 4th century and its momentous impact on Armenia and the Near East. Agathangelos' work, circa 700, tells the story of the conversion of the Armenian King Trdat and the missionary activity in Armenia of St. Gregory the Illuminator.

It is not, however, a history book about the conversion of Armenia, conversion referring to the whole cultural transformation of the country as opposed to the single act of one Armenian king. That would be impossible since there is no detailed study of the struggles of the church party during the fourth century. "History of the Armenians" has become the standard "received" version of what happened, and therefore it has played a major role in the outlook of later generations of Armenians down to the present. It is one of the only acknowledged historical records in existence.



#### Five Bids for World Chess Championship Match Site

LOS ANGELES - The World Chess Federation (FIDE) received world championship match between champion Gary Kasparov and challenger Anatoly Karpov. #### Jessica Nails Scratch Surface of Law

LOS ANGELES - Request which makes it a criminal offor preliminary injunction a-gainst Jessica Vartoughian to perform pedicure on Paul Jasperson was turned down by the court, in Santa Monica. This is unusual case where confrontation between the right of the individual to health (that is free of illness) and civil rights of the individual is taking place.

Paul Jasperson filed suit against Jessica and her Nail Clinic for-refusing to provide him with nail service.

Last July, Paul Jasperson a hairdresser from West Hollywood, asked for an appointment at Jessica's nail care salon on the Sunset Blvd. He was given one for the next day. Jasperson claims that at the same time he was engaged in a conversation with employees of Jessica's establishment who were previous co-workers of his. He also talked to some clients. The bottom line of the conversations being that he had recently come out of hospital and was diagnosed as AIDS carrier.

Later on the recptionist at Jessica's nail care salon calls him up to cancel the appointment due to double booking. Jasperson claims that various phone calls were received at the establishment where he works making enquiries about the fact that he is an AIDS carrier. "Ultimately he went to West Hollywood Authorities who have a local ordinance which makes it a crime to refuse services to an AIDS carrier.

According to Paul Geragos, the defense lawyer of Jessica Vartoughian, "It is the only ordinance that we know of.

fense to refuse service to an AIDS carrier. Los Angeles has similar ordinance that gives civil penalties: fines and damages".

Geragos, a well known Armenian defense attorney, adds "The city of West Hollywood, ultimately, filed a compaint against Jessica and her corporation."

Last Friday, May 8, notice was received by Jessic's attorney to the affect that the criminal complaint has been extended to include the receptionist and the manicurist as well as the other corporations owned by Jessica.

Vartoughian, an Jessica Armenian from Roumania has established herself as one of the most popular manicurist and pedicurists in the nation and around the world. She has groomed the hands and feet of famous film stars as well as other personalities.

In 1981 Vartoughian flew from her stylish Los Angeles "Nail clinic", Jessica's, to Washington to give the First Lady an emergency manicure prior to Reagan's 70th birthday party. "It is an honor to do the First Nails," said Jessica,

#### Horrible Events of Armenian Genocide Difficult for "Upheavals in the Middle East" is General Public to Accept, Says Rev. Hartunian AAIC Annual Conference Topic

CAMBRIDGE - The facts of the Armenian Genocide are so horrible that the general public has difficulty in accepting them as true, Rev. Vartan Hartunian of Belmont, Mass., a genocide survivor, told an audience of Greater Boston Armenians re-

Speaking at a reception on April 3 in his honor in Watertown, Mass., sponsored by the National Association for Armenian Studies and Research, Rev. Hartunian recounted the obstacles that had to be overcome in order to have his father's memoir about the Armenian Genocide, "Neither To Laugh Nor To Weep," published. NAASR has just released an expanded second edition of the memoir under the imprint of its Armenian Heritage Press.

The book describes Abraham Hartunian's survival through three massacres in Turkey (1894-96, 1915, and 1922) and his miraculous escape from death on seven different occasions. The memoir was translated into English by Rev. Vartan Hartunian in the late 1930s but remained unpublished for three decades.

The manuscript was rejected by several publishers before Beacon Press agreed to print it in 1968, Rev. Hartunian said. Some publishers implied that he had made the story up. Reva-Hartunian recalled; another advised that the account would never be believed and suggested that it be recast in the form of a novel.

#### New Second Edition

Although it was reprinted in 1976 by the Armenian Missionary Association of America, the book has been out of print for several years. NAASR's new expanded second edition includes an introduction by Marjorie Housepian Dobkin, author and dean at Barnard College, Columbia University, who had come from New York for the reception. The new edition also includes as a preface an article written in 1918 by the late Henry Morgenthau, the U.S. Ambassador to Turkey during World War I, in which the Young Turks' plan to annihilate the Armenians is described.

Manoog S. Young of Belmont, Mass., NAASR Board Chairman. opened the program before a capacity audience at the St. James Armenian Church Hall Watertown by describing briefly NAASR's publications program as one of many activities that have grown out of

#### Dr. John Amoore to Speak at Bay Area APS Meeting

SAN FRANCISCO – Dr. John Amoore is a consultant in Environmental Chemistry who received his Ph.D. and Bachelors in Biochemistry from Oxford University. He has pursued Post-Doctoral Fellowships at the University of Edinburgh and UC Berkeley. He was the author of "Molecular Basis of Odor" published in 1970. He has also published numerous research papers in several scientific journals since 1952.

His work has focused on the human sense of smell and the odorous properties of volatile chemicals. For fifteen years, he was a research scientist for the U.S. Department of Agriculture (USDA) in Berkeley developing a method, based on the study of people exhibiting selective "odor-blindness", for identifying the distinctive but elusive "primary odors" that make up the sense of smell.

Since leaving the USDA in 1978, he has founded Olfacto-Labs, a firm producing ready-touse test kits for medical doctors to measure the patient's olfactory sensitivity as an aid to diagnosis. He has also conducted numerous analyses for various State agencies and private industries dealing with odor sensitivity to industrial chemicals. His consulting work has included the evaluation of the effects of hazardous wastes from industrial processes and disposal sites.

More recently, Dr. Amoore has been involved in setting up a mobile service for rapid on-site chemical evaluation of odoremission and hazardous waste

discharge problems: He currently serves as an appointee of Governor Deukmejian on the Scientific Advisory Committee on Acid Deposition ("acid rain") to the Califòrnia Air Resources Board.

membering the Genocide is so important," the Massachusetts chief executive asserted, "is so that we never again permit the kind of indifference, the neglect, and the failure to respond that took place at that time."

In concluding his remarks, in an indirect reference to his candidacy for president on the Democratic ticket which was announced officially one week later, Governor Dukakis remarked with a grin:

"I'd love to be able to say that one day in Washington we will have an exhibit like this, but I can't say so now." He then added, to the enthusiastic applause of all present, "If it happens, we'll have an Armenian exhibit in Washington."

Turkey Should Allow Repairs

House Speaker George Keverian expressed his "deep sense of personal pride" to see an exhibit of Armenian culture on display at the State House.

The Speaker then cited the need to restore the great creations of Armenian architecture, especially the churches, located in present-day Turkey.

"It is impossible to tour this exhibit without experiencing a strong sense of tragedy that the Armenian architectural monuments in Turkey are being allowed to fall into disrepair and disintegration," Speaker Keverian said.


Noting that the present Turkish Government will neither repair these monuments itself nor allow international organizations to repair them, Speaker Keverian continued: "We are still hopeful that the Turkish Government will see the light of reason and will cooperate in efforts to prevent any further decay in this proud legacy from the past."

Presentations

In recognition of his achievement as an Armenian-American, Speaker Keverian was presented with a framed collage of Keverian family photographs, including pictures of his parents, his grandparents, and his own picture as a child. The presentation was made by Ruth Thomasian, director of Project SAVE, a photographic archive documenting the history of the Armenian people during the past century.

Earlier in the program, the Speaker presented Barbara Merguerian, chairman of the ad hoc exhibit organizing committee, with a framed citation issued that day by the Massachusetts House of Representations in recognition of "her outstanding contribution to the Armenian community."

Ms. Merguerian thanked the Speaker for his support and encouragement of the exhibit and recognized the contributions of the three Armenian cultural preservation organizations that had been invited to participate: Dr. Vasken L. Parsegian, Chairman of the Armenian Architectural

## Ca. Investor Bids for Acquisition of Ramada Hotel Chain; Gets No Response

LOS ANGELES, CA - The investor Paul A. Bilzerian said this week that he was interested in acquiring the hotel and restaurant properties of Ramada Inc. and had requested a meeting with the company's management. Mr. Bilzerian also indicated that if he were unable to negotiate a friendly deal he would consider a hostile bid for Ramada.

The investor holds about 1.6 million, or 4 percent, of Ramada's shares outstanding through his company, the Bicoastai Financial Corporation of Tampa, Fia. Ramada, a lodging and gaming company based in Phoenix, has 39.8 million shares outstanding. Its stock rose \$1.25 a share earlier in the week and was the third-most-active stock on the New York Stock Exchange.

Mr. Bilzerian said he had requested a meeting with Richard Snell, Ramada's chairman. However, the management of the firm pointed out that it did not wish to meet the investor, who is noted for his attempts of taking over major firms.

Ramada owns, operates, licenses or franchises more than 98,000 rooms domestically and overseas, and also operates the Tropicana Hotel and Country Club in Las Vegas, Nev., and the Tropicana Hotel and Casino in Atlantic City. The company reported earnings of \$10.3 million, or 27 cents a share, on sales of \$687 million for the fiscal year 1986.

Mr. Bilzerian, who teamed up last year with Edward J. DeBartolo Sr. in an unsuccessful \$3.6 billion bid for the Allied Stores Corporation, has also offered to acquire Pay 'N Pak Stores Inc. for \$19 a share, or about \$171 million. Mr. Bilzerian was quoted as saying that he had reached a standstill agreement with Pay 'N Pak's management, which has agreed to provide him access to internal documents if the investor does not make a tender offer before June 6.



Weekly Wrap-up

Monday I had breakfast with Rabbi Arnold Resnicoff, a Navy chaplain who delivered the benediction at the Holocaust Memorial Ceremony in the Rotunda on Tuesday. I also hosted a briefing for the Freedom Federation. I closed the day by attending a reception put on by the Young Leadership Cabinet of the United Jewish Appeal.

Tuesday I attended the Rotunda ceremony. I left early to go to York, Pennsylvania. In the evening I attended a National Jewish Coalition reception.

Wednesday I had breakfast with David Matnai of the Israeli Embassy. I had lunch with the National Jewish Coalition (they had all the Republican hopefuls speak to them that day). That evening I gave a West Wing tour and had a discussion afterwards with a very distinguished group of South Africans.

Friday I hosted and spoke to a group of ADL human rights activists from Latin America.

In addition to the above, I have worked on my constituency report, the Novak et. al. meeting, the Asian Pacific American event that is scheduled for Monday, arranging a meeting for Jewish leaders with Ken Duberstein and Howard Baker, etc.

One think you should know about is that a Turkish-American group wrote a letter to Howard Baker protesting a letter I sent to another group. All the relevant documents are enclosed. All I can say is that I was simply defending what the President had already said. In retrospect I think I should have asked NSC or State to respond to the first letter we received.

Dear Mr. Baker:

A letter written by Mr. Max Green, Assoc. Dir. of Office of Public Relations of the White House, addressed to Mr. Ugur Camli of Maryland Turkish-American Assoc. recently came to our attention. A copy of this letter is enclosed along with Mr. Camli's letter to Mr. Green.

All members of our organization were appalled by the blunt, convinced, and subjective tone of Mr. Green's letter in an extremely complex and historically controversial and diplomatically sensitive issue of so called the "Armenian Claims of a Genocide charge against Turks" spearheaded by the Armenian Revolutionary Federation (ARF) of Boston and its political arm, the Armenian National Committee (ANC) of Washington, D.C.

The personal opinion of Mr. Green on the issue is quite unimportant to us as we all very well know, historically, how many good names in the U.S. Government and in the U.S. Congress have been hoodwinked by the A.R.F. zealots to gain support to their cause during their 96 years of effort to rewrite the history. However, when the personal opinion is typed on a piece of stationary bearing the title of the Office of the Public Relations of the White House it

takes on an important bearing which we cannot condone as a slippage. Because, such a document may be construed by hostile circles as the official view of the President of the U.S.A.

It is commonly known that the Administration and the Congress are both under pressure by the Armenian Lobby to legitimize their falsified claims in the political arena. In this effort they are constantly seeking to place and cultivate people sympathetic to their cause. Such people do exist in the State Department, the Presidential Commissions, many on the Capitol Hill and also in the White House. Again, the recent events clearly prove that some staff in the White House can take matters into their own hands without the due knowledge or supervision of their superiors which can cause embarrasment and instabilities even in the highest circles. The Armenian issue carries such a potential with deep domestic and international political consequences.

On the other hand, we also believe that President Reagan and the U.S. Administration greatly value the good relations between our country and Turkey which is a staunch ally and strong supporter of the Western Solidarity against Communism, and the Free World ideals.

In the light of these considerations we have decided to bring this very grave misjudgement by Mr. Green to your attention.

Mr. Green claims that "Genocide of Armenians by Turks is a historical judgement, overwhelmingly accepted by the U.S. society due to many, many historical works, too many to mention in this letter". If Mr. Green is thinking of the many, many one-sided, distorted, anti-Turkish propaganda and

hate material, he is quite right in his assessment of the profusion. Such publications have a history of 96 years or more. In fact in a rewakened anti-Turkish campaign the Armenians are mass producing some of them and disseminating to the pertinent offices and persons to further their cause. Among them, perhaps, Mr. Green also received his share of it. If, on the other hand, Mr. Green means well respected authorities of the Middle Eastern History in the prestigious universities here and abroad he would not find a single one. On the contrary, there are dozens of authorities of the Middle East and last century Political History who completely disagree and reject the Armenian claims. If you need to know, we will be more than happy to provide a list.

Recently, 69 leading Professors of Turkish and Middle Eastern studies in this country wrote an open letter to the members of the U.S. Congress declaring that the Armenian issue is a very controversial one and best left to the unemotional and disinterested research by historians in the academia (copy enclosed).

If Mr. Green's logic is correct and valid that the existence of "many, many historical works" justifies the truth of an issue, then we kindly submit to his attention of the mountain of anti-semitic literature both in the Western world and in the U.S.A. written by many low-grade historians and, also by no less famed people than Martin Luther, Voltaire, Houstan Chamberlain and Arnold Toynbee, to mention a few, who we all agree, are among the founding giants of Western philosophy and morality. Then, by the same logic, would Mr. Green and through his office, the President accept such preponderance as sufficient grounds to pass judgement on the issue and justify issuing Presidential

Proclamations? We certainly hope NOT! We all recognize that all the antisemitic literature is due to racial and religious hatred and bigotry and therefore baseless and should be ignored and rejected. By this token did it also occur to Mr. Green that anti-Turkish defamation literature in abundance might have a historical trace of bigotry, racial hate, and therefore should not be taken at its face value?

We would also like to remind Mr. Green that Turkey and Turks were not only subjected to defamation and hatred campaign just because of their race and religion as the Jewish people had been, but additionally they were maligned by a vicious and sadistic propaganda campaign, such as the masterworks of Wellington House in England and in the Allied countries during World War I for just being on the wrong side of the war.

The volume of publicity or propaganda cannot be considered as proof of a genocide when such a crime was not committed. Similarly lack of publicity and interest should not be construed as sufficient proof that such a crime did not occur when it was actually committed. Such was the case of the Turkish Genocide by the Armenians during 1918 to 1921. Victims were the Ottoman and Caucasian Turks and all Moslems (Armenians call them Tartars in their epic books to camouflage the issue) and therefore, had no sympathizers in the West, nor did they have a lobby machine and friends in the U.S. media and the Congress. They constituted 45% of the population in the Independent Republic of Armenia of Eastern Turkey and the Caucasus. It lasted 2.5 years.

Witnesses who wrote books about it in the West were two American officials, one was the intelligence officer of Admiral Lambert Bristol (who was the U.S. High Commissioner and later became Ambassador to Turkey); the other was a Near Eastern Relief program officer; still another, A political Diary by Avetis Aharonian, and Armenian Statesman who admitted years later. Other reports included the British official investigations and foreign office dispatches and the diaries of the residual Russian Army Officer in the post war zone. But, since this unique genocide did not create any interest and publicity in the West, we are sure that Mr. Green never heard of it and therefore, according to his logic, it cannot exist.

We believe that publicity or no publicity, sympathy or no sympathy, in the West, in the annals of Turkish history this affair remains to be a Genocide because of the historical facts and documents, however, modest in quantity compared to the Armenian case built on falsifications, hate campaigns, lobby pressures and muscle, there is a difference!

Armenian propagandists and their Congressional insiders can call their case a Genocide. It is regrettable, but, this is a price we pay for our fundamental right for free expression of opinion. However, in our judgement, if a White House official uses it carelessly and irresponsibly, it takes on a different

#### Days of Remembrance of Victims of the Holocaust

By the President of the United States of America

#### A Proclamation

The Congress of the United States established the United States Holocaust Memorial Council to create a living memorial to the victims of the Nazi Holocaust. Its purpose: So mankind will never lose memory of that terrible moment in time when the awful spectre of death camps stained the history of our world.

When America and its allies liberated those haunting places of terror and sick destructiveness, the world came to a vivid and tragic understanding of the evil it faced in those years of the Second World War. Each of those names—Auschwitz, Buchenwald, Dachau, Treblinka and so many others—became synonymous with horror.

The millions of deaths, the gas chambers, the inhuman crematoria, and the thousands of people who somehow survived with lifetime scars are all now part of the conscience of history. Forever must we remember just how precious is civilization, how important is liberty, and how heroic is the human spirit.

Like the genocide of the Armenians before it, and the genocide of the Cambodians which followed it—and like too many other such persecutions of too many other peoples—the lessons of the Holocaust must never be forgotten.

As part of its mandate, the Holocaust Memorial Council has been directed to designate annual Days of Remembrance as a national, civic commemoration of the Holocaust, and to encourage and sponsor appropriate observances throughout the United States. This year, the national Days of Remembrance will be observed on April 26 through May 3.

NOW. THEREFORE. I, RONALD REAGAN, President of the United States of America. do hereby ask the people of the United States to observe this solemn anniversary of the liberation of the Nazi death camps, with appropriate study, prayers and commemoration, as a tribute to the spirit of freedom and justice which Americans fought so hard and well to preserve.

IN WITNESS WHEREOF. I have hereunto set my hand this 22nd day of April. in the year of our Lord nineteen hundred and eighty-one, and of the Independence of the United States of America the two hundred and fifth.

US policy on America Resolution

Dear Senator Thurmond:

I understand that the Committee on the Judiciary will consider SJ Resolution 43 designating April 24, 1987 as a "National Day of Remembrance for Victims of the Armenian Genocide". The purpose of this letter is to give you the Administration's views on this legislation, which we oppose. Our opposition is based on three central and related concerns: first, the significance of Turkey as an ally; second, the very negative effect on this sensitive and vital relationship were Congress to pass a resolution which accuses the Turks of genocide against the Armenians; and third the risk that passage of this legislation could encourage terrorism directed at both Turkish and American citizens.

In the postwar era, the United States has attached great importance to its relationship with Turkey. Administrations have done so with the support of Congress because of a shared recognition of the need to maintain a strong and fruitful relationship between the United States and Turkey. A major nation with a promising future, Turkey is a bridge and buffer in a critical region. It sits astride the vital narrows between the Black Sea and the Mediterranean, controls land and air access to the Middle East and has extensive borders with Bulgaria, the Soviet Union, Iran, Iraq and Syria. We are fortunate that our desire for a strong partnership with Turkey has been realized in an alliance based on mutual respect and confidence.

Turkey contributes greatly to the success of the NATO Alliance in deterring aggression. While it is the poorest member of NATO, Turkey nonetheless spends a greater percentage of its GNP on defense than almost any other NATO ally. It has NATO's second largest Army, tying down major Soviet and Warsaw Pact forces.

Moreover, as part of our alliance relationship with Turkey, we have access to military facilities there that play a major role in our defense. Composed of six major facilities and many smaller ones, they include air bases for deployment of U.S. forces, logistic depots and vital intelligence collection facilities. In this regard, we have just signed an agreement for our defense cooperation with Turkey, extending our present agreement until 1990 and committing us to strong efforts to provide necessary assistance to help Turkey modernize its military and strengthen its economy.

SJ Resolution 43 judges the Armenians who died in the Ottoman Empire (present-day Turkey) in 1915-1923 to be victims of genocide. A similar draft resolution in 1985 provoked near universal public outcry in Turkey, as well as a movement in the Turkish Parliament for review of diplomatic relations with the United States. Prime Minister Ozal was able to head off this latter effort. However, the Turkish Government also informed us that adoption of a resolution to this effect would seriously damage the vital relationship between Turkey and the United States. And that is still the prospect if the 100th Congress should pass a resolution that indicts the Turkish people for the events of 1915-1923.

Besides reflecting resentment at a judgment by the United States Congress that Turkey, and the Turks as a people, bear the guilt of perpetrating genocide, such strong Turkish reaction is also related to modern Armenian terrorism. Since 1975 over 50 Turkish citizens, mostly diplomats, have been killed by Armenian terrorists. In addition to demanding Turkish Government recognition of an Armenian genocide, the terrorists demand reparations and cession of a major portion of eastern Turkey to form an independent Armenian state. The Turks thus view the campaign to characterize the tragedy of the Armenians as a genocide as the first step toward their territorial dismemberment.

Armenian terrorism has affected Americans. Four assassinations have occurred on our soil. U.S. citizens have been the target of a number of attempted bombings or other harassment during this terrorist campaign, and one U.S. citizen died in an Armenian attack on a Turkish airport. ASALA, one of the two major Armenian terrorist groups engaged in these activities, also aids other terrorist groups which have Americans as their primary target. It has publicly declared its support of Islamic Jihad, the Iranian-supported terrorist organization responsible for so much of the violence in Lebanon. We believe that resolutions judging Turkey responsible for Armenian genocide, however well-intentioned and however worded, will inevitably be seen by the terrorists as encouragement of and justification for their acts.

We regret the suffering and tragedy experienced by Armenians. We do not seek to dismiss the devastation and the widespread massacres suffered by this group. Indeed, there is no doubt that much of the population in Eastern Turkey, Christian and Moslem, experienced death, deprivation and removal during these wartime years. When a House Resolution similar to SJ Res 43 was under consideration in 1985, sixty-nine American academicians who specialize in Turkish, Ottoman and Middle Eastern studies wrote the House membership that they had reservations about use of the word genocide to describe what took place in 1915-1923.

Politically, Turkey has continued to consolidate its democracy. Economically, the country is making progress in a program to release its huge potential. Passage of a resolution offensive to Turkey and to Turks would undermine the effectiveness of our support for these efforts when we have every reason to want Turkey to succeed as a prospering democracy. Passage could also set back our efforts to encourage Turkey to play a positive role on Cyprus--an issue which also arouses deep nationalist sentiments and on which the Turkish government is playing a positive role.

Dear Mr. President,

I am a student of genocide and an official witness to the Holocaust. I often lecture about these mass destructions of the innocent to all kinds of audiences, including substantial numbers of graduate, college and high school students.

I am surprised and mortified by your reported opposition to the congressional resolutions (S.J. Res. 43 and H.J. Res. 132) designating April 24 as a National Day of Remembrance for victims of the Armenian Genocide Such a stand would offend a growing number of citizens who are learning about the Holocaust and at the same time are realizing the significance of the Armenian tragedy in relation to the large scale violence of our century.

Our country, so devoted to human rights, should be an example to the rest of the world in making this first step towards remedying a long festering injustice and your leadership in this matter would enhance your historical status in the annals of our republic.
