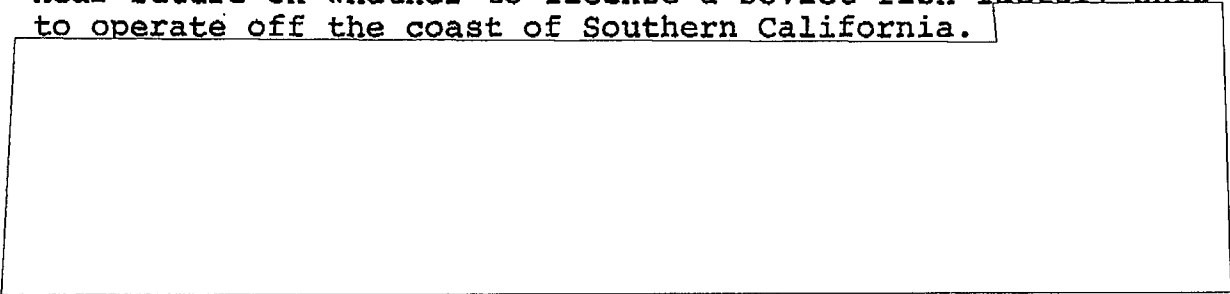

SUBJECT: Soviet Fish Factory Ship

It is my understanding that a decision may be made in the near future on whether to license a Soviet fish factory ship to operate off the coast of Southern California.

I request that appropriate elements of the intelligence community undertake an immediate assessment of the hostile intelligence threat which could be posed by a Soviet vessel which is permitted to operate in this area. The results of this assessment should be made available to myself and to appropriate officials within the Commerce Department, after which a final decision can be made.
