2. BRIAN URQHART, UN UNDERSECRETARY GENERAL, CALLED DEPARTMENT AT 2130 HOURS JUNE 5 TO CONVEY PLO REACTION TO SECURITY COUNCIL RESOLUTION 508 CALLING FOR A LEBANON CEASE-FIRE. URQHART REPORTED THAT HE HAD JUST RECEIVED A MESSAGE FROM THE PLO WHICH HE EMPHASIZED WAS CONVEYED AS AUTHORITATIVE, THAT IS, IT HAD THE APPROVAL OF THE FULL PLO LEADERSHIP. THE OPERATIVE PART OF THE MESSAGE STATED THAT IT IS ENCUMBENT UPON ISRAEL TO STOP AGGRESSION BUT "THE PALESTINIAN SIDE CONVEYS ITS COMMITMENT TO STOP ALL MILITARY OPERATIONS ACROSS LEBANON'S BORDERS WHILE RESERVING ITS RIGHT TO RESPOND TO AGGRESSION."

3. URQHART SAID THAT IN ADDITION HE HAD BEEN TOLD THAT THIS MESSAGE WAS SPECIFICALLY MEANT WAS A POSITIVE RESPONSE TO UNSC RESOLUTION 508 AND THAT IT WAS MEANT TO REAFFIRM THE POSITIVE RESPONSE GIVEN BY THE PLO TO THE APPEAL OF THE UNSYG FOR AN END TO THE FIGHTING. URQHART ADDED THAT THE PLO HAD STATED IT UNDERSTOOD THAT IN PRESENT CIRCUMSTANCES THE DIFFICULTY IN HAVING A TOTAL END TO ALL

1. FOLLOWING ARE PROPOSED QS & AS REGARDING LEBANON AND UN ACTION ON THE FIGHTING.

2. Q. WHAT ARE YOU DOING TO STOP THE BLOODSHED IN THE LEBANON-ISRAEL SITUATION?

A. WE HAVE BEEN PULLING OUT ALL STOPS TO BRING ABOUT AN END TO THE FIGHTING AND A RESTORATION OF THE JULY 1981 CESSATION OF HOSTILITIES ARRANGED BY PHIL HABIB. WE HAVE SUPPORTED STRONGLY THE CALL BY THE SECURITY COUNCIL AND THE SECRETARY-GENERAL FOR A CESSATION OF HOSTILITIES AT DAWN THIS MORNING. WE HAVE BEEN IN TOUCH WITH ISRAEL AND EVERY SINGLE GOVERNMENT WITH SOME INFLUENCE OVER THE SITUATION OR THE PARTIES WHICH HAVE BEEN FIGHTING. I AM CONSULTING WITH PHIL HABIB LATER TODAY ON STEPS WE MIGHT TAKE TO BE HELPFUL.

3. Q. ISN'T THE US GIVING AT LEAST TACIT SUPPORT TO ISRAEL IN THIS FIGHTING? HASN'T THE ISRAELI MILITARY REACTION BEEN WAY OUT OF PROPORTION TO THE ATTEMPTED ASSASSINATION OF THE ISRAELI AMBASSADOR IN LONDON?

A. WE ARE NOT CONDONING FIGHTING AND VIOLENCE BY ANY PARTY, INCLUDING ISRAEL. I GRIEVE FOR THE MANY MANY INNOCENT WHO HAVE DIED IN THIS LATEST FIGHTING IN LEBANON AND FOR THOSE WHO HAVE SUFFERED IN ISRAEL. AS FOR WHAT WE ARE TRYING TO DO ABOUT THIS LOSS OF LIFE, WE ARE TRYING TO STOP IT. THAT IS OUR MAIN PREOCCUPATION, NOT WHAT BROUGHT IT ALL ABOUT.

A. WE ARE HOPEFUL THAT ALL CONCERNED WILL HEED THE CALL TO END THIS FIGHTING. (FILL IN DETAILS AS THEY BECOME AVAILABLE.)

A. WHATEVER HAPPENS THE US IS DETERMINED TO MOVE FORWARD AND TRY TO DEVELOP A BROAD AND JUST PEACE IN THE MIDDLE EAST. THERE HAVE BEEN MANY SETBACKS IN THE SEARCH FOR PEACE, BUT SIGNIFICANT PROGRESS HAS ALSO BEEN MADE. WE MUST OVERCOME THEM AND WORK TO SOLVE THE ROOT CAUSES OF THE CONFLICT, INCLUDING THE PALESTINIAN PROBLEM.
