2. AMBASSADOR AND POLOFF MET JUNE 6 WITH VISIT GROUP OF 16 AMERICAN CLERGYMEN AND MEDICAL PERSONNEL. LATTER ARRIVED IN BEIRUT LAST WEEK AT INVITATION OF RED CRESCENT INTERNATIONAL AND HAD JUST LEFT SABRA CAMP WHEN ISRAELIS BOMBED ON FRIDAY. THEY HAVE SPENT THE LAST TWO DAYS TREATING VICTIMS OF ISRAELI RAIDS AT THE AKKA HOSPITAL IN SABRA.
3. MEMBERS OF THE GROUP WERE CLEARLY SHAKEN AND OUTRAGED BY WHAT THEY HAD SEEN. THEY CONFIRMED THAT MANY OF THE CASUALTIES ARE CIVILIANS: 45 WERE DEAD ON ARRIVAL FRIDAY OR SUCCUMBED TO INJURIES. THEY SPENT MOST OF YESTERDAY, JUNE 5, IN THE EMERGENCY ROOM TRYING TO SAVE 35 CHILDREN WHO WERE ON A SCHOOL BUS HIT BY BOMBERS ON THE SIDON-BEIRUT ROAD SOUTH OF KHALDAH THAT DAY. TWENTY DIED.
4. MEMBERS OF THE GROUP WERE BITTER OVER BOTH ISRAELI ACTIONS AND PERCEIVED ABSENCE OF U.S. EFFORT TO FORESTALL OR STOP SUCH ATTACKS. AS ONE PUT IT, " THERE IS A LOT OF ANGER AGAINST THE U.S. AT THIS TABLE." WE SUSPECT IT IS NOTHING COMPARED TO ATTITUDES ELSEWHERE IN BEIRUT AND THE

THE CABINET TOOK THE FOLLOWING DECISION:

1. TO INSTRUCT THE ISRAEL DEFENSE FORCES TO PLAC ALL CIVILIAN POPULATION OF THE GALILEE BEYOND THE RANGE OF THE TERRORIST FIRE FROM LEBANON WHERE THEY, THEIR BASES AND THEIR HEADQUARTERS ARE CONCENTRATED.
2. THE NAME OF THE OPERATION IS "PEACE FOR GALILEE"
3. DURING THE OPERATION, THE SYRIAN ARMY WILL NOT BE ATTACKED UNLESS IT ATTACKS OUR FORCES.
4. ISRAEL CONTINUES TO ASPIRE TO THE SIGNING OF A PEACE TREATY WITH INDEPENDENT LEBANON, ITS TERRITORIAL INTEGRITY PRESERVED.
