1. SUMMARY AND COMMENT: NOT SURPRISINGLY, THE SHARP EXCHANGE OF CORRESPONDENCE BETWEEN CALLAGHAN AND EITAN HAS NOW BEEN MADE PUBLIC. THE JERUSALEM POST TODAY REPRINTED VIRTUALLY ALL OF EITAN'S LETTER, ALONG WITH A ROUGH PRECIS OF PORTIONS OF THE PROTEST FROM CALLAGHAN THAT BEGAN THE EXCHANGE. WORSE YET, THE POST STATES AS A FACT THAT "IN A FACE-TO-FACE MEETING THE DAY BEFORE THE ACTION WAS LAUNCHED, CALLAGHAN HAD REPEATEDLY WISHED EITAN AND THE IDF "GOOD LUCK AND SUCCESS IN ITS VENTURE." PLAINLY, THE IDF IS OUT TO HURT CALLAGHAN. END SUMMARY  
2. FOLLOWING IS FULL TEXT OF ARTICLE AS IT APPEARED 10 JUNE IN JERUSALEM POST OVER BYLINE OF ZE'EV SCHUL. BEGIN TEXT. CHIEF OF STAFF RAFAEL EITAN YESTERDAY FIRED OFF A SHARPLY WORDED LETTER TO UNIFIL COMMANDER GENERAL WILLIAM CALLAGHAN. THE IRISH GENERAL HAD CHARGED EITAN WITH A "BREACH OF FAITH" AND CRITICISED THE IDF FOR (AMONG OTHER THINGS) GIVING THE UNIFIL UNITS LESS THAN HALF AN HOUR'S WARNING OF THE INVASION OF LEBANON. " I HAVE RECEIVED YOUR LETTER AND UNDERSTAND FROM ITS CONTENTS THAT THE IDF'S ACTION IN THE LEBANON DOES

NOT MEET WITH YOUR APPROVAL," WROTE EITAN. "BUT I NEVER ASKED FOR YOUR PERMISSION OR AGREEMENT IN THE FIRST PLACE," THE CHIEF OF STAFF WROTE, POINTING OUT THAT THE ACTION WAS INTENDED TO ENSURE THE SAFETY OF ISRAELI CITIZENS ALONG THE COUNTRY'S NORTHERN BORDER.

EITAN ALSO NOTED THAT GREAT PAINS HAD BEEN TAKEN TO AVOID "UNNECESSARY CLASHES" WITH UNIFIL UNITS. IN A FACE-TO-FACE MEETING THE DAY BEFORE THE ACTION WAS LAUNCHED, CALLAGHAN--EVIDENTLY FULLY INFORMED OF WHAT WAS ABOUT TO HAPPEN--HAD REPEATEDLY WISHED THE ISRAELI CHIEF OF STAFF AND THE IDF GOOD LUCK AND SUCCESS IN ITS VENTURE.

BUT IN HIS LETTER, DISPATCHED A DAY LATER, AND IN TOTAL CONTRADICTION TO THE SPIRIT THAT, AT LEAST INFORMALLY, HAD PREVAILED THE DAY BEFORE, THE GENERAL ACCUSED EITAN OF A "BREACH OF FAITH," ADDING THAT THE DEATH OF A NORWEGIAN SULDIER COULD HAVE BEEN AVOIDED HAD ISRAEL ABSTAINED FROM ITS "ILLEGAL INCURSION" INTO TERRITORY HELD BY THE UNIFIL UNITS IN TRUST.

CALLAGHAN SAID THAT THE INVASION VIOLATED THE UN DECISION TO SET UP AN INTERNATIONAL FORCE BETWEEN ISRAEL AND THE PALESTINIANS. "THIS WAS AN UNPRECEDENTED DISPLAY OF FORCE, WITH NO REGARD FOR LEBANESE SOVEREIGNTY," HE WROTE.

INFORMED SOURCES HERE POINTED OUT THAT GENERAL CALLAGHAN'S LETTER MADE NO REFERENCE TO THE CAUSES OF THE IDF OPERATION --INCLUDING THE PERPETRATION OF ACTS OF MURDER AND TERROR AGAINST CIVILIAN POPULATIONS IN THIS COUNTRY AND THE WORLD IN GENERAL.

EITAN WROTE THAT CALLAGHAN'S ACCUSATION CONCERNING THE DEATH OF THE NORWEGIAN SULDIER MATCHED "THE DASTARDLY CHARGES MADE BY UNIFIL MEN CONCERNING THE BURNING OF CORPSES OF INFILTRATORS."

IN JANUARY 1981, DUTCH UNIFIL SOLDIERS REPORTED THAT ISRAELI SOLDIERS HAD MUTILIATED THE BODIES OF DEAD TERRORISTS. THE CHARGE WAS SUBSEQUENTLY PROVED UNFOUNDED. "THEN AS NOW THESE ACCUSATIONS LACK ALL SUBSTANCE AND CONSTITUTE A GRAVE AFFRONT TO TRUTH AND MILITARY INTEGRITY," EITAN WROTE, ADDING "THE IDF WILL CARRY OUT ITS ASSIGNMENTS WHETHER YOU LIKE IT OR NOT...I NOTE THAT YOUR LETTER TO ME WAS NOT MARKED 'CLASSIFIED' AND I THEREFORE DECIDED TO PUBLISH YOUR LETTER AND MY REPLY TO IT, RAV-ALUF RAFAEL EITAN, CHIEF OF STAFF, IDF, 8.6.82.

1. TUENI WARNS AGAINST U.S. APPEARING TO NEGOTIATE A CEASEFIRE WITH ISREAL AND SYRIA. THIS HAS TWO PITFALLS: (A) IT MAKES SYRIA SEEM TO BE THE CHIEF SPOKESMAN FOR AKABS AND ALL NON-ISREALI FORCES. THIS STRENGTHENS SYRIA -- A PATENTLY UNDESIREABLE OUTCOME. (B) IT MAKES THE GOL APPEAR IRRELEVANT NOT EVEN A PARTY TO A CEASEFIRE AND THEREFORE, WEAKENS IT.

2. IT IS MUCH PREFERABLE THEREFORE TO WORK IN THE CONTEXT OF THE UN SECURITY COUNCIL RESOLUTION 509 WHICH IS ADDRESSED TO THE GOL AND THE PLU, THOUGH "SYRIA HAS TO BE TAKEN CARE OF SOMEHOW." GOL HAS CONSISTENTLY EMPHASIZED UNSC RESOLUTION 509 AS CONTEXT FOR ENDING HOSTILITIES AND ALSO EMPHASIZED US PARTICIPATION.

3. IMPORTANT TO BEAR IN MIND IN THINKING ABOUT ISRAELI WITHDRAWAL TO THE 42ND PARALLEL IS THAT LEBANESE ARMY SHOULD NOT BE ASKED TO TAKE OVER TYRE AND SIDON ET AL. DIRECTLY FROM THE ISRAELI CONQUEST. IT IS FAR BETTER TO LEAVE THE ISRAELI ARMY THERE FOR A PERIOD WHILE LONGER RANGE ARRANGEMENTS ARE BEING WORKED OUT. EVERYONE "EXPECTS" WITHDRAWAL WILL TAKE SOME TIME. SYRIA ALSO SHOULD NOT BE REMITTED TO FEEL THIS VACUM.

4. HOWEVER, IT IS VERY IMPORTANT THAT BEIRUT NOT BE OCCUPIED BY ISRAELIS. NO ARAB CAPITAL EVER HAS BEEN. AT ALL COSTS, DON'T LET BEIRUT COME TO BEIRUT.

5. THE IRANIAN DEFENSE CHIEF IS IN BEIRUT. THERE ARE SOME IRANIAN VOLENTEERS THERE.

6. THERE WILL PROBABLY BE A CALL FOR A SPECIAL SESSION AT THE CA TOMORROW IF WE DON'T HAVE CONCRETE PROGRESS BY THEN.

7. U.S. SHOULD NOT MAKE ANY PUBLIC COMMENTS AT ALL ABOUT A UNIFIL ROLE. THIS AROUSES SOVIET OPPOSITION. THE CHANCE OF GETTING AN ENLARGED UNIFIL ROLE IS INVERSE TO PUBLIC DISCUSSION OF IT.
