SUMMARY. This memorandum forwards for your consideration a proposed Executive order which would extend the time for submission of the report of the Presidential Commission on Indian Reservation Economies.

BACKGROUND. Executive Order No. 12401 of January 14, 1983, established the Presidential Commission on Indian Reservation Economies and provided that it would report to the President by September 30, 1983. The Commission has yet to hold its first meeting. The proposed order would extend the time for the Commission to conduct its study and submit its report until six months after the appointment of the last Commissioner or April 30, 1984, whichever comes earlier.

None of the affected agencies has objected to the proposed Executive order.

RECOMMENDATION. I recommend that you sign the proposed Executive order.

By the authority vested in me as President by the Constitution and laws of the United States of America, including the Federal Advisory Committee Act, as amended (5 U.S.C. App. I), it is hereby ordered as follows:

Section 1. Section 2(d) of Executive Order No. 12401 is hereby amended to provide as follows:

"The Commission shall, unless sooner extended, submit a final report to the President and the Secretary of the Interior within six months after appointment of the last Commissioner, or by April 30, 1984, whichever comes earlier."

Sec. 2. Section 4(b) of Executive Order No. 12401 is hereby amended to provide as follows:

"The Commission shall terminate 30 days after it transmits its final report to the President."

NATIONAL DAY OF MOURNING
SUNDAY, SEPTEMBER 11, 1983

BY THE PRESIDENT OF THE UNITED STATES OF AMERICA
A PROCLAMATION

TO THE PEOPLE OF THE UNITED STATES:

September 1, 1983, will be seared in the minds of civilized people everywhere as the night of the Korean Air Lines Massacre. Two hundred sixty-nine innocent men, women and children, ^{including United States Congressman Larry P. Mc Donald,} from 13 different countries, who were flying aboard KAL flight 007, were stalked, then shot out of the air and sent crashing to their deaths by a missile aimed and fired by the Soviet Union.

Good and decent people everywhere are filled with revulsion by this despicable deed, and by the refusal of the guilty to tell the truth. This was a crime against humanity that must never be forgotten, here or throughout the world.

We open our hearts in prayer to the victims and their families. We earnestly beseech our loving God to minister to them in their trial of grief, sorrow, and pain.

In His name, and in their memory, we ask all people who cherish individual rights, and who believe each human life is sacred, to come together in a shared spirit of wisdom, unity, courage, and love, so the world can prevent such an inhuman act from ever happening again.

NOW, THEREFORE, I, RONALD REAGAN, President of the United States of America, in tribute to the memory of the slain passengers of Korean Air Lines flight 007, and as an expression of public sorrow, do hereby appoint Sunday, September 11, 1983, to be a National Day of Mourning

throughout the United States. I recommend that the people assemble on that day in their respective places of worship, there to pay homage to the memory of those who died. I invite the people of the world who share our grief to join us in this solemn observance.

IN WITNESS WHEREOF, I have hereunto set my hand this
day of September, in the year of our Lord
nineteen hundred and eighty-three, and of the Independence of
the United States of America the two hundred and eighth.





Dear President Reagan:

You are herewith most cordially and formally invited to address the delegates of the 12th Annual International AAI Academy at the Banquet Dinner on Saturday, October 22, 1983 at 7:30 P.M.

The new Sheraton Hotel in Lansing, Michigan will be the site for this important annual event. The dates are set for Thursday, October 20 to Sunday, October 23.

In each of the past two years we have written to you and asked for your personal encouragement and official support of our vital volunteer services in our country and around the world. In both instances, your inspiring support messages which you sent by telegram were read at the annual banquet and received by the registrants with electrifying enthusiasm. They returned to their local service centers in their native countries and in the U.S.A. to bring renewed motivation to the thousands of volunteer workers and pro-life centers.

The alternatives to abortion service programs with about 1,500 local groups in the U.S.A. alone, are now even more urgent and indispensable, if this is possible. Year after year, since our inception in 1971, the services which we offer at no cost have reached thousands and thousands of distressed girls and women, enabling them to save their unborn babies, while protecting their own well-being and building their future lives positively and successfully. With the latest Supreme Court pro-abortion rulings on Wednesday, June 15, the abortion dilemma in the U.S., to this point already having reached an intolerable 1.5 million legal abortions annually, is now legally set up to deepen and widen. The volunteer services of Alternatives to Abortion International not only



remain, but now have become the major practical pro-life effort which directly assists those who otherwise might be pressured into having abortions.

Please bear in mind that AAI is strictly a service movement, not involving itself in the political arena, but devoting its efforts entirely to the appeals for assistance by the millions who are confronted with problem pregnancies, and who, without such support, might succumb to the blandishments of those seeking - for whatever reason - to promote abortion as a proper expedient over the convictions and wishes of such distressed persons.

By being non-political, these centers can come closer to reaching the millions today who are so desperately in need of personal and practical support. By being non-political, AAI is unhampered by adversaries and thus in a position to help turn around the thinking of those under pressure by forces of the anti-life movement.

Mr. President, with this in mind we hope you will seriously consider accepting our invitation and address the gathering at our Annual Banquet. Naturally, because our groups are made up of more than 99% volunteer workers, both professional and para-professional, the strictly volunteer nature of this endeavor should meet with the often expressed approval by you and Mrs. Reagan. We would therefore be most honored to have the First Lady along with you for a most important source of inspiration and support.

Politically speaking, there may be some merit to recall that Michigan was one state in which a plebiscite was conducted on the subject of abortion, now more than ten years ago. Those who voted rejected abortion in 81 of 83 counties there. Then too, the Michigan legislature has nine times passed restrictive ruling on abortion, only to have such measures vetoed by the then Governor.

Thank you very much for your consideration of our large request on behalf of the American people, the people of the world -- their mothers, their babies and their families.
