SUBJECT: Letter to Prime Minister Takeshita of Japan

State has drafted a letter (Tab A) to Prime Minister Takeshita from the President to be delivered by Assistant Secretary Gaston Sigur during his visit to Tokyo, November 10-11. The letter:

- is the first "Ron-Noboru" correspondence, and congratulates the new Prime Minister;
- reviews the agenda of key issues and the need for close cooperation on each.
- repeats the President's visit invitation, date to be determined.

The letter will be hand-carried by Sigur over the weekend and so needs to be signed by tomorrow afternoon, November 6.

Speechwriters concur.



Issue

Whether to sign the letter to Prime Minister Takeshita at Tab A.

Fact

Assistant Secretary of State Gaston Sigur is going to Tokyo at Secretary Shultz's direction and he will meet with Prime Minister Takeshita on next Tuesday or Wednesday, November 10-11. This is the first "Ron-Noboru" letter and is designed to reiterate your congratulations, review the key issues and our need for close cooperation, and repeat your invitation for Takeshita to visit at some appropriate time.

Discussion

Your letter will set a business-like tone for the new relationship with Prime Minister Takeshita. It is intended to demonstrate your particular interest in the issues cited above, and to evoke a positive response.
