The motorcade's departure from the Waldorf Astoria was delayed by 20 minutes because the First Lady's car was tied up in heavy traffic. Rumor had it that she was shopping. When the President and the First Lady boarded the plane, we asked her about her tardiness. She said "traffic." When we asked if she had been shopping, she made a gesture we couldn't interpret -- it looked sort of like she was patting the air. Then she and the President boarded the plane. When we were on board, Marlin came back and said the First Lady had asked ~~me~~ him to impart a message to us: she was late because of heavy traffic. We ~~had~~ asked where she had been before her car arrived and Marlin laughed and said he didn't know. Ken Duberstein said, before boarding the plane, that she had been having lunch. He said he did not know who her lunch partners were.

P.S. While waiting for Mrs. Reagan's car to arrive, we spotted Colin Powell and Ken Duberstein head across the street to a deli and return carrying hotdogs.

Despite previous advertisements by Roman Popaduk that NSC Adviser Powell would come back and talk to your pool during ~~the~~ the flight, Powell never appeared.

I have read your memo nominating Lenny Perroots for the award of the National Security Medal. I certainly agree that Lenny has contributed significantly to our national security while Director of DIA and in previous positions and is deserving of significant recognition. I am writing to follow up on a suggestion made during the summer. It concerns Steve Bryen who will resign on September 30th as Deputy Under Secretary of Defense, Trade Security Policy.


Steve has also been dual hatted as the Director, Defense Technology Security Administration since May 10, 1985 and has been the President's point man in DoD for strategic policy issues since 1981. He has made a superb contribution to our national security interests through his judicious articulation of Defense concerns in the export license decision process. Steve has demonstrated remarkable courage in pursuing extremely complex matters that were at the time unpopular, because he correctly understood the strategic importance of certain high technology items in the balance of power between the West and the East Bloc.

Of all of the people that I have had the honor to work with in the course of this Administration, I believe that Steve deserves recognition at the highest level.

Accordingly, I would like you to consider an appropriate Presidential award/citation to commemorate his effort to others who have committed their careers to achieving the same strategic objectives to strengthen the export license control system.

You asked why you are getting pulled into the issue of the Commission on Merchant Marine report. The answer is that when the commission presented its report to the President, NSC picked up responsibility for staffing its recommendations -- a process that is ongoing, in response to our tasking to the departments and agencies concerned. Denton and others are concerned that there may not be time for this Administration to act on the recommendations (they are probably right, and no one in the Administration wants to seize that nettle, anyway). As I observed in my profs note, the main reason it has taken several months to staff the recommendations is that the commission provided absolutely no cost data, and OSD has been working up cost estimates. There is no real reason for you to get personally involved at this point; and Will Ball may not call you. If he does, I suspect it will be simply to pass on the gist of the conversation he had with Denton.

Colin, I readdressed to you Jim Miskel's note concerning a possible call to you from Will Ball on sealift policy. Jerry Denton, and members of the commission on merchant marine, are pressing to accelerate executive branch action on the commission's report. Principal reason for the delay has been the fact that the report had absolutely no cost data related to the commission's recommendations, and both OMB and DOD felt no intelligent assessment of the recommendations could be made in the absence of at least rough cost estimates. DOD has finished that effort, together with a draft sealift policy statement, which are going out now for review. The issue is a contentious one bureaucratically, and I doubt that we will get it resolved before the end of the Administration. The arguments are very familiar ones; but it comes down to a question of priorities -- what do we give up to invest more heavily in the merchant marine. Navy (and most in DOD) feel this Administration's track record on sealift has been a good one, and that the more sweeping recommendations of the commission aimed at rebuilding the US merchant marine are generally not affordable.






Dear Colin:

IMPLEMENTING THE TRADE ACT - THE TEN MOST IMPORTANT PRIORITIES

1. Preserve the President's prerogative in setting trade policy. Only the President can weigh all aspects of the national interest, not individual members of Congress or Cabinet members.

The Trade Act transfers authority from the President to USTR on Section 301 cases. We should issue an executive order that reaffirms the President's prerogative and ensures he has the best advice available from all the members of his Cabinet.

2. Minimize the confrontational aspects of the law, particularly with regard to identifying "priority" countries.

The trade law requires the executive branch to draw up lists of "priority" countries on intellectual property, telecommunications and general unfair trade practices. This is the vestige of the Gephardt Amendment. These lists will anger those countries which we identify, perhaps to an extent that may impede our ability to achieve our market-opening objectives. When drawing up these lists, we must be thinking strategically and tactically, not merely from an accountant's perspective.

3. Use our trade laws to attack trade problems, and avoid linkage with other issues, including foreign policy concerns.

The new law identifies denial of worker rights as an unreasonable trade practice, and therefore a basis for filing a petition under section 301. In fact, the AFL-CIO is considering filing such a petition against the Polish government for its refusal to recognize the Solidarity Trade Union. Existing regulations require a petitioner to show that a practice "burdens or restricts US commerce". We should emphasize that trade actions will be taken only to remedy trade complaints. We should not use our trade laws to address social or foreign policy concerns, no matter how well-intentioned.

4. Provide clarity and specificity in the procedural questions. Define who has standing to initiate a petition for trade action.

The new law contains many arcane changes which move away from the principle of presumed innocence toward presumed guilt. Examples include easier standards and longer terms of relief on Section 201 cases, monitoring downstream industries for antidumping filing and shorter deadlines for decisions on cases. We must establish strong economic

criteria for acceptance of new cases under these statutes, and ensure that the burden of proof of guilt and provision of information remains with the petitioner.

5. Quickly implement changes in our export licensing procedures so our firms can export competitively without unnecessary red tape.

The Trade Act expresses the desire of Congress to decontrol a large number of items that no longer are of strategic importance. We must promptly streamline our control lists, bringing them into conformity with the COCOM list. We also should work with our Allies to reduce the COCOM list as much as possible, consistent with our security.

6. Administer export control laws in a manner that strengthens COCOM and promotes the adoption of strong export control systems by our COCOM allies and other cooperating countries.

The Trade Act authorizes us to remove export controls from countries which meet the Act's standard of an "effective export control system". Very few COCOM members could fully pass such a test now. Giving most COCOM countries a "failing grade" in public would embarrass them and would make it more difficult for them to cooperate with us. Rather, we should work within COCOM to develop a common standard that would serve as a basis for certification. We should use both diplomatic leverage and technical support to ensure that every COCOM country achieves a satisfactory level of effectiveness.

7. Ensure that in carrying out the new trade law, we do not violate our GATT obligations, or weaken the GATT as an institution.

Our major trading partners believe this law is GATT illegal. We must draft regulations to ensure that amendments to countervailing duty and anti-dumping laws and to Section 301 (retaliation against unjustifiable, unreasonable, or discriminatory practices) are interpreted and applied in a way that is consistent with our GATT obligations. For example, we may well wish to retaliate against a practice that we consider unreasonable though not illegal under the GATT. In those cases, we should choose a method of retaliation that does not violate our GATT commitments.

As we have often noted in the past, we continue to review the situation in the Persian Gulf on an ongoing basis in order to adjust both operations and force levels to support most effectively our interests in the region. The Administration is considering additional steps which I would describe as modest modifications of our present method of providing protection to U.S. flag ships in the Gulf. While I am not in a position to go into detail, I can state that the modifications we currently have under consideration do not involve any significant reduction in U.S. force levels. We are continuing to consult closely with our friends and Allies.

I talked with Duncan Hunter this morning and told him that Mr. Adams had not seen MIG-23's at Sandino Airfield. I also told him we had talked with the Major who thinks it was either helicopters or T-33's. Mr. Hunter passed this on to Mr. Adams who then said he knows the difference between a helicopter and a jet and they were jets and he has flown in the back seat of a T-33 and he didn't think these were T-33's. Hunter then called me back. I told Hunter that we were through chasing this story. The entire intelligence community has now spent close to a week on what I believe was a mistake made by Mr. Adams. If Mr. Adams makes the claim that he has seen MIG-23's the intelligence community and the government will not substantiate that claim. I do not believe Mr. Adams will make such a claim. I told Congressman Hunter that we would not be pursuing this any further. Sorry but Mr. Adams to the best of our knowledge and belief was mistaken. If he can get better evidence we would be delighted to reopen it but we cannot spend any more time on this effort.

Yesterday evening I had a one-on-one conversation with Steve Solarz in my office. His principal reason for seeing me was to discuss the non-Communist resistance (NCR). He knows that we are examining providing additional support to the NCR and he encourages us in our effort for reasons you all know well. He believes it is essential that the NCR be made a more viable military and diplomatic counterforce to the Khmer Rouge. I told him I would check on the status of our consideration of additional resources and I would get back to him. Please give me a profs note back that I can use to talk to Congressman Solarz.

We also discussed the Philippines and we both have the same view that the Philippine Foreign Minister has got to be told in no uncertain terms that we are not prepared to go as far as he wishes us to go on the Bases, that we are definitely studying alternatives and that their failure to solve this problem will have serious consequences to the multinational aid package. He asked if we were counting in our soft dollars providing the Philippines surplus army helicopters.

Turning to Burma, Steve feels that Me Win is still calling the shots. He said that Mike Mansfield has a special relationship with Me Win and we might want to give some consideration to asking Ambassador Mansfield to make an approach to Me Win. Steve gave this idea to Gaston Sigur. Any follow-up?

P.S. With respect to the NCR, Steve was talking about a level of support that would provide 1,000 additional fighters each month.
