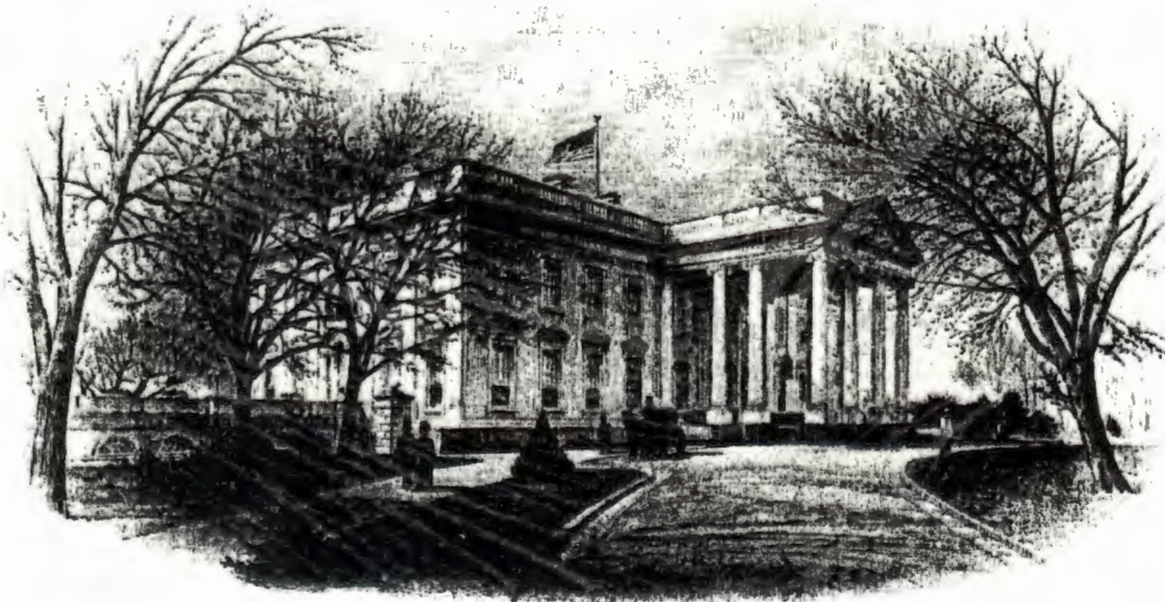

THE INTENSIFICATION OF THE UNITED STATES' POLICY OF BARING ITS
