ON RECEIPT OF REF A I CONTACTED KIMCHE ON SUNDAY AFTERNOON JUNE 20 TO INFORM HIM THAT HARIB HAD JUST MET WITH SARKIS, BOUTROS AND ABDU AND HAD URGED THEM TO SPELL OUT THEIR OWN DEMANDS CLEARLY TO THE PLO NOT WITHSTANDING THE FACT THAT THE PLO WAS STILL RESISTING A SCENARIO WHEREBY IT WOULD ACCEPT THE AUTHORITY IMPOSED THROUGH THE DEPLOYMENT OF THE LAF INTO WEST BEIRUT AND ULTIMATE NEGOTIATIONS TO LIMIT THE PALESTINIAN PRESENCE IN LEBANON AND TO TRANSFORM THE PLO-GOL RELATIONSHIP.
