COMMENCE TEXT: FOREIGN MINISTER YITZHAK SHAMIR WARNED AGAINST OPERATIVE TIES BETWEEN EGYPT AND THE PLO. IN A TELEVISION INTERVIEW ON THE ARAB PROGRAM, THE FOREIGN MINISTER SAID PRIOR TO THE SINAI WITHDRAWAL'S COMPLETION WE HAD WARNED THE EGYPTIANS AGAINST OPERATIVE TIES WITH THE TERRORIST ORGANIZATIONS, SINCE WE FEARED SUCH TIES WOULD ADVERSELY INFLUENCE THE PEACE PROCESS AND EGYPTIAN-ISRAELI RELATIONS.
