WITHOUT PUTTING TOO FINE A POINT ON IT, FAILURE OF MCPHERSON TO DEAL WITH THE GOI AUTHORITIES IN SOUTHERN LEBANON OR ATTEMPT TO CONDUCT THE VISIT AS A BUSINESS AS USUAL ATTEMPT AT FACT-FINDING RISKS NOT ONLY THE SUCCESS OF THIS TRIP BUT GETS THE ENTIRE RELIEF EFFORT IN SOUTHERN LEBANON OFF ON THE WRONG FOOT. WE APPRECIATE THE FRUSTRATION OF OUR COLLEGUES IN BEIRUT AT NOT BEING ABLE TO HANDLE THIS STRICTLY WITH REFERENCE TO THE LEBANESE AUTHORITIES. BETHLEHEM WAS FOUND AT THE SITE WITH MANY STAB WOUNDS. THE VICTIM WAS IDENTIFIED AS DAVID ROSENFELD, AN AMERICAN CITIZEN LIVING IN THE SETTLEMENT OF TEQQA. THE IDF SUBSEQUENTLY ARRESTED TWO ARABS FROM A NEARBY VILLAGE, WHOM THE ISRAELI RADIO CHARACTERIZED AS "MEMBERS OF A TERRORIST ORGANIZATION," AND DESTROYED A HOUSE IN TA'AMREH VILLAGE WHICH BELONGED TO ONE OF THEM.

(C) AL QUDS AND THE POST REPORT THAT AN "IMPORTANT" P.L.O. INFORMATION CENTER WAS UNCOVERED IN RAMALLAH ON JULY 4, OPERATING UNDER THE COVER OF THE "UNION OF PALESTINIAN WOMEN." PAMPHLETS AND CASSETTES WERE SEIZED, AND SEVERAL YOUTHS FOUND INSIDE THE BUILDING (WHICH IRONICALLY WAS CLOSED AS PART OF THE COMMERCIAL STRIKE) WERE ARRESTED.

COMMENT: EVER SINCE THE IDF OPERATION IN LEBANON BEGAN A MONTH AGO, PRIME MINISTER BEGIN AND HIS COALITION HAVE BEEN IN LITTLE DANGER OF BEING THREATENED AT A TIME WHEN MANY ISRAELIS HAVE RALLIED TO SUPPORT THE GOVERNMENT. PRIME MINISTER BEGIN HAD BEEN EXPOSED IN THE KNESSET WITH ONLY 59 VOTES (OUT OF 120) AFTER THE DEFECTION IN MAY OF YITZHAK PERETZ AND AMNON LINN TO THE ALIGNMENT. WITH HURVITZ AND BEN-PORAT COMING INTO THE FOLD, HOWEVER, THE COALITION CAN LOOK FORWARD TO A DEGREE OF RELATIVE PARLIAMENTARY STABILITY, AT LEAST IN THE SHORT RUN. THE PRIME MINISTER IS NOW ACTIVELY PURSUING TEHIYA AND FEW EXPECT HIM TO MOVE FOR EARLY ELECTIONS ANY TIME IN THE NEAR FUTURE. THUS, ACTIVE CONSIDERATION OF ELECTIONS (WHICH THE NRP CONTINUES TO OPPOSE) WILL BE PUT OFF AT LEAST UNTIL THE LEBANESE SITUATION SETTLES DOWN AND THE OUTLINES OF A SETTLEMENT FIRM UP.
