SUBJ: BEIRUT MEDIA SUMMARY, JULY 6

1. JULY 6 EDITIONS OF BEIRUT DAILIES REPORT A MEETING IN BAABDA YESTERDAY BETWEEN AMBASSADOR HABIB AND ISRAELI DEFENSE MINISTER ARIEL SHARON. ACCORDING TO INDEPENDENT AL-ANWAR, AFTER HABIB ASKED THE ISRAELIS TO OPEN THE CROSSING POINT BETWEEN EAST AND WEST BEIRUT AT GALLERY SEMAN, AGREEMENT WAS REACHED TO OPEN THE CROSSING UNDER LEBANESE ARMY SUPERVISION, WITH PASSAGE LIMITED TO SENIOR GOVERNMENT, POLITICAL AND MILITARY FIGURES. AL-NAWAR SAYS, HOWEVER, THAT THE HABIB-SHARON DISCUSSION CENTERED ON TWO MAIN POINTS: (1) THE INTRODUCTION OF FRENCH FORCES INTO BEIRUT TO REASSURE THE PALESTINIANS WHO DO NOT TRUST THE LEBANESE ARMY ALONE, A PROPOSAL WHICH SHARON WAS SAID NOT TO WELCOME BUT NOT TO HAVE OPPOSED INTENSELY, SINCE THE PRINCIPAL ISRAELI DEMAND IS TO GET THE PALESTINIANS OUT OF LEBANON. SHARON IS REPORTED TO HAVE SAID THAT ISRAEL IS READY TO DECREASE PRESSURE ON BEIRUT AND BEGIN A WITHDRAWAL THE MOMENT HALF OF THE PALESTINIANS LEAVE, (2) THE SYMBOLIC PRESENCE OF THE P L O. SHARON WAS REPORTED TO HAVE REAFFIRMED THAT ISRAEL DOES NOT ACCEPT ANY SYMBOLIC P L O PRESENCE IN BEIRUT. AL-ANWAR QUOTES ITS SOURCE AS SAYING THAT HABIB INSISTED ON A SOLUTION SATISFACTORY TO BOTH THE P L O AND ISRAEL. SHARON IS REPORTED TO HAVE TOLD HABIB THAT ISRAEL WOULD ACCEPT A P L O INFORMATION OFFICE IN BEIRUT SIMILAR TO THOSE IN OTHER CAPITALS. AL-ANWAR'S SOURCE SAYS THAT THE PRINCIPAL PROBLEM NOW REMAINING IS WHERE THE PALESTINIANS GO WHEN THEY LEAVE LEBANON AND THAT SHARON GAVE HABIB UNTIL FRIDAY TO DEVELOP SOME ANSWERS FOR THIS QUESTION.

2. COMMENTING ON THE HABIB-SHARON MEETING, LEFTIST AS-SAFIR CARRIES THE BANNER HEADLINE: "FROM BAABDA, HABIB AND SHARON SUPERVISE THE OPERATION OF BURINING THE WRITTEN PALESTINIAN (WORKING) PAPER. BEIRUT IS PRISONER OF A WAR HUNGER AND SHELLING." AS-SAFIR SAYS THAT THE PALESTINIAN LEADERSHIP FEELS ISRAEL HAS TRANSLANTE ITS REJECTION OF THE

MESSAGE / ANNOTATION:

PALESTINIAN WORKING PAPER INTO A TIGHTENING OF ITS GRIP ON BEIRUT AND AN EFFORT TO ADVANCE MILITARILY IN THE SOUTHERN SUBURBS, DESPITE THE CURRENT CEASEFIRE, BECAUSE WASHINGTON AND TEL AVIV WANT TO FORCE A PALESTINIAN CAPITULATION. THE PALESTINIANS BASE THIS CONCLUSION, IN PART, ON THE FACT THAT HABIB AND SHARON MET YESTERDAY AS THE MILITARY AND SUPPLY WAR AGAINST BEIRUT WAS AT ITS MOST INTENSE.

3. IN A MORE GENERAL AND RELATIVELY PESSIMISTIC COMMENT ON THE STATUS OF NEGOTIATIONS, MODERATE AN-NAHR SAYS: "A (WELL INFORMED) SOURCE CONSIDERS THAT THE EFFORT, WHICH WAS UNDERTAKEN BETWEEN THE PALESTINIAN RESISTANCE AND ISRAEL THROUGH PRIME MINISTER SHAFIQ AL-WAZZAN AND THE AMERICAN ENVOY AMBASSADOR PHILIP HABIB, HAS ENTERED THE FINAL PHASE, BECAUSE IT DID NOT GIVE THE EXPECTED RESULTS. IT WAS CLEAR, IN THE VIEW OF THE SOURCE, THAT THE PALESTINIAN ANSWER, WHICH WAS TRANSMITTED BY WAZZAN THROUGH A TELEPHONE CONTACT WITH HABIB TWO DAYS AGO, DID NOT GIVE SATISFACTION, ESPECIALLY SINCE P L O LEADER YASR ARAFAT DENIED SIGNING ANY PALESTINIAN DOCUMENT THAT INCLUDES ANSWERS TO THE QUESTIONS OF THE AMERICAN ENVOY, WHILE PRIME MINISTER WAZZAN AFFIRMED THE EXISTENCE OF THE DOCUMENT."

4. ALMOST ALL PAPERS REPORT A U N SECURITY COUNCIL RESOLUTION, ADOPTED UNANIMOUSLY, CONDEMNING VIOLENCE AGAINST CIVILIANS IN LEBANON AND A STATEMENT BY WHITE HOUSE SPOKESMAN SAYING THAT PRESIDENT REAGAN HAS SENT NEW INSTRUCTIONS TO PHILIP HABIB.

5. AN-NAHAR'S COLUMNIST, MICHEL ABU JAWDE, SAYS: "THE UNITED STATES ALONE IS TAKING CARE OF NEUTRALIZING THE SOVIET UNION AND UNDERMINING ANY FRENCH, EUROPEAN OR EVEN EGYPTIAN ROLE, IF THIS ROLE DOES NOT LEAD TO THE AMERICAN PEACE." AS-SARIF'S COLUMNIST SAYS: "AT FIRST GLANCE, IF A DIFFERENCE OCCURS BETWEEN THE PARTIES OF THE LEBANESE AUTHORITY, THIS DIFFERENCE WILL BE ON THE PALESTINIAN ISSUE AND HOW TO DEAL WITH IT. BUT THIS CONCEPT IS COMPLETELY WRONG, BECAUSE THE SUBJECT OF THE REAL DIFFERENCE WILL BE ABOUT THE LEBANESE QUESTION AND HOW TO DEAL WITH IT IN THE LIGHT OF ISRAELI CONDITIONS. THAT WAS REVEALED BY MENACHEM BEGIN HIMSELF WHO ANNOUNCED THAT, AFTER THE OUSTING THE P L O FIGHTERS FROM BEIRUT, WE WILL SIGN A PEACE AGREEMENT WITH LEBANON."
