BEGIN AND RESERVISTS

1. THE ISRAELI GOVERNMENT PRESS OFFICE TODAY (JULY 12) RELEASED ITS OFFICIAL TRANSLATION OF AN EXCHANGE OF LETTERS BETWEEN 35 ISRAELI RESERVISTS AND PRIME MINISTER MENAHEM BEGIN. THE LETTER SIGNED BY THE RESERVISTS DECRIES THE PURPOSE AND CONDUCT OF OPERATION "PEACE FOR GALILEE." IN HIS REPLY, THE PRIME MINISTER JUSTIFIES THE WAR AS ONE OF SELF DEFENSE.

2. COMMENCE TEXT:

JULY 5, 1982

DEAR MR. PRIME MINISTER:
NOT FOR THIS DID I VOLUNTEER (TO JOIN) THE RECONNAISSANCE PLATOON!
IT WAS ALWAYS CLEAR TO ME THAT WERE I TO GO TO WAR, IT WOULD BE A JUST WAR FOR OUR LIVES AND OUR EXISTENCE AS A PEOPLE. THIS TIME I WENT OUT TO A WAR WHOSE DECLARED PURPOSE WAS DISTANCING THE TERRORISTS

MESSAGE / ANNOTATION:

40 KILOMETERS FROM THE NORTHERN SETTLEMENTS. TODAY IT IS CLEAR TO ME THAT I WAS DECEIVED AND CALLED TO THE FIRST WAR IN ISRAEL'S HISTORY WHICH WAS NOT A DEFENSIVE WAR BUT RATHER A DANGEROUS GAMBLE ON ACHIEVING POLITICAL AIMS--AND THIS AT A COST OF HEAVY IDF CASUALTIES AND HURTING INNOCENT CIVILIANS--A STEP WHICH CONSTITUTES A GRAVE PRECEDENT, A DISASTER TO OUR IMAGE, AND WHICH HARMS OUR MORAL FIBER AND THE CHANCES OF PEACE IN THIS BLOOD-SOAKED REGION.

KNOW THAT THOSE VOICES PROTESTING THE WAR NOT ONLY DO NOT HARM MY MORALE, BUT IT IS THEY WHO GIVE ME THE STRENGTH TO CONTINUE AT THE FRONT, IN THE KNOWLEDGE THAT REASON AND HUMANITY HAVE NOT DISSIPATED ON THE HOME FRONT.

EVEN NOW, I WILL CONTINUE TO CARRY OUT THE ORDERS OF MY COMMANDERS, IN THE KNOWLEDGE THAT I AM RISKING MY LIFE IN A WAR WHOSE JUSTICE I DO NOT BELIEVE IN:

I HAVE NO FAITH IN THE DEFENSE MINISTER!!

DEAR MR. ASSAF:

I HEREBY ACKNOWLEDGE WITH THANKS RECEIPT OF THE LETTER IN WHICH YOUR NAME APPEARS, TOGETHER WITH THE NAMES OF 34 OTHER CITIZENS. THIS LETTER DOES NOT CONTAIN THE MINIMUM OF COURTESY. INDEED YOU APPENDED TO IT A LIST OF 35 NAMES, BUT NO ONE AMONG YOU SIGNED IT PERSONALLY. NOT NICE.

NEVERTHELESS, I WILL REPLY TO YOUR SHOCKING WORDS:

A. THE DEFENSE MINISTER DOES NOT REQUIRE YOUR FAITH, AS VOTING CITIZENS (I PRESUME) YOU DID NOT VOTE FOR HIM, OR FOR THE PARTY THROUGH WHICH HE AND I AND OUR FRIENDS SERVE THE STATE OF ISRAEL. AS SOLDIERS, YOU OWE HIM UNDISPUTED OBEDIENCE. ACCORDING TO THE BASIC LAW: THE ARMY, THE CHIEF OF STAFF, WHO IS THE COMMANDER IN CHIEF OF THE ARMY, IS SUBORDINATE TO THE DEFENSE MINISTER, WHO REPRESENTS

THEREFORE, WE CONTINUED TO FIGHT. IN THE COURSE OF 24 HOURS WE THRUST THE ENEMY BACK BEYOND 40 KILOMETERS NORTH OF METULLA, AND THEN, ON FRIDAY, AT 1200 NOON, WE DECLARED, OF OUR OWN FREE WILL AND ON OUR OWN INITIATIVE, A UNILATERAL CEASE-FIRE. THE SYRIANS ACCEDED--THE TERRORISTS DID NOT, ANNOUNCING THAT THEY WOULD CONTINUE TO FIGHT US, AND LET FLY AT US WITH ALL THEIR WEAPONS. LONG RANGE ONES. AS STALWART FIGHTERS OF THE RECONNAISSANCE PATROL, WHAT WOULD YOU HAVE PROPOSED TO DO UNDER THESE CONDITIONS: TO FIGHT TO REPULSE THE ATTACKER, OR TO RETREAT TOWARDS THE RENEWAL OF THE LINE FROM WHICH THEY WOULD BE ABLE TO SHELL THE CIVILIAN POPULATION IN THE SETTLEMENTS OF THE GALILEE PANHANDLE. I HAVE NO DOUBT AT ALL AS TO WHAT REPLY YOU WOULD HAVE GIVEN, WERE THE AUTHORITY TO DECIDE IN YOUR HANDS. THE AUTHORITY WAS GIVEN TO YOUR HIGH COMMAND, WHICH IS THE GOVERNMENT; AND IT DECIDED TO PRESS THE ENEMY WHICH CONTINUED TO FIGHT YOU AND YOUR COMRADES IN ARMS. ANYONE WHO CHARGES "DECEPTION" IS DECEIVING THE PUBLIC AND IS BEING DRAGGED AFTER THE HATRED WHICH HAS PERMEATED OVER A NUMBER OF GENERATIONS A PART OF THE NATION AMONG ANOTHER PART OF THE NATION.

I HEREBY WISH YOU AND ALL YOUR COMRADES COMPLETE SUCCESS IN YOUR ARMY SERVICE. AND IN THE FUTURE, IF YOU HAVE SOMETHING TO TELL ME, OR TO REQUEST FROM ME, PLEASE DO NOT WRITE ME COLLECTIVE "PETITIONS;" BUT LET EACH CITIZEN TURN TO THE PRIME MINISTER OF HIS COUNTRY, AND HE WILL RECEIVE A REPLY.
