IN INTERVIEWS YESTERDAY (JULY 14) FOREIGN MINISTER SHAMIR AND COMMUNICATIONS MINISTER ZIPORI SAID SEPARATELY THAT ISRAEL HAS NOT SET A DEADLINE FOR THE COMPLETION OF NEGOTIATIONS FOR REMOVING THE PLO FROM WEST BEIRUT, THOUGH TIME IS OF THE ESSENCE. THE MINISTERS ALSO COMMENTED ON THE WORLD REACTION TO THE LEBANON OPERATION, WITH SHAMIR CHARGING THAT FRANCE'S SUPPORT FOR THE PLO HAS ENCOURAGED THE PLO TO BECOME MORE INTRANSIGENT. SHAMIR ARGUED THAT THERE IS NO CHANCE THE PLO WILL BECOME SOLELY A POLITICAL ORGANIZATION WITHOUT A MILITARY DIMENSION. ZIPORI'S INTERVIEW WAS BROADCAST IN BOTH HEBREW AND ENGLISH ON JULY 14 AND 15, APPARENTLY SIGNIFYING THE GOVERNMENT'S DETERMINATION THAT THE PUBLIC BE AWARE THAT THERE IS NO FIRM DEADLINE FOR DEALINGS IN BEIRUT.

2. COMMENCE EXCERPTS OF SHAMIR'S INTERVIEW:

QUESTION: MR. SHAMIR, WHAT IS THE SITUATION OF THE NEGOTIATIONS IN BEIRUT, UP TO THIS MOMENT, REGARDING THE REMOVAL OF THE TERRORISTS FROM BEIRUT?

ANSWER: IT IS TRUE THAT TODAY THERE IS NO EARTH-SHAKING NEWS, BUT THE NEGOTIATIONS OVER THE TERRORISTS' REMOVAL FROM BEIRUT AND LEBANON ARE CONTINUING. . . . I THINK THAT THERE IS STILL HOPE OF REACHING POSITIVE RESULTS AND WE ARE HOLDING TO OUR DECISION TO PROVIDE OUR FRIENDS THE AMERICANS WITH TIME AND A CHANCE TO CONTINUE WITH THE NEGOTIATIONS UNTIL WE OBTAIN THE OBJECTIVES. I CAN DEFINE THE CURRENT SITUATION IN THE NEGOTIATIONS. THERE IS A COMMITMENT IN PRINCIPLE BY THE TERRORISTS' LEADERSHIP TO LEAVE BEIRUT AND LEBANON. THERE IS NOT YET AGREEMENT ABOUT THE WAYS; THERE IS NO AGREED TIMETABLE; IT IS NOT CLEAR WHEN THE MULTINATIONAL FORCE WILL ARRIVE, WHAT ITS AUTHORITY WILL BE AND HOW IT WILL BE COMPOSED; IT IS NOT YET CLEAR WHERE THE TERRORISTS WILL GO AFTER THEY ARE EVACUATED FROM BEIRUT. THIS IS THE SITUATION. THE NEGOTIATIONS ARE FOCUSING ON THESE POINTS.

QUESTION: WHEN WILL THE PERIOD OF TIME THAT ISRAEL IS ALLOWING FOR THE NEGOTIATIONS END?

ANSWER: WE HAVE NOT SET A DATE. BUT WE HAVE SAID THAT TIME IS NOT UNLIMITED, BECAUSE IT CANNOT CONTINUE WITHOUT A LIMIT; BUT WE ARE STILL WAITING.

IT IS NOT YET CLEAR TO US IF THE TERRORISTS' DECISION TO LEAVE BEIRUT AND LEBANON IS REALLY CLEAR, PLAIN AND FIRM. THERE IS THE IMPRESSION THAT THEY ARE STILL HOPING FOR SOME SORT OF MIRACLE WHICH WILL PREVENT THEIR REMOVAL FROM BEIRUT. THEY ARE ENCOURAGED BY ALL SORTS OF PHENOMENA SUCH AS, FOR EXAMPLE, FRANCE'S POSITION. THEY ARE PERHAPS HOPING FOR SOME SORT OF CHANGE AS A RESULT OF SOME SORT OF SHOCKS IN ISRAELI SOCIETY, THE IMPORTANCE OF WHICH THEY ARE EXAGGERATING GREATLY; BUT IT SEEMS TO ME THAT IT IS CLEAR EVEN TO THEM THAT THEIR FATE IN BEIRUT HAS BEEN DECIDED. THEIR CAREER IN BEIRUT IS OVER. THEY MUST LEAVE THERE, AND IF THIS IS NOT YET CLEAR TO THEM, I HOPE IT WILL BE CLEAR TO THEM WITHIN THE NEXT FEW DAYS.
