2. AFTER A SURVEY OF 17 WEST BEIRUT HOSPITALS AND CLINICS CONCLUDED AUGUST 6, ICRC REPORTS THAT FIVE HOSPITALS HAVE CLOSED DUE TO LACK OF STAFF AND SHORTAGE OF SUPPLIES, FUEL OR WATER. OTHERS ARE ON THE VERGE OF SHUTTING DOWN. ONE HUNDRED THIRTY VACANT HOSPITAL BEDS REMAIN IN WEST BEIRUT. FOLLOWING ARE HIGHLIGHTS OF ICRC REPORT:
  - AMERICAN UNIVERSITY HOSPITAL (AUH). ALL BEDS FULL, OXYGEN SUPPLY ONLY UNTIL AGUST 8, WATER UNTIL AUGUST 13.
  - AKKA HOSPITAL (PALESTINE RED CRESCENT). HOSPITAL CAN ONLY BE REACHED BY FOOT AND ACCESS IS DANGEROUS BECAUSE OF PROXIMITY TO ISRAELI LINES NEAR KUWAITI EMBASSY CIRCLE.
  - NAJAR HOSPITAL. 32 OUT OF STAFF OF 140 REMAIN. THREE OF FOUR FLOORS ARE CLOSED. FUEL OIL RESERVES SUFFICIENT FOR FOUR DAYS. FOOD IN SHURT SUPPLY.
  - AMAL HOSPITAL. IN PROCESS OF TRANSFER TO UNDERGROUND LOCATION.
  - BARBIR HOSPITAL. NO LONGER MORE THAN A DORMITORY. SOME PATIENTS HAVE BEEN EVACUATED BY ICRC.
  - MAQASSID HOSPITAL. S AFF SHORTAGE. WATER AND FUEL OIL FOR 3-4 MORE DAYS.
  - JOSMIN CENTER. FOOD GONE. (73) 98) !94 48 HOURS.
  - POPULAR DISPENSARY OF LEBANON. NU WATER, NU GASULINE FOR AMBULANCE (ICRC NOTES DISPENSARY HAS BEEN TREATING

GENERALLY QUIET AS OF 1700 EDT, ALTHOUGH SMALL ARMS AND ARTILLERY FIRE WAS EXCHANGED AROUND BURJ AL-BARAJINAH FOR SEVERAL HOURS EARLIER IN THE DAY. THE MUSEUM AND PORI CROSSINGS HAVE REMAINED CLOSED, AND BEIRUT RADIO REPORTS THAT THE GALERIE SEMAAN CROSSING WAS CLOSED AT 1600 GMT AS A RESULT OF PALESTINIAN SNIPER FIRE. EMBASSY BEIRUT REPORTS THE ISRAELIS ALLOWED A FIVE TRUCK ICRC RELIEF CONVOY (4 TRUCKS OF FOOD AND 1 OF MEDICINE INTO WEST BEIRUT AND THAT ICRC WILL ATTEMPT TO GET ANOTHER CONVOY THROUGH TOMORROW. THE SYRIAN PRESS CARRIED A STATEMENT BY A MILITARY SPOKESMAN ANNOUNCING THAT SYRIAN CASUALTIES IN BEIRUT IN THE LAST WEEK WERE 64 DEAD AND WOUNDED, SUGGESTING THAT THE REMAINING SYRIAN TROOPS IN BEIRUT ARE ACTIVELY RESISTING ISRAELI FORCES. EMBASSY TEL AVIV REPORTS THE ISRAELIS BELIEVE THE PUBLIC ANNOUNCEMENT OF

SYRIAN LOSSES RESULTS FROM ASSAD'S DESIRE TO DEMONSTRATE TO OTHER ARAB COUNTRIES THAT SYRIA IS SUPPORTING THE PLO IN ORDER TO RALLY ARAB SUPPORT FOR HIS POLICIES.

3. DIPLOMATIC DEVELOPMENTS: AMBASSADOR HABIB CONTINUES HIS EFFORTS TO REACH A NEGOTIATED SETTLEMENT AMID NUMEROUS PRESS REPORTS THAT AN AGREEMENT ACCEPTABLE TO ALL PARTIES WILL BE REACHED WITHIN A FEW DAYS. AFTER MEETING WITH HABIB THIS MORNING, PRIME MINISTER AL-WAZZAN REPORTEDLY TOLD BEIRUT RADIO THAT PLO FIGHTERS COULD BEGIN LEAVING BEIRUT "WITHIN DAYS."

4. THE FRENCH GOVERNMENT OFFICIALLY ANNOUNCED THAT IT HAS MADE ARRANGEMENTS TO SEND A FRENCH DETACHMENT TO BEIRUT WITHIN THE FRAMEWORK OF AN INTERNATIONAL FORCE. THE ISRAELI PRESS REPORTED SOON AFTER THE ANNOUNCEMENT, HOWEVER, THAT ISRAEL WARNED FRANCE NOT TO SEND ITS TROOPS TO BEIRUT BECAUSE OF ISRAELI FEAR THAT THE PLO WILL REFUSE TO LEAVE BEIRUT ONCE FRENCH FORCES ARE IN POSITION BETWEEN THE IDF AND PLO.
