2. MILITARY SITUATION: BEIRUT IS REPORTEDLY CALM AT THIS HOUR, FOLLOWING A DAY OF SPURADIC FIGHTING BETWEEN PLO AND IDF FORCES. AT 1400 LOCAL, IAF JETS LAUNCHED CONCERTED AIRSTRIKES UPON PLO TARGETS IN THE BURJ AL-BARAJNEH AND HAY SULLAM AREAS SOUTH OF BEIRUT. THE BOMBING, WHICH CEASED AT APPROXIMATELY 1515 LOCAL, WAS ACCOMPANIED AND FOLLOWED BY ARTILLERY AND SMALL ARMS EXCHANGES. MEANWHILE, IDF RADIO IN TEL AVIV CLAIMED THAT ISRAELI PLANES ATTACKED AND DESTROYED A SYRIAN SA-9 MISSILE SITE IN THE BEKAA VALLEY; HOWEVER, EMBASSY BEIRUT SOURCES HAVE BEEN UNABLE TO CONFIRM THESE REPORTS. CONTRARY TO VARIOUS MEDIA ACCOUNTS, ISRAELI FORCES MAINTAINED THEIR POSITIONS AT THE PORT AND MUSEUM CROSSINGS, WHICH REMAINED CLOSED TO CIVILIAN TRAFFIC THROUGHOUT THE DAY. THE GALERIE-SIMAN CROSSING WAS OPEN, AND FLOODED WITH HEAVY EAST/WEST TRAFFIC. IN

BEIRUT, AN ICRC RELIEF CONVOY ARRIVED, CARRYING FOOD, MEDICAL SUPPLIES, AND A 60-BED MOBILE HOSPITAL TO RESIDENTS IN THE WESTERN SECTORS OF THE CITY. STILL, CIRCUMSTANCES IN WEST BEIRUT ARE REPORTEDLY GRIM AS IDF FORCES MANNING THE CITY'S POWER STATION REFUSE TO ALLOW RESUMPTION OF ELECTRICITY TO THE WESTERN PORTIONS OF THE CITY.

3. DIPLOMATIC DEVELOPMENTS: AFTER MEETING WITH GOL OFFICIALS THIS MORNING, AMBASSADOR HABIB TRAVELLED TO JERUSALEM FOR TALKS WITH ISRAELI LEADERS REGARDING THE DETAILS OF A PACKAGE PLAN FOR THE PLO WITHDRAWAL FROM WEST BEIRUT. EARLIER TODAY, THE ISRAELI CABINET ANNOUNCED THAT IT HAD TENTATIVELY APPROVED THE DOCUMENT, BUT NOTED THAT A NUMBER OF "SUBSTANTIVE AND TEXTUAL" DIFFERENCES REMAINED. ACCORDING TO THE CABINET SPOKESMAN, SEVERAL AMMENDMENTS HAD BEEN SUBMITTED TO HABIB FOR HIS CONSIDERATION. A FULL LIST OF COUNTRIES WILLING TO ACCEPT THE SUM OF PLO MEMBERS IN WEST BEIRUT WAS CITED AS A PRECONDITION FOR ANY FURTHER DECISION ON THE CONTENT OF THE PLAN. MEANWHILE, IN AN OFFICIAL STATEMENT QUOTED BY THE PRESS, WHITE HOUSE SOURCES WELCOMED THE ISRAELI ASSESSMENT AS AN "ESSENTIAL ELEMENT IN GETTING THE PROBLEM SOLVED IN BEIRUT."

OPPOSITION LABOR PARTY LEADER SHIMON PERES MET WITH PRESIDENT REAGAN AND SECRETARY OF STATE SHULTZ TODAY FOR DISCUSSIONS ON THE CURRENT SITUATION IN LEBANON.

3. THE JEWISH RENAISSANCE GROUP HAS ANNOUNCED A STREET RALLY THIS AFTERNOON IN FRONT OF NOTRE-DAME CATHEDRAL TO PROTEST INTERNATIONAL TERRORISM.

4. ABOUT 1,000 PERSONS ATTENDED A STREET RALLY OUTSIDE THE ISRAELI EMBASSY YESTERDAY EVENING.
