--ACCUSED THOSE "FROM ACROSS THE OCEAN" OF INTERFERING IN ISRAEL'S INTERNAL AFFAIRS, MENTIONING SPECIFICALLY THE NEW YORK TIMES, THE WASHINGTON POST, ANTHONY LEWIS AND RABBI HERTZBERG.

--CHALLENGED THE LABOR PARTY ALIGNMENT TO AGREE TO EARLY ELECTIONS IN MAY OR JUNE 1983 AND "THEN WE WILL SEE WHAT IS LEFT OF THE LABOR ALIGNMENT." AT THE BEGINNING OF THE SPEECH, THE PRIME MINISTER ANNOUNCED THAT THE ISRAELI AIR FORCE HAD JUST DESTROYED SYRIAN SURFACE-TO-AIR MISSILE BATTERIES WHICH HAD BEEN REINTRODUCED INTO LEBANON.

3. IN CONTRAST TO THE PRIME MINISTER'S SPEECH, THE REST OF THE DEBATE WAS UNEXCITING AND UNEMOTIONAL. FOREIGN MINISTER SHAMIR LED OFF THE AFTERNOON'S PROCEEDINGS BY CHARGING THAT THE U.S. HAD UNDERMINED CAMP DAVID.
