SUBJECT: ARRIVAL OF PLO FEDAYEEN IN YEMEN

1. (U) ARRIVAL OF PLO FIGHTERS IN YAR WENT SMOOTHLY AND WITHOUT INCIDENT. YARG MEDIA MADE MUCH OF THEIR ARRIVAL AT HODEIDAH PORT 9/6, AND IN SANAA THE NEXT DAY, TV SHOWED THEM LEAPING JAUNTILY FROM SHIPS, TO BE GREETED BY YARG VP AL-ARASHI, THE DEPUTY CHIEF OF STAFF, THE INTERIOR MINISTER, AND THE GOVERNOR OF HODEIDAH. PALESTINIANS WERE LED BY LT. COL. ABU HUMAYD AND LT.: COL. ZIAD AL ATRASH (AKA ABU JIHAD) OF FATAH. ALL OF THE PALESTINIANS WERE BRANDISHING THEIR WEAPONS, AND KEPT UP A VOLLEY OF SMALL-ARMS FIRE AS THEY PROCEEDED IN OPEN TRUCKS THROUGH THE STREETS OF HODEIDAH.

2. (U) ON THE WAY TO SANAA 9/7, YARG LINED ROAD WITH INHABITANTS OF VILLAGES, PLO FIGHTERS AND RETURNING YEMENI VOLUNTEERS DISMOUNTED FROM TRUCKS AND MARCHED FOR TV FILMING. IN SANAA YARG TURNED OUT A LARGE CROWD OF SCHOOL CHILDREN AND GOVERNMENT EMPLOYEES TO LINE THE STREETS AND CHEER THE "HEROS", PROCESSION WAS QUITE ORDERLY, ALTHOUGH IT PARALYZED TRAFFIC FOR SEVERAL HOURS. ONLY A FEW VOLLEYS OF AUTOMATIC WEAPONS FIRE WERE HEARD. (FRIDAY MOSQUE SERMONS HAD ADMONISHED POPULACE NOT TO GREET THE PALESTINIANS WITH THIS TRADITIONAL YEMENI

3. (U) YARG GAVE PRIME-TIME TV EXPOSURE TO HARANGUES DELIVERED BY VP ARASHI, LOCAL PLO REPRESENTATIVE, AND PLO CHIEFS. SPEAKERS SWELLED ON HEROISM OF PLO FIGHTERS AND YEMENI VOLUNTEERS, AND SUPPORT YEMEN HAD GIVEN PLO: "YEMEN WILL BE A BRIDGE RETURNING US TO PALESTINE."

4. ~~(L)~~ PLO CARAVAN ARRIVED TWO HOURS LATE IN SANAA, PROMPTING SOME GRUMBLING AMONG BYSTANDERS, SOME OF WHOM HAD BEEN WAITING FOR OVER THREE HOURS. ONE WAS HEARD TO ASK, EXASPERATED, "WHERE ARE THOSE DJINNS?" AT WHICH ANOTHER MAN OBSERVED, "LOOK, THEY'RE NOT EVEN HERE YET, AND ALREADY PEOPLE ARE CALLING THEM DEVILS"...

5. ~~(C)~~ COMMENT: WHILE DOING ITS BEST TO EXTEND A HERO'S WELCOME TO THE FEDAYEEN, YARG IS ALSO MAKING SURE TO KEEP THEM UNDER TIGHT CONTROL AND SURVEILLANCE. WHEN THE INITIAL EXCITEMENT DIES DOWN, FRICTION BETWEEN THE TRADITIONALIST AND TRIBAL YEMENIS, AND THE ROOTLESS, URBANIZED PALESTINIANS IS LIKELY.

- ALL MEDIA CONTINUE COMMENTS ON THE PRESIDENT'S PEACE INITIATIVE AND THE ISRAELI REACTION AS REFLECTED IN YESTERDAY'S KNESSET DEBATE THE PRESIDENT'S PROPOSALS.
- P.M. BEGIN IS QUOTED BY THE MEDIA AS SAYING THE U.S. PROPOSALS HAD BEEN "STILL-BORN."
