SUBJECT: TEXT OF SECDEF WEINBERGER'S BACKGROUND BRIEFING WITH ISRAELI EDITORS IN JERUSALEM, SEPTEMBER 3, 1982
1. DURING HIS VISIT TO ISRAEL, SECRETARY OF DEFENSE CASPAR WEINBERGER HELD AN INFORMAL BACKGROUND BRIEFING ON HIS TRIP TO THE MIDDLE EAST WITH THE SENIOR ISRAELI EDITOR OF ALL THE DAILY NEWSPAPERS AND ISRAEL RADIO AND TELEVISION. THE BRIEFING, WHICH WAS HELD AT THE AMERICAN CULTURAL CENTER (USIS) IN JERUSALEM WAS ATTENDED BY THE FOLLOWING:

ACC JERUSALEM, SEPTEMBER 3, 1982:
AMB LEWIS: THE IDEA OF GATHERING YOU HERE WAS TO HAVE AN INFORMAL CHAT, NOT A PRESS CONFERENCE. AND THE SECRETARY KINDLY THOUGHT IT WOULD BE A GOOD IDEA. HE WANTED TO GET SOME FEELING FOR WHAT THE GREAT EDITORIAL POWER OF THIS COUNTRY WAS LIKE AS WELL AS VICE VERSA. BUT THIS IS ON DEEP BACKGROUND AND HE IS REALLY NOT TRYING TO HANDLE THIS AS A NEWS CONFERENCE. YOU WILL ALL RECALL WHAT DEEP BACKGROUND MEANS, SOME OF YOU, ANYWAY. TO REFRESH YOUR MEMORY, IT NEEDS NO ATTRIBUTION TO ANYBODY. IT COMES OUT OF YOUR MIND, WHATEVER YOU LEARN COMES OUT OF YOUR OWN BRILLIANCE....

EDITOR: IT CAN COME OUT AS LONG AS IT'S TOTALLY UNSOURCED.

AMB LEWIS: THAT'S RIGHT, THAT'S RIGHT. BUT THE IDEA IS NOT GOING TO MAKE NEWS ANYWAY -- SO THERE WE ARE,

SECRETARY WEINBERGER: THIS IS TO LEARN THE FULL POWER OF THE PRESS IN THIS COUNTRY AND I SHOULD KEEP SILENT -

WHAT I SAID I WAS GOING TO DO WHEN I LEFT WASHINGTON - IS TO LISTEN AND TO LEARN AND LOOK - I DON'T THINK THIS IS THE OBJECTIVE OF THE PRESS - BUT I'LL BE DELIGHTED TO TRY TO DEAL WITH SOME QUESTIONS IF I CAN.

AMB LEWIS: ANYBODY HAS ANY QUESTIONS?

Q: YES, CAN I HAVE THE FIRST AND THE LAST PLEASE?

AMB: THE FIRST -- WE WON'T GUARANTEE THE LAST.

Q: OUR AMBASSADOR TO THE UNITED STATES, MR. ARENS, HAD AN INTERVIEW WITH - IT HAPPENS TO BE MY PAPER - BUT (INAUDIBLE) AND HE SAYS HE SAID ON THE RECORD THAT HE FELT THAT THE WHOLE GLOBAL BALANCE HAS CHANGED IN THE FAVOR OF THE UNITED STATES AS A RESULT OF THE LEBANESE CAMPAIGN. HE ALSO WENT INTO GREAT DETAIL TO EXPLAIN WHY HE THOUGHT SO, BUT I DON'T THINK I SHOULD TAKE UP YOUR TIME IN GOING INTO THOSE DETAILS. BUT MY QUESTION WAS DO YOU FEEL THAT THIS WAR HAS IN ANY WAY AND IN WHAT WAY ENHANCED THE AMERICAN INTERESTS BECAUSE WE FEEL THIS WAS AS MUCH AN AMERICAN WAR AS IT WAS AN ISRAELI WAR ?

SECRETARY WEINBERGER: WELL, GLOBAL BALANCE IS A VERY, VERY LARGE TERM. I CAN'T FEEL FOR EXAMPLE THAT THIS WAR HAS CHANGED THE NUMBER OR THE STRENGTH OR THE POWER OF THE SOVIET MISSILE. I CAN'T FEEL THAT IT HAS CHANGED THE IMBALANCE THAT WE SEE IN NATO OR THAT IT HAS LESSENERED IN ANY WAY THE SOVIETS' MORE OR LESS INCESSANT DESIRE TO KEEP ADDING TO THEIR ARMAMENTS IN A PERIOD OF

WE BELIEVE AND WE UNDERSTAND THE SELF-DEFENSE ARGUMENT , WE THINK THAT SOMEWHERE AROUND -- SOMEWHERE BETWEEN 20 AND 30 KILOMETERS IT STOPS FROM BEING SELF-DEFENSE AND TURNS INTO OFFENSE, BUT WE UNDERSTAND THE DEEP EMOTIONS AND THE DEEP SENTIMENTS ABOUT IT.
