1. THE FOLLOWING MESSAGE HAS BEEN RECEIVED FROM FORMER
PRIME MINISTER SA'IB SALAM FOR PRESIDENT REAGAN:
2. BEGIN TEXT: DEAR MR. PRESIDENT: AT THE TIME OF THE
MURDER OF OUR PRESIDENT-ELECT AT THE HANDS OF THE CRIMINALS,
CONTINGENTS OF THE ISRAELI DEFENSE FORCES STARTED AN ADVANCE
TOWARDS THE CENTER OF BEIRUT, WHEREBY IT IS IN COMPLETE
CONTRADICTION TO THE AGREEMENTS THAT WERE LAID DOWN BY YOUR
SPECIAL ENVOY, AMBASSADOR PHILIP HABIB. THESE AGREEMENTS
STIPULATED THAT THE ISRAELI DEFENSE FORCES WOULD NOT ENTER
BEIRUT. PRESENTLY, FIGHTING IS TAKING PLACE IN THE STREETS
OF BEIRUT WHICH HAVE BEEN FOR TWO DAYS UNDER THE AUTHORITY
OF THE INTERNAL SECURITY AND LEBANESE ARMY.
THE ADVANCE OF THE ISRAELI DEFENSE FORCE HAS PLACED THE
PROGRESS OF SECURITY IN BEIRUT IN JEOPARDY, AND ANXIETY
PREVALES WITH ALL THE PEACEFUL PEOPLE OF BEIRUT,
FEARING THAT SAVAGE WAR WHICH WAS SINGULARLY CHARACTERISTIC
OF ISRAELIS WOULD BE RENEWED. WHAT THE UNITED STATES HAS
ACCOMPLISHED AS A BEGINNING FOR RESTURING LEBANON'S
AUTHORITY AND SOVEREIGNTY AND ITS ENVISIONING OF CON-
SOLIDATION OF THE CENTRAL GOVERNMENT IN LEBANON AND THE
PREVALENCE OF ITS AUTHORITY OVER ALL LEBANESE TERRITORY
IS NOW IN A GREAT DANGER.
WE SOLICIT YOUR INTERVENTIUN WITH THE UTMOST SPEED
POSSIBLE TO DETER THE ISRAELI DEFENSE FORCE FROM ADVANCING
INTO THE HEART OF BEIRUT WITH ALL THE PEACEFUL CIVILIANS
IN IT WHEN THEY WERE SUPPOSED TO BE WITHDRAWING AWAY FROM
BEIRUT AND ITS SUBURBS, AND TO STOP THEM FROM EVERY EFFORT
THAT WOULD IMPINGE WHATEVER HAS BEEN ACCOMPLISHED OF THE
