1. AS OF 1300 LT SEPTEMBER 19 WE HAVE SEEN NO OFFICIAL SYRIAN GOVERNMENT REACTION TO BEIRUT MASSACRE OF PALESTINIANS SEPTEMBER 17-18. SYRIAN PRESS SEPTEMBER 19 HOWEVER GAVE BANNER HEADLINES TO THE MASSACRE. THE GOVERNMENT-CONTROLLED PRESS ALLEGED THAT THE ISRAELIS COMMITTED THE ATROCITIES. THERE WAS NO MENTION OF PHALANGIST MILITIA INVOLVEMENT.
2. ALL DAILY PAPERS CARRIED PICTURES OF VICTIMS, AND SYRIAN TELEVISION COVERAGE ON SEPTEMBER 18 INCLUDED FILMS OF THE BODIES OF PALESTINIANS LYING IN THE WRECKAGE OF THE TWO CAMPS.
3. ALL THREE ARABIC-LANGUAGE NEWSPAPERS REPORTED PRESIDENT REAGAN'S STATEMENT CONCERNING THE EVENTS IN STRAIGHTFORWARD TERMS. THE NEWS REPORTING ON THE KILLING DID NOT LINK U.S. POLICY DIRECTLY TO THE INCIDENT WHICH WAS DESCRIBED AS AN ISRAELI CRIME. HOWEVER, ALL PAPERS CARRIED EDITORIALS WHICH, WHILE NOTING THE STATEMENTS OF THE PRESIDENT AND SECRETARY SHULTZ, ASKED RHEYORICALLY WHY THE AMERICAN LEADERSHIP IS SO SURPRISED AT THE MASSACRE.
