CITING MILITARY SOURCES-THAT I HAD THWARTED DIRECT CONTACTS
BETWEEN THE IDF AND LAF. THIS IS PRETTY RICH. I CAN SAFELY
SAY THAT HABIB AND I HAVE DONE MORE TO PROMOTE MILITARY-TO-MILITARY
