Dear Mr. President:

There is no reason you should remember me, but I served with the Religious Subcommittee of the Presidential Inaugural Committee in setting up the Sunday worship service the week of your inauguration. My position was one of liaison between the committee and various media groups. I also represented a mentally retarded bell choir which performed for the service and for which Mrs. Reagan graciously provided tickets for the parade during those festivities.

As Vice President for Communications of the National Benevolent Association, one of my responsibilities is a dinner for approximately 1,000 people held by NBA biannually in connection with the General Assemblies of the Christian Church (Disciples of Christ). There will be a probable total attendance of 8,000 to 10,000 persons at the Assembly. The National Benevolent Association is the Division of Social and Health Services of the Christian Church and owns, operates, sponsors or is affiliated with over 50 care facilities throughout the United States including Alaska. NBA provides services to children, mentally retarded persons, and older adults. The facilities range from low income housing for older persons, through retirement villages, residential care centers for emotionally disturbed children, emergency shelters for battered children and teens, community programs in child abuse and single parenting, residential and community housing for mentally retarded, and a myriad of other social services. Our facilities rely heavily on government funding in many instances.

At the dinner to be held at the General Assembly in San Antonio, Texas, on September 25, 1983, we plan to launch campaigns for eleven of the facilities which will tie in to a later campaign for national NBA to raise funds, primarily endowment funds in order to build reserves allowing our facilities to more fully operate with less government funding. This we believe to be in full keeping with your proposed economic program. The total NBA campaign will culminate in 1987, at which time NBA will be celebrating its 100th anniversary of service.

Dear Mr. Dobberstein:

I am replying to your message to President Reagan concerning the investigation by the South African Government's Eloff Commission into the finances and activities of the South African Council of Churches (SACC). We regret the delay in this response.

We share your desire that the South African Government carefully consider your message and the many others it has received about the proposal to declare the South African Council of Churches an "affected organization."

The SACC plays an important role in South Africa's religious life. It is also an advocate of racial reconciliation and political reform in South Africa and has emerged as a leading proponent of peaceful, evolutionary change away from apartheid. Organizations like SACC are a strong counterweight to those which advocate violent solutions to South Africa's complex political issues. SACC and other organizations which advocate peaceful change are essential to the continuation of the reform process.

South Africa has taken the first steps on the long road to reform. We hope that those differences which now keep men and women of goodwill apart can become the common ground in binding together South Africans of all races who share a commitment to peaceful, evolutionary change. Trying to help strengthen the bridges which will permit this change is a basic objective of U.S. policy toward South Africa.

Advocates of peaceful change away from apartheid are heartened by support from those who care about the welfare

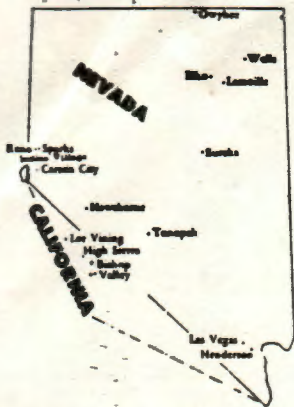
The General Council of the Presbytery of Nevada has instructed me to communicate to you the following statement.

"It is an awesome thing to be a part of the universal Church of God. As members of the General Council, Presbytery of Nevada, United Presbyterian Church in the United States of America, we take seriously our calling as baptized members of God's Church to care for those who are oppressed, sick, hungry and in prison. (Matthew 25:34-46)

In the light of Scripture, we believe that God bears a passionate concern for every human being. We believe that the South African Council of Churches has done no more than attempt to live up to this Gospel calling and demand, while doing all in its power to avoid the further escalation of violence in South Africa.

Lieutenant General J. Coetzee in his evidence to the Eloff Commission of Inquiry on February 14, 1983, advocated declaring the South African Council of Churches an "Affected Organization" and also limiting its ability to raise funds within South Africa. This amounts to an attack upon the central nature of the SACC and is also an attack upon a part of the universal Church of God. Lieutenant General Coetzee's proposal is abhorrent to the Gospel, to Christian conscience and to our own part of the Church as fellow pilgrims with Bishop Desmond Tutu and the South African Council of Churches. (I Corinthians 12:12-27)

Should action be taken against the SACC, we will seek to exert the influence of members of this Church in the media, business and political arenas to express our

support and concern for Bishop Tutu and the SACC.

We prayerfully urge the South African government to reconsider their attack upon this part of the Church of God."


Thank you for your securing of the Paul Harris Fellowship for the President.






