

Attached for your signature is a note to Sir Oliver Wright. On 14 December he sent you a copy of the White Paper, "The Falklands Campaign: The Lessons." The White Paper summarizes the Falklands campaign, the lessons being drawn from it for the British Armed Forces, and the plans being made to replace the war losses. Overall, the Falklands conflict will result in a strengthening of the U.K. armed forces--all conflict losses will be replaced, previously planned retirements will be postponed, and many individual improvements to equipment and training are being made.
