

DRAFT PUBLIC AFFAIRS ANNOUNCEMENT

The Secretary of Defense has formed a group, headed by Andrew Marshall, Director of Net Assessment, to study the lessons learned from the conflicts in the Falklands and in Lebanon. Initially we will try to analyze the immediate lessons with regard to weapons, tactics, etc., on which there is general agreement.

A longer-term research program also is being developed to analyze the data and information that will be gathered at greater length.

The coordinated Defense Department effort will include the Office of the Secretary of Defense, Joint Chiefs of Staff, Services and Defense Agencies that have interest in the lessons that can be learned from both the Falklands and the Lebanon invasions.
