In addition to insurance rates, we have added information on spot prices, tanker movements and a few of our own comments on the situation. Hull Insurance

SECRET

-- In the exclusion zone, the war risk premium was increased to \$4 per \$100 insured value as of yesterday. Before the latest series of attacks, the premium had been \$1.50.

-- Outside the exclusion zone, the rate has increased to 25 cents per \$100 insured value, up from 3.75 cents early last week.

-- High war risk insurance premiums now apply not only to tankers calling at Kharg Island but to ports north of the 28th parallel -- this includes Kuwaiti export terminals.

Cargo Insurance

-- Premiums for the exclusion zone now stand at \$1.35 per barrel.

-- In the non-exclusion zone, premiums have been raised to 8 cents per barrel, up from 2 cents early last week.

Spot Prices

-- After the attack on the "Yanbu Pride," spot crude oil prices increased by up to \$1 per barrel. They may have begun to recede today.

Tanker Movements

-- Mobil will not send its tankers north of the Saudi export terminals.

-- EXXON and Socal have not yet made a decision.

-- British and Japanese interests are reviewing their policies.

Comment

-- Every \$1 increase in hull insurance raises crude prices roughly 20 cents per barrel. Hull insurance premiums have never gone above \$5 during the Iran-Iraq war.

-- The expansion of the exclusion zone threatens to increase costs for other ports in the Gulf. Any further expansion would encompass the main Saudi export terminals. In our view, if attacks continue, the logical progression of events will result in a larger exclusion zone.

-- As long as insurance and crews are available, spot price changes will better reflect world oil price pressures since they are susceptible to greater movement.
