The attached threat situation summary describes the status of our current crisis planning activities for Iran-Iraq. Since the overall threat has decreased perceptibly in recent weeks, we are downgrading this situation from a "crisis" to a "threat" category. Until events warrant changes, we will continue to issue threat situation summaries on this region, but only at approximately two week intervals.
