2. BEGIN TEXT:

THE RIGHT HONOURABLE LYNDEN O. PINDLING, PRIME MINISTER OF
THE BAHAMAS, ON THURSDAY OF LAST WEEK, WROTE TO THE RIGHT
HONOURABLE MARGARET THATCHER, MP, PRIME MINISTER OF THE
UNITED KINGDOM, EXPRESSING HIS CONCERN AND REGRET OVER
ARGENTINA'S INVASION OF THE FALKLAND ISLANDS. THE PRIME
MINISTER ALSO ADVISED THE BRITISH PRIME MINISTER OF
THE SENTIMENTS OF THE GOVERNMENT WHICH HAD BEEN EXPRESSED
IN A NOTE TO THE GOVERNMENT OF ARGENTINA.
ON WEDNESDAY APRIL 7TH THE MINISTRY OF EXTERNAL AFFAIRS
SENT A NOTE TO THE GOVERNMENT OF ARGENTINA EXPRESSING THE DEEP
CONCERN OF THE GOVERNMENT OF THE BAHAMAS OVER THE SITUATION
WHICH HAS ARISEN AS A RESULT OF ARGENTINA'S INVASION OF THE
FALKLAND ISLANDS.

THE GOVERNMENT OF THE BAHAMAS EXPRESSED TO THE GOVERNMENT
OF ARGENTINA ITS BELIEF THAT THE INVIOLABILITY AND
TERRITORIAL INTEGRITY OF ALL STATES MUST BE PRESERVED AND
UNEQUIVOCALLY REJECTED THE USE OF FORCE AS A MEANS TO THE
SETTLEMENT OF DISPUTES BETWEEN STATES.

THE GOVERNMENT OF THE BAHAMAS RESTATED ITS FIRM COMMITMENT
TO THE PRINCIPLES OF SELF-DETERMINATION AND TO THE RIGHT
OF THE PEOPLE OF THE FALKLAND ISLANDS TO CHOOSE FOR
THEMSELVES THEIR POLITICAL DESTINY.

THE GOVERNMENT OF THE BAHAMAS INFORMED THE GOVERNMENT OF
ARGENTINA THAT IT AGREED WITH AND UNCONDITIONALLY SUPPORTED
THE UNITED NATIONS SECURITY COUNCIL RESOLUTION NO. 502
AND URGED THE GOVERNMENT OF ARGENTINA TO COMPLY WITH
