LEAVE IT THEY WISHED. EMBOFF TOLD HIM THAT WE WERE ASSURED ON THIS END THAT THEY COULD CONTINUE TO EXPECT SUCH TREATMENT IF GOA EVACUATION ASSISTANCE IS REQUESTED, BASED ON THE TESTIMONY OF THE YOUNGQUISTS.

4. MEANTIME, EX-DEPUTY GOVERNOR OF THE FALKLANDS, FRANCIS BAKER, TOLD EMBOFF AT AIRPORT TUESDAY NIGHT AS HE WAS BEING EVACUATED TO MONTEVIDEO THAT HE ESTIMATES ONLY ABOUT 20 PERCENT OF THE ISLAND'S 1,800 TOTAL POPULATION WOULD REMAIN. THESE HE DESCRIBED AS LAND-OWNING "BITTER ENDERS WHO ARE FOURTH OR FIFTH GENERATION KEPLERS." LEONARD TODAY CONFIRMED ENGLISH WANTED TO LEAVE ALSO, BUT FOR SOME REASON FEARED (A) THEIR RECEPTION HERE OR (B) WHAT LIFE HOLDS FOR THEM OFF THE ISLANDS.
