SUBJECT: SENATOR TOWER'S INTERVIEW WITH BBC

MEMBER OF SENATOR TOWER'S STAFF HAS INFORMED US THAT THE SENATOR GAVE AN INTERVIEW TO BBC-TV APRIL 15 IN WHICH HE CHARACTERIZED ARGENTINE ACTION AS NAKED AGGRESSION AND AN OFFENCE TO ALL PEOPLE WHO SUPPORT SELF DETERMINATION, TOWER, CHAIRMAN OF THE ARMED SERVICES COMMITTEE, REPORTEDLY SAID THAT IF A SHOOTING WAR DEVELOPED, HE HOPED THAT THE US WOULD SUPPORT THE BRITISH AND THAT THE BRITISH WOULD ULTIMATELY PREVAIL. THROUGHOUT THE INTERVIEW SENATOR TOWER MADE CLEAR THAT HE WAS SPEAKING PERSONALLY AND NOT FOR THE ADMINISTRATION. IN REFERENCE TO THE ADMINISTRATION'S POSITION, THE SENATOR SAID WE WERE ACTING AS AN HONEST BROKER, IN AN EVEN-HANDED MANNER AS POSSIBLE, HE DID NOT KNOW, HE SAID, HOW GOOD THE CHANCES WERE FOR A PEACEFUL SOLUTION. 2. THE UK USED THE OCCASION OF ECOSOC CONSIDERATION OF THE AGENDA ITEM ON THE INTERNATIONAL DAY AND YEAR OF PEACE TO AGAIN STATE ITS CASE ON THE FALKLANDS. PERM REP PARSONS DELIVERED A BRIEF BUT HARD-HITTING STATEMENT IN WHICH HE:
 - (A) CONTRASTED THE FINE-SOUNDING DECLARATIONS ON PEACEFUL SETTLEMENT OF DISPUTES AND INADMISSIBILITY OF THE USE OF FORCE WITH THE ACTIONS OF COUNTRIES BENT ON USING FORCE TO ACHIEVE THEIR OBJECTIVES;
 - (B) CITED ARTICLES 2.3 AND 2.4 OF THE UN CHARTER AFFIRMING DUTY OF MEMBER STATES TO SETTLE THEIR DISPUTES BY PEACEFUL MEANS;
 - (C) REITERATED THAT ON APRIL 2 THE GOA HAD CARRIED OUT A MILITARY INVASION OF THE FALKLANDS, "AN ACT OF UNPROVOKED AGGRESSION" IN DEFIANCE OF STATEMENTS BY THE SECRETARY GENERAL AND THE SC PRESIDENT APPEALING FOR RESTRAINT.
3. ARGENTINE REP TO ECOSOC DELIVERED A RIGHT OF REPLY REJECTING THE ASSERTION THAT ARGENTINA HAD COMMITTED AN ACT OF AGGRESSION BECAUSE THE TERRITORY RECLAIMED BELONGED RIGHTFULLY TO ARGENTINA. SHE ACCUSED THE UK OF BEING THE AGGRESSOR, CITING AS EVIDENCE THE UK NAVAL FLEET ON ITS WAY TO THE FALKLANDS. SHE ALSO CHARGED THE UK WITH VIOLATING ACCEPTED AGREEMENTS BY INTRODUCING "NUCLEAR WEAPONS" TO THE SOUTH ATLANTIC.
4. THE VENEZUELAN MISSION CIRCULATED THE FORMAL STATEMENT ON THE FALKLAND ISLANDS DISPUTE ISSUED APRIL 13 (REF A) STRONGLY SUPPORTING ARGENTINA'S RIGHT TO THE ISLANDS AND OPPOSING BRITISH "MILITARY INTERVENTION." THE PANAMANIAN LETTER ASKING FOR INFORMAL SC CONSULTATIONS REPORTED REF B WAS ALSO CIRCULATED AS AN OFFICIAL DOCUMENT.
5. SECURITY COUNCIL PRESIDENT (ZAIRE), IN RESPONSE TO THE PANAMANIAN REQUEST, IS CONDUCTING INFORMAL CONSULTATIONS WITH INDIVIDUAL SC MEMBERS. HE HAS SET A VERY DELIBERATE PACE AND IS UNLIKELY TO COMPLETE HIS INITIAL ROUND OF CONSULTATIONS BEFORE THE WEEKEND, THUS ALL BUT ENSURING THAT NO FURTHER SC ACTION WILL BE CONSIDERED UNTIL NEXT WEEK.
